Note 1 - Plan Description

The following description of Alpine Lumber Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Administration

Alpine Lumber Company (the "Company") is the sponsor and has responsibility for the administration of the Plan. Fidelity Management Trust Company (Fidelity) functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

General

The Plan is a defined contribution plan covering all eligible employees of Alpine Lumber Company who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan has a discretionary employer match of 50 percent of the participant's contribution, not to exceed 4 percent of the employee's eligible deferred compensation. The employer match is trued up annually. The Company contributed \$522,236, which is net of \$15,219 of forfeitures applied, for the year ended December 31, 2024. During 2024, the Plan determined that contributions from certain participants needed to be refunded based on compliance testing results. The participant refunds total \$281,367, which were accrued as excess contributions payable as of December 31, 2024 and will be refunded during 2025.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in their voluntary contributions, allocated earnings or losses thereon, and any qualified nonelective contributions.

The Company's discretionary contributions (including forfeitures), if any, and the earnings or losses thereon not fully vested when contributed will vest according to the following schedule:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 60), retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may have a maximum of two notes outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 3.25 percent to 8.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator at loan origination, and mature at various dates through February 2030. Principal and interest are paid ratably through monthly payroll deductions.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Forfeitures are used to reduce company contributions and are subject to the vesting provisions of company contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$175,565 and \$57, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are also exempt from the prohibited transaction rules.

Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. See the subsequent event below related to the sale of the Company effective January 2, 2025 and the termination of the Plan that occurred in conjunction with the sale of the Company.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market prices.

Note 2 - Summary of Significant Accounting Policies (Continued)

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. For the Columbia Trust Stable Income fund, if the Plan initiates a full redemption of this fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

As discussed in the *Termination* subnote in Note 1 to the financial statements, the plan sponsor terminated the Plan in conjunction with the sale of the Company, which occurred on January 2, 2025. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2024 to the liquidation basis. The Plan will not have any eligible compensation, and there is not expected to be participant or significant Company contributions into the Plan from January 1, 2025 onward.

Note 3 - Certified Information

Fidelity (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Note 1 - Plan Description

The following description of Alpine Lumber Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Administration

Alpine Lumber Company (the "Company") is the sponsor and has responsibility for the administration of the Plan. Fidelity Management Trust Company (Fidelity) functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

General

The Plan is a defined contribution plan covering all eligible employees of Alpine Lumber Company who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan has a discretionary employer match of 50 percent of the participant's contribution, not to exceed 4 percent of the employee's eligible deferred compensation. The employer match is trued up annually. The Company contributed \$522,236, which is net of \$15,219 of forfeitures applied, for the year ended December 31, 2024. During 2024, the Plan determined that contributions from certain participants needed to be refunded based on compliance testing results. The participant refunds total \$281,367, which were accrued as excess contributions payable as of December 31, 2024 and will be refunded during 2025.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in their voluntary contributions, allocated earnings or losses thereon, and any qualified nonelective contributions.

The Company's discretionary contributions (including forfeitures), if any, and the earnings or losses thereon not fully vested when contributed will vest according to the following schedule:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 60), retirement due to disability, or termination of the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may have a maximum of two notes outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 3.25 percent to 8.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator at loan origination, and mature at various dates through February 2030. Principal and interest are paid ratably through monthly payroll deductions.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Forfeitures are used to reduce company contributions and are subject to the vesting provisions of company contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$175,565 and \$57, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are also exempt from the prohibited transaction rules.

Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. See the subsequent event below related to the sale of the Company effective January 2, 2025 and the termination of the Plan that occurred in conjunction with the sale of the Company.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market prices.

Note 2 - Summary of Significant Accounting Policies (Continued)

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. For the Columbia Trust Stable Income fund, if the Plan initiates a full redemption of this fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

As discussed in the *Termination* subnote in Note 1 to the financial statements, the plan sponsor terminated the Plan in conjunction with the sale of the Company, which occurred on January 2, 2025. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2024 to the liquidation basis. The Plan will not have any eligible compensation, and there is not expected to be participant or significant Company contributions into the Plan from January 1, 2025 onward.

Note 3 - Certified Information

Fidelity (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
