As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024, and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**( 1 ) Description of plan**

The following description of the Akron General Health System Matched Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions. Copies of these documents are available from the Total Rewards Department at The Cleveland Clinic Foundation ("Foundation").

**General** - The Plan is a defined contribution plan sponsored by the Akron General Medical Center and certain affiliated entities (together the "System") that is designed under and intended to comply with the provisions of Internal Revenue Service ("IRS") code section 403(b). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On November 1, 2015, the Foundation became the full member of Akron General Health System pursuant to a Member Substitution Agreement.

The Plan Administrator is Akron General Health System ("AGHS"). The Board of Directors of AGHS has authorized the Retirement Committee of the Foundation to act on behalf of AGHS to perform its duties as Plan Administrator. The Retirement Committee has overall responsibility for the operation and administration of the Plan, including actions with respect to contracts, trusts, evaluation and engagement of investment fund managers and other Plan matters as required.

During 2024 the Plan was merged into The Cleveland Clinic 401(K) Plan ("CC 401(k)") and the Cleveland Clinic Savings and Investment Plan ("SIP") (See Note 10). The following plan description notes the plan features that existed prior to the merger date.

**Eligibility** - All highly compensated employees of the System are eligible to participate in the Plan. The compensation used to determine this status is the annual pay at the time of hire for new hires, and the prior year pay for all other employees. New hires are automatically enrolled in the Plan within 45 days of their start date unless they affirmatively enroll before then or decline enrollment. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are automatically invested in a designated target-date fund until changed by the participant.

**Contributions** - Participants may contribute amounts to the Plan up to the greater of the Internal Revenue Code Section ("IRC") 402(g) limit or 70% of their compensation, as defined. Eligible participants may also contribute "catch up" contributions to the Plan. Participants can designate their contributions as pre-tax or Roth contributions. Effective March 4, 2019 participants can also make after-tax contributions. Rollover contributions from other Plans are also accepted, provided certain specified conditions are met. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code ("IRC").

**( 1 ) Description of plan (continued)**

**Participant investment account options** - All contributions to the Plan are deposited in accounts maintained by Fidelity Management Trust Company ("Fidelity"). Separate accounts are maintained for each participant. All contributions and earnings are to be invested as directed by the participants in any of the various mutual funds or a guaranteed investment contract held by Fidelity. Additionally, self-directed brokerage account investments are available through Fidelity Brokeragelink. Voya Retirement Insurance and Annuity Company ("Voya") continues to hold certain Plan assets in accordance with participant direction. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant accounts** - Each participant's account is credited with the participant's elective contributions, and an allocation of earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - All participants are 100% vested in their contributions plus any earnings thereon.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest payments for loans originating prior to January 1, 2018 can be made ratably through payroll deduction or by the participant directly to Fidelity. Loans originating after January 1, 2018 require principal and interest payments to be made ratably by the participant directly to Fidelity.

**Payment of benefits** - On termination of service due to death, disability or retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in periodic installments. In the event of financial hardship, participants may apply to receive a distribution from their fund accounts, subject to meeting IRS mandated rules for hardship withdrawals. If the vested portion of a participant's account does not exceed \$7,000 upon termination of service, the Plan is permitted to make a lump sum distribution to the participant under certain conditions as defined in the plan document. The Plan also allows in-service distributions for participants age 59 ½ or older.

**( 2 ) Summary of significant accounting policies**

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment trustee and custodian. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

**Contributions** - Contributions from the participants are recorded in the year in which the participant compensation is paid to the participants.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the System and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The System may obtain reimbursement from the Plan for certain administrative expenses paid on behalf of the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**( 3 ) Information prepared and certified by the trustee and custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, and Voya, a custodian of the Plan, have certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments and notes receivable:

- Investments at fair value
- Investments at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Dividends and interest
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**( 4 ) Fair value measurements**

Authoritative guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**( 4 ) Fair value measurements (continued)**

The financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV of units of the separate account. The NAV, as provided by Voya, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. The pooled separate accounts are redeemed on a daily basis and do not have redemption restrictions other than noted above. Additionally, there are no unfunded commitments.

*Self-directed brokerage accounts:* Accounts primarily hold investments in mutual funds.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. **( 5 ) Fully benefit-responsive investment contracts**

The Plan had fully benefit-responsive guaranteed investment contracts (GICs) with Prudential Life Insurance Company of America ("Prudential") and Voya at December 31, 2023. The contracts were held by Fidelity and Voya, respectively. Contributions were maintained in the general accounts of the contract issuers. Each account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers were contractually obligated to repay the principal and a specified interest rate that was guaranteed for a specified period of time as outlined in the GICs. The crediting interest rates were based on formulas agreed upon with the issuers but could not be less than 2.45% for Prudential and 3.0% for Voya at December 31, 2023. Such interest rates were reviewed on a quarterly or annual basis for resetting using a portfolio rate approach where a single interest crediting rate was applied to all contributions made regardless of the timing of those contributions. The contracts were evergreen and did not have maturity dates.

**( 5 ) Fully benefit-responsive investment contracts (continued)**

The GICs met the fully benefit-responsive investment contract criteria and, therefore, were reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because that was the amount received by participants if they initiated permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Fidelity and Voya, represented contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations.

Certain events that could limit the ability of the Plan to transact at contract value with the issuers included the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. These events could cause contract value to be reduced subject to the application of market value adjustments, as defined in the contracts. No events occurred that limited the Plan's ability to transact at contract value with Plan participants.

There were no events that permitted the issuers to terminate the contracts which would have required the Plan to transact at amounts different than contract value.

**( 6 ) Related party transactions and party-in-interest transactions**

Fees for legal, accounting, trustee, custodian, and other services are paid by the System. Administrative fees charged by Fidelity (the trustee) and Voya (the custodian), including penalties for withdrawals, are deducted from the individual accounts of applicable participants. Other party-in-interest transactions include the purchase and sale of investments through Fidelity and Voya. Such transactions are exempt from being prohibited transactions. Fidelity and Voya provide certain management services to the Plan pursuant to plan service agreements. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are deducted from the NAV of the respective mutual fund, rather than through a direct payment.

**( 6 ) Related party transactions and party-in-interest transactions (continued)**

A Revenue Credit Account is maintained at Fidelity and is funded quarterly based on revenue sharing on covered investments, as defined, in excess of a quarterly participant fee. The Revenue Credit Account may be used to reimburse the System for fees and expenses or to pay such vendors directly for services provided to the Plan. Amounts not used to pay expenses of the Plan may be allocated to Plan participants. During 2024 and 2023, the Plan earned revenue credits of \$5,072 and \$12,772, respectively, which are reported in the financial statements as other income and were used to pay plan expenses.

**( 7 ) Plan termination**

Although it has not expressed any intent to do so, the System has the right to terminate the Plan subject to the provisions of ERISA.

**( 8 ) Tax status**

The Plan adopted the Fidelity Workplace Services LLC 403(b) Volume Submitter Plan Document (Basic Plan Document #20 and Adoption Agreement #001), along with certain Participation Agreements for affiliated employers and a Superseding Provisions Amendment.

The Fidelity Workplace Services LLC 403(b) Volume Submitter Plan has received a favorable opinion letter from the IRS dated August 7, 2017 regarding the tax-qualified status of the Plan pursuant to Revenue Procedure 2013-22. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe the Plan is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and 2023, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, currently no audits for any tax periods are in progress.

**( 9 ) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**( 10 ) Plan Merger**

Effective January 1, 2024, the Plan was amended and all non-union participants ceased to be active participants in the Plan as of December 31, 2023 and became eligible to participate in the CC 401(k) on January 1, 2024. Additionally, on January 4, 2024, all assets and liabilities of the Plan that were attributable to non-union participants were transferred to and became assets and liabilities of the SIP.

The Plan's union participants approved, in their collective bargaining agreement, participation in the CC 401(k) effective December 31, 2024, and at which time the assets and liabilities of the Plan were transferred to and became assets and liabilities of the SIP.

**( 11 ) Subsequent events**

The Plan has evaluated events that have occurred subsequent to the year ended December 31, 2024, through September 23, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
