## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Hollow Metal Pension Fund  
Separate Benefit Account

### Opinion

We have audited the financial statements of the Hollow Metal Pension Fund Separate Benefit Account (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Hollow Metal Pension Fund Separate Benefit Account (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

**General** - The Plan was adopted pursuant to the authority of the Board of Trustees granted under the Agreement and Declaration of Trust entered into as of July 1, 1985. The Plan is a defined contribution pension plan covering employees of employers having collective bargaining agreements with Local 2947 of the United Brotherhood of Carpenters and Joiners of America. These employers are required to make contributions to the Plan pursuant to those agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Participant Accounts** - Each participant's account is credited with the employer contributions, as well as allocation of Plan earnings. Allocations are based on participant earnings, account balances or transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Under current provisions of the Plan, participants are fully vested at all times.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts up to the maximum equal to the lesser of \$50,000, or 50% of the participant's account. The loans are secured by the balance in the participant's account. The loan interest rate is specified as the prime rate (as reported by the Federal Reserve) plus 1%.

**Benefits** - On termination of service due to disability, retirement or termination of employment, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

**Investments and Income Recognition** - Investments are carried at fair value which generally represents the net asset value of mutual funds as of the last business day of the year as provided by the investment company, Empower Retirement, LLC. Short-term investments are valued at cost, which approximate fair value.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Fully Benefit-Responsive Investment Contract** - The investment contract with the insurance company is carried at contract value, as provided by the insurance company, Empower Annuity Insurance Company.

**Notes Receivable from Participants** - Participant notes are measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

**Contributions** - Employer contributions due and not paid prior to year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded. Contributions are accounted for as exchange transactions.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

## **NOTE 3. PRIORITIES UPON TERMINATION**

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA. Upon termination, each affected participant would become 100% vested in their account.

## **NOTE 4. TAX STATUS**

The Plan obtained its latest determination letter on January 20, 2016 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### **NOTE 4. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

#### **NOTE 5. FUNDING POLICY**

The participating employers contribute such amounts as specified in their collective bargaining agreements.

#### **NOTE 6. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

##### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 6. FAIR VALUE MEASUREMENTS (continued)**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

**NOTE 7. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional investment contract with Empower Annuity Insurance Company (Empower). This contract is considered fully benefit responsive. Empower maintains plan contributions with the general assets. The account is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. The contract is included in the financial statements at contract value as estimated by the insurance company. The Plan's participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. The contract value, as estimated by Empower at December 31, 2024 and 2023 was \$527,082 and \$528,279, respectively. The average yield, calculated for the years ended December 31, 2024 and 2023 was approximately 2.04% and 1.79%, respectively. The effective crediting interest rate was 2.30% from January 1, 2024 to June 30, 2024, 2.35% from July 1, 2024 to December 31, 2024, 1.80% from January 1, 2023 to June 30, 2023 and 1.85% from July 1, 2023 to December 31, 2023. The crediting interest rate is determined semi-annually by Empower but cannot be less than zero.

**NOTE 7. INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued)**

There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

**NOTE 8. RELATED ORGANIZATIONS**

**Identification of Related Organizations**

The Plan has the following related entities with which it has transactions:

- Hollow Metal Pension Fund
- Hollow Metal Trust Fund
- New York City District Council of Carpenters Benefit Funds
- Retirement Plan for Officers and Employees of the New York City District Council of Carpenters and Related Organizations

All of the above entities qualify as tax-exempt organizations.

The entities listed above share common trustees or officers with this Plan.

**Common Administrative Expenses**

At December 31, 2024 and 2023, the Plan owed \$12,346 and \$14,715, respectively, to the Hollow Metal Pension Fund for the balance of employer contributions remitted to the Plan that were erroneously deposited into the Hollow Metal Pension Fund Separate Benefit Account's account.

Certain Plan investments are shares of mutual funds managed by Empower Retirement, LLC, the Trustee, as defined by the Plan. These transactions qualify as party-in-interest transactions and have been denoted as such on the supplemental schedule of assets held at end of year.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 9. RISK AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 21, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
