### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Carylon Corporation 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Carylon Corporation 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of the Plan**

The following description of the Carylon Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General:**

The Plan was established effective as of March 31, 1999 to provide benefits to employees of The Carylon Corporation and its subsidiaries (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility:**

Employees become eligible to participate after one-half year of employment, as of the first day of the next calendar quarter. Employees covered by a collective bargaining agreement, unless explicitly stated that they can participate in their agreement, and employees who are nonresident aliens with no U.S. source of income are excluded from participation. Employees of the collective bargaining unit International Union of Operating Engineers, Local 150AFL-CIO at National Industrial Maintenance, Inc. must complete 1,000 hours of service to become eligible.

#### **Employee contributions:**

The Plan is a defined-contribution Section 401(k) salary deferral plan. Participants may contribute up to 75% of eligible compensation on a pre-tax basis within certain specified limitations. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

#### **Employer contributions:**

The Company may make discretionary matching contributions of 25% of participants' contributions not to exceed \$1,000 per year and other employer contributions of \$100 and \$200 per calendar quarter to qualifying participants, as defined in the amendments to the Plan documents.

#### **Participant accounts:**

Each participant directs their individual investments including their share of allocated Company contributions into various investment options offered by the Plan. Each participant's account is credited with contributions, appreciation (depreciation) in fair value of investments and interest and dividend income. Allocations are based on participant earnings or account balances as defined by the Plan.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **1. Description of the Plan (continued)**

#### **Vesting:**

Participants' elective deferral account balances and earnings thereon are fully vested at all times. Employer matching contributions are vested after five years of service.

#### **Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon reaching normal retirement age (the later of the age of 65 or the fifth anniversary of the first day of the Plan year in which a participant commenced participation in the Plan), death, permanent disability or resignation from the Company, to be paid in a manner specified in the Plan. Upon death, disability or reaching normal retirement age, a participant's account balance becomes fully vested. Upon resignation, participants are entitled to receive the vested portion of their account balance.

The Plan also allows in-service withdrawals from a participant's elective deferral account balance for hardship withdrawals or from all vested account balances upon attaining age 59 1/2.

#### **Forfeitures:**

If a participant terminates employment and is less than 100% vested in the employer account, then the participant will forfeit the nonvested portion of the employer account. Forfeitures are retained in the Plan and can be used as discretionary contributions, to reduce the Company's future required contributions or to offset expenses of the Plan. Forfeitures totaled \$13,441 and \$30,920 at December 31, 2024 and 2023, respectively.

### **2. Summary of significant accounting policies**

#### **Basis of accounting:**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment valuation and income recognition:**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **2. Summary of significant accounting policies (continued)**

#### **Investment valuation and income recognition: (continued)**

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions:**

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

#### **Payment of benefits:**

Benefits are recorded when paid.

#### **Administrative expenses:**

Certain third-party administration, audit fees and other operating expenses of the Plan are paid by the Company. Recordkeeping and transaction fees are paid by participants.

#### **Expense offset arrangements:**

Certain fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

#### **Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the end of the Plan year and the reported amounts of changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates.

#### **Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

### **3. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Excess contributions**

Contributions by highly compensated employees exceeded the maximum deferral percentage prescribed by Section 401(k)(3) of the Internal Revenue Code (the Code) during the year ended December 31, 2023. Consequently, contributions by certain participants were required to be reduced and refunded to them in order to bring them within the required Plan limits. There were no such excess contributions received during the year ended December 31, 2024.

### **5. Investments (information prepared and certified by Fidelity Management Trust Company (the Trustee))**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

The Trustee certified the fair value of investments of \$32,556,610 and \$27,595,544 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value in the amount of \$3,376,663, as certified by the Trustee. Dividend and interest income was \$878,726 for the year ended December 31, 2024, as certified by the Trustee.

NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 7. Party-in-interest transactions

The Plan's investments are shares of mutual funds managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for recordkeeping totaled \$9,948 for the year ended December 31, 2024.

### 8. Related plan

The Company also maintains an employee stock ownership plan which covers substantially all employees of the Company. Employees covered by a collective bargaining agreement or nonresident aliens with no U.S. source of income are excluded from participating. Employees become eligible to participate after they complete one year of service and attain the age of 21.

### 9. Tax status

The Plan is exempt from federal income tax under Section 401 of the Code. The Plan is a prototype plan. The Internal Revenue Service has determined and informed the prototype sponsor by a letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the Code. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 10. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.
