## **Opinion**

## **Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 7 to the financial statements, the governing body of Royal Carting Service Co. 401(k) Plan adopted a resolution to terminate the Plan effective October 11, 2024. Liquidation of the Plan has been deemed imminent, and management has approved a plan for liquidation. As a result, the Plan has changed its basis of accounting from the going-concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit the Financial Statements**

## **Note 1 Plan Description**

The following description of Royal Carting Service Co. (the “Company” or “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

During October 2024, the Company was sold to an unrelated third party and the Company made the decision to terminate the Plan effective October 11, 2024, with no further contributions to be made under the Plan. Refer to Note 7.

### **General**

The Plan is a defined contribution plan covering eligible employees of the Company who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Contributions**

Subject to annual limitations established by the Internal Revenue Code (“IRC”), participants may contribute up to 100% of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions in accordance with provisions of the IRC. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan was restated July 1, 2021, adding an auto-enrollment provision, whereby upon meeting the eligibility provisions participants are auto enrolled at a default percentage of 4%, unless the participant affirmatively elects out. In connection with the Plan’s termination effective October 11, 2024, no further employee contributions were made under the Plan (refer to Note 7).

The Employer may make a matching contribution equal to 50% of the participant’s contributions but no greater than 2% of the participant’s eligible compensation. In addition, the Employer may make an additional discretionary contribution up to 25% of eligible compensation, subject to annual limitations established by the IRC. This amount is determined annually by the respective board of directors. The minimum discretionary contribution is 3% of eligible compensation.

For the year ended December 31, 2023, there was an Employer matching contribution and Employer discretionary contribution of 3% of eligible compensation made. There were no employer contributions made for the year ended December 31, 2024.

### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Employer’s contribution and Plan earnings. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The Employer contribution shall be allocated to participant accounts as of the last day of the Plan year. Participant accounts are charged with direct expenses and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1 Plan Description (continued)**

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account is based on continuous years of service. A participant is 100% vested after three years of service. Refer to Note 7 regarding vesting upon the Plan's termination.

**Notes Receivable from Participants**

The Plan does not allow for participant loans.

**Payment of Benefits**

On termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account, or a direct rollover into an individual retirement account. In-service and hardship withdrawals are permitted by the Plan.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$28,012, respectively. Forfeitures of non-vested accounts shall be used at the discretion of the Company; to pay Plan expenses or to offset future Employer contributions (or reallocate as Employer contributions). In 2024, prior to the Plan's termination there were additional forfeitures in the amount of \$19,756. During the year ended December 31, 2024, forfeitures in the amount of \$48,594 were reallocated to participant accounts. There was no utilization of forfeitures during the year ended December 31, 2023.

**Note 2 Summary of Significant Accounting Policies**

**Basis of Accounting**

As a result of the Plan's termination, the financial statements of the Plan as of and for the year ended December 31, 2024 have been prepared in accordance with the liquidation basis of accounting. The financial statements of the Plan as of and for the year ended December 31, 2023 are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. See Note 5 for discussion of contract value.

**Note 2 Summary of Significant Accounting Policies (continued)**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the years.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. At the discretion of the Company, forfeitures may also be used to pay administrative expenses of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant accounts are charged directly to the participants' accounts and are included in administrative expenses. Certain investment-related expenses are included in net appreciation of fair value of investments.

**Note 3 Information Certified by the Plan's Custodian**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian of the Plan, Voya Retirement Insurance and Annuity Company.

**Note 4 Fair Value Measurement**

The Financial Accounting Standards Board's ("FASB") Accounting Standard Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Note 4 Fair Value Measurement (continued)**

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodology used for assets measured at fair value.

*Pooled separate accounts*

Value based on the daily net asset value ("NAV") of the units held by the Plan at year end, which is used as a practical expedient to approximate fair value. Investments in pooled accounts represent a unit of account whose per unit value is the result of the accumulated values of the underlying investments determined at their fair value (NAV). In accordance with ASC Subtopic 820-10, the pooled separate accounts which are measured at NAV per share (or its equivalent) practical expedient are not required to be classified in the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for this investment; the redemption notice period is applicable only to the Plan.

**Note 5 Fully Benefit-Responsive Investment Contract**

The Plan holds a traditional investment contract that meets the criteria of a fully benefit-responsive investment and therefore is reported at contract value. Contract value is a relevant measure for fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan has an investment contract with Voya, known as Voya Fixed Account. This investment offering meets the criteria of a fully benefit-responsive investment contract and as such, the investment is reported at contract value. Contract value as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Additionally, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is an unallocated guaranteed investment contract that is fully and unconditionally guaranteed by the respective issuer. For each contract, the contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Amounts are held in the issuer’s general account and are credited on a net daily basis at annual effective rates. The key factors that influence future interest crediting rates could include the following: the level of market interest rates, the amount and timing of participant contributions, transfers and withdrawals into/out of the contract; and the duration of the underlying investments backing the contract.

The investment contract specifies certain events that may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following: 1) premature termination of the contract and 2) Plan termination or merger. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: 1) a material misrepresentation, 2) a business hardship or failure causing the Plan to lack a plan sponsor or 3) a material amendment to the Plan that may adversely impact the issuer financially.

Although the Plan has terminated it has been determined not to be an event that would limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants. No other events are probable of occurring that would limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**Note 6 Party-In-Interest**

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. As described in Note 2, fees related to the administration of participant accounts paid from the Plan assets and certain expenses of the Plan are paid by the Plan and at the discretion of the Company, forfeitures of employer contributions may be used to pay expenses of the Plan. Therefore, payments to such service providers by the Plan qualify as party-in-interest.

Voya serves as custodian and recordkeeper. Therefore, these transactions and the Plan's payment of fees to this service provider qualify as party-in-interest transactions.

**Note 7 Plan Termination**

During October 2024, the Company was sold, and the Company made the decision to terminate the Plan effective October 11, 2024, subject to the provisions of ERISA. Contributions to the Plan ceased during October 2024. Liquidation of the Plan has been deemed imminent, and management has approved a plan for liquidation. Upon Plan termination, participants became 100% vested in their account balances. The Plan intends for all assets to be fully distributed by December 31, 2025.

**Note 8 Tax Status**

The Plan is an adoption of the CCH Incorporated DBA FTWilliam.com Pre-Approved Profit-Sharing Plan for which the Internal Revenue Service ("IRS") has determined and informed CCH Incorporated DBA FTWilliam.com by an opinion letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 10 Subsequent Events**

Plan management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
