Schedule SB, Part V – Statement of Actuarial Assumptions/Methods

- a. Mortality: The 2024 Static Mortality Tables were used for the period after retirement age. The optional combined tables for small plans were used, separately for male and female lives.
- b. Interest: Benefits were discounted by 4.75% (first segment rate) for payments expected from January 1, 2024 – December 31, 2028, by 4.96% (second segment rate) for payments expected from January 1, 2029 – December 31, 2043, and by 5.59% (third segment rate) for payments expected on or after January 1, 2044. These are the Segment Rates prescribed by IRC Section 430(h)(2)(C) for the 2024 Plan Year. For calculations under IRC Section 404(o)(2), the following segment rates applied: 4.37%, 4.96% and 4.95%.
- c. Salary Scale: 3.00% per annum.
- d. Severance of Employment: No discount for severance of employment was included in the factors on which costs were based.
- e. Assumed Retirement Age: It was assumed that all active employees would retire at their Retirement Age, or in one year if at or past Retirement Age. Terminated employees were assumed to retire immediately if at or beyond Retirement Age.
- f. Form of Benefit Payment: It was assumed that there would be a 100% probability of electing lump sum payments.
- g. Actuarial Value of Asset Valuation Method: The fair market value of assets was used.
- h. Expenses: The Target Normal Cost was increased by \$-0- to reflect anticipated expenses to be paid from the plan in the current year.
- i. Actuarial Cost Method: The method prescribed by IRC Section 430 was used which determines a minimum required contribution equal to the sum of the plan's Target Normal Cost for the plan year, plus a Shortfall Amortization charge [if any] and Waiver Amortization charge [if any] of a prior funding deficiency.
- j. Interest Crediting Rate: For principal credits accrued prior to 2023, the assumed interest crediting rate is based on average applicable rate during the current and last 4 plan years [or since plan inception, if less], which was 3.40% for the Partners and 4.51% for non-partners. Principal Credits earned by Partners after 2022 will earn 1.00%, while the Principal Credits earned by non-partners will earn 3.00%.
- i. Participants Included: It was assumed that employees who satisfied eligibility requirements by the July 1 entry date would be included for valuation purposes.

- f. Cash Balance Account: The value of a Participant's Cash Balance Account shall be determined by crediting the account of each participant with a Contribution Credit and Interest Credit each year based on employee classifications as defined by the Plan.

The Contribution Credit is credited at the end of the Plan year to eligible participants who have at least 1,000 hours during the Plan Year. The current value of the Cash Balance Account shall be the sum of all contribution and interest credits as of such determination date.
- g. Death Benefits: Full value of the Cash Balance Account.
- h. Severance Benefits: Vested in the Cash Balance Account based on years of service. Less than 3 years of service, 0%, and then 100% after 3 years of service. Full vesting upon attainment of retirement age, death or disability
- i. Timing of Benefit Payment: As soon as administratively feasible following termination of employment.
- j. Actuarial Equivalence: Applicable Mortality Table after retirement; 30-Year Treasury Rate as of November preceding each plan year.
- k. Optional Forms of Benefits: Life annuity and joint & survivor annuities.
