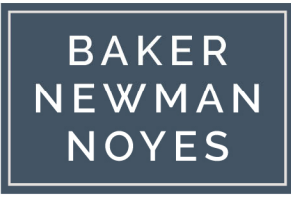

INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Copyright Clearance Center, Inc. Savings and Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Copyright Clearance Center, Inc. Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established by the Board of Directors of Copyright Clearance Center, Inc. (the Company) and became effective on January 1, 1989. The Plan is a defined contribution plan qualified under Section 401(a) and 401(k) of the U.S. Internal Revenue Code (IRC) covering eligible employees of the Company. Employees must be at least age 21. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective July 1, 2022, the Plan was amended to allow all prior service for employees of Ringgold, Inc. and Book News, Inc. to be included for eligibility and vesting requirements under the Plan.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act have been or will be adopted if elected and/or required.

Plan Trustee

The Plan Sponsor has entered into a service agreement with Fidelity Management Trust Company (Fidelity), whereby Fidelity is the trustee of the Plan and provides recordkeeping services to the Plan.

Contributions

Contributions to the Plan are made by both the participants and the Company. Eligible employees may elect to defer either pre-tax or after-tax compensation as defined by the Plan, subject to the maximum amount allowable under federal income tax regulations. The Company adds a matching contribution of 100% of the participants' elective deferrals (including catch-up contributions) not to exceed 4% of each participant's compensation as defined. Participants select the investments in which their accounts are invested. The Company makes nonelective contributions equal to 2% of each employee's compensation, as defined, for all eligible employees hired on or after January 1, 2007.

Effective January 1, 2025, the Plan provides for the optional SECURE Act provisions to allow increased catch-up contributions for participants between the ages of 60 and 63.

The Plan provides for an automatic election to have pre-tax contributions of 2% of compensation made for all participants upon first becoming eligible under the Plan. Participants may affirmatively elect a different percentage or elect not to make elective deferral contributions.

Rollover contributions are subject to conditions stated in the Plan and in the appropriate sections of the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the contributions of the participant and the Company and an allocation of earnings or losses and expenses of each fund based on the participant's relative account balances.

Vesting

Participants are immediately 100% vested in their voluntary contributions, employer matching contributions and the earnings thereon.

The Company's nonelective contribution plus earnings thereon are vested according to the following schedule:

Participants become fully vested upon normal retirement age (65), disability or death.

Forfeitures of employer contributions may be used to pay plan expenses and any remaining forfeitures are used to offset any future employer contributions that would otherwise be paid by the Company. At December 31, 2024 and 2023, \$8,811 and \$6,861, respectively, of forfeited nonvested amounts were included in net assets available for benefits. During the year ended December 31, 2024, forfeitures of \$31,202 were used to reduce employer contributions.

Participant Withdrawals

The Plan provides for participants to withdraw their funds at any time after reaching normal retirement age (65) or early retirement age (55) with five years of service. Such withdrawals are based on the amount in the participant's account as of the valuation date coinciding with or immediately after the participant's retirement date. Participants may also make in-service withdrawals upon attainment of age 59 ½. The Plan also provides for withdrawals in the event of death, disability, hardship or termination.

Effective March 29, 2024, the Plan adopted an auto portability feature in coordination with its recordkeeper and the Portability Services Network (PSN). Auto portability is designed to facilitate the automatic rollover of small account balances from a terminated participant's prior employer-sponsored retirement plan into their new employer's plan, provided that both plans participate in the PSN network.

The SECURE Act provisions includes a required change to the age at which required minimum distributions must commence from 72 to 73 for individuals who attain age 72 on or after January 1, 2023 and from age 73 to 75 for individuals who attain age 73 on or after January 1, 2033

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balances subject to Internal Revenue Service (IRS) limitations. Loans are repaid with interest through payroll deductions, normally within five years. Participants may have a maximum of two notes outstanding at any time. Participant loans bear interest at the Prime rate in effect on the date the loan is granted. Interest rates ranged from 3.25% to 8.50% at December 31, 2024 with various maturities through April 2034. During the repayment period of the loan, repayment amounts are reallocated among the investment funds in the same proportion as current investment allocations.

Administrative Expenses

The Company pays certain administrative expenses of the Plan, except for certain investment services which are paid by the Plan. Also, in accordance with the fee agreement certain fees incurred by the Plan for investment management services are included in investment income on the statement of changes in net assets available for benefits as they are paid through revenue sharing, rather than direct payment. See Note 7.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan accounts for transactions using the accrual basis of accounting.

Contributions

Contributions are recorded in the period in which payroll deductions are made; employer matching contributions and employer nonelective contributions are recorded in the same period as corresponding participant contributions. Employer discretionary contributions are recorded in the year to which the contributions relate.

Investment Valuation

All investments are valued at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at a measurement date. Certain Plan investments are stated at fair value based on net asset value (NAV). NAV is determined based on the fair value of the fund's underlying net assets and the number of units outstanding. See Note 6 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation in Fair Value of Investments

Net realized and unrealized appreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Participant loans are valued at their unpaid principal balance plus any accrued and unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans are treated as distributions based upon the terms of the Plan document. Interest income is recorded as earned on the accrual basis. Notes receivable from participants are reflected as participant loans on Form 5500.

Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks such as interest rate, market, liquidity and credit risk, among others. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Reclassifications

Certain 2023 amounts have been reclassified to conform to the 2024 presentation.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

3. Tax Status

The Plan operates under a non-standardized pre-approved basic plan document sponsored by FMR, LLC. The non-standardized pre-approved plan has received an opinion letter from the IRS as to its qualified status dated June 30, 2020, stating that the Plan was designed in accordance with applicable IRS requirements. While the Plan has been amended since the receipt of the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company, the trustee, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the trustee stating that the information provided to the Plan Administrator by the trustee is complete and accurate. Such information includes investments, dividend and interest income, net appreciation in fair value of investments, investment transactions, notes receivable from participants, interest income on notes receivable and notes receivable transactions.

The Plan offers various investment options to participants. Participants have the options of investing in Fidelity mutual funds, certain other mutual funds otherwise not offered by Fidelity, collective trust funds including a stable value fund and a brokerage account. Participants opting to invest in a brokerage account are allowed to invest in individual stocks, bonds, and mutual funds through an outside brokerage firm. Each participant selects the investments to which their account will be allocated. Investment options may be changed at any time during the year.

6. Fair Value Measurements

The Plan has adopted the framework for measuring fair value under generally accepted accounting principles.

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs are used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset and liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the net asset value (NAV) of shares held (based on quoted market prices) by the plan at year end. The mutual and money market funds are actively traded.

Collective trust funds: The Plan has interests in various collective trust funds which consist of the following: a family of Fidelity Freedom index date commingled pools Class B, and a stable value fund. The funds are open-end commingled pools dedicated exclusively to the management of assets of defined contribution plans. The collective trust funds are valued using NAV provided by the trustees as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. Were the Plan to initiate a full redemption of the collective trust funds, the trustees reserve the right to temporarily delay withdrawal from the collective trust funds (up to 12 months in the case of the stable value fund) in order to ensure that securities' liquidations will be carried out in an orderly business manner. The collective trust funds have no unfunded commitments, other redemption restrictions, or redemption notice periods.

Self-directed brokerage accounts: Accounts primarily consist of cash, exchange-traded funds, mutual funds and common stocks that are valued at the closing prices reported on the active market as well as certificates of deposit, which are valued based on estimates using current market offers for deposits with similar remaining maturities. Investments in certificates of deposit are classified within Level 2 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Party-In-Interest Transactions

Plan investments include certain investments managed by Fidelity, the current trustee, and therefore, these transactions qualify as party-in-interest transactions.

Direct administrative expenses paid by the Plan to Fidelity amounted to \$56,534. Additionally, in accordance with the fee agreement with Strategic Advisors, LLC, fees incurred by the Plan for the investment management and recordkeeping services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than a direct payment. Administrative expenses in 2024 were offset by \$235,913 of revenue credits from Fidelity because its recordkeeping revenues in connection with the Plan exceeded agreed-upon compensation. In addition, loans to participants qualify as party-in-interest transactions.
