We have performed an audit of the financial statements of Hexion Inc. Retirement Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

1 Description of Plan

The following description of Hexion Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan in which the majority of the U.S.-based associates of Hexion Inc. (“Hexion”, the “Plan Sponsor” or the “Company”), may participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was restated effective January 1, 2018 and is administered by the Global Benefits Committee appointed by the Board of Directors of the Company.

Eligibility:

Newly hired associates (who are not leased employees, independent contractors, or consultants) become eligible to participate in the Plan upon completion of one hour of service.

Contributions:

Employee Contributions - Highly Compensated Employees, as defined in the Plan, may make pre-tax, after-tax, and Roth contributions of 1% to 15% of eligible compensation. All other participants may make pre-tax, after-tax and Roth contributions of 1% to 25% of eligible compensation, or as otherwise defined in the Plan document. Newly hired associates completing one hour of service are passively enrolled in the Plan at a basic pre-tax savings contribution of 5%.

Employer Contributions - Hexion provides associates with matching contributions on a per pay period basis. The match consists of 100% of the first 5% of eligible compensation deferred. The Plan also provides for true-up matching contributions that take into account compensation on an annualized basis. Unless otherwise provided for by a collective bargaining agreement, Hexion associates are eligible for an Annual Retirement Contribution (“ARC”), which is determined as a percentage of eligible compensation, based on years of service. Hexion associates who are eligible may also receive an Employer Achievement Match, a discretionary matching contribution equal to 25% of the participant’s employer match, if the global performance targets set by the Board of Directors are met.

The Plan also allows for catch-up contributions in accordance with Internal Revenue Code Section 414(v).

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”), as defined in the Plan document.

1 Description of Plan, Continued

Participants' Accounts:

Each participant's account is credited with the participant's own contributions and an allocation of the employer's contributions and investment earnings, net of certain administrative expenses, and is charged with his or her withdrawals. Allocations are based on participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Under an agreement with the trustee and recordkeeper, the Plan receives revenue credits from certain mutual funds offered to participants. These credits are allocated to participant accounts.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts, including the earnings thereon, is based on years of continuous service.

Employer matching contributions and employer discretionary contributions made to non-bargained associates generally vest 100% upon the completion of three years of service. Vesting for certain other associates' accounts may vary based on the terms of collective bargaining agreements, as described in the Appendices to the Plan. These participants are 100% vested between five and seven years, depending on the collective bargaining agreement.

Forfeitures:

Following termination of employment, any unvested portion of a participant's account is forfeited at the earlier of the time of distribution of the vested portion, or upon five consecutive one year breaks in service. Funds from forfeitures are first applied to reinstate the unvested account balance for rehired participants whose previous termination resulted in forfeiture and who are re-employed by the employer prior to incurring five consecutive one year breaks in service. Any remaining forfeited funds may be used to fund future matching employer contributions or to pay allowable administrative expenses.

During 2024, forfeitures of \$210,524 and \$215,068 were used to fund employer contributions and to pay allowable administrative expenses, respectively.

Forfeited non-vested accounts totaled \$72,675 and \$8,165 as of December 31, 2024 and 2023, respectively.

1 Description of Plan, Continued

Notes Receivable from Participants:

Active Plan participants may elect to take loans from the Plan using their account as collateral and subject to the loan policy established by the Company and legal limitations. The loan repayment period is any multiple of months up to 60 months or up to 120 months for purchase of a primary residence. The fixed interest rate charged is the prime rate on the last day of the month prior to the inception of the loan. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Any delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits:

Participants become 100% vested in their account balance upon the attainment of age 65 (normal retirement age), death or disability. Benefits are recorded when paid.

Investment Options:

Upon enrollment in the Plan, participants can designate their contributions and employer contributions to be invested in a combination of mutual funds, a brokerage account, and collective trust funds. If the participant does not designate any funds, the account is invested in a Qualified Default Investment Account with a customized portfolio of investments based on the date the participant will attain age 65.

The Hexion Global Investment Committee (the “Committee”) periodically reviews the investment options in the Plan to evaluate each fund’s strategy, value, and performance.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Accordingly, revenues are recognized when earned and expenses are recognized when incurred.

Valuation of Investments:

The Plan's investments are stated at fair value. Marketable securities are reported at fair market value as of the financial statement date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Expenses:

Administrative fees paid by the Plan primarily represent trustee and recordkeeping expenses. Investment management fees and operating expenses charged to the Plan for plan investments are deducted from income earned on a daily basis and are not separately reflected.

Consequently, management fees and operating expenses of the funds are reflected as a reduction of investment return for such investments.

The Plan's fee structure includes a per-participant administrative fee, which is charged by the Plan's trustee and recordkeeper on a quarterly basis. Participants share the cost of trustee and recordkeeping fees and are charged quarterly for these fees which were used to pay administrative expenses.

Plan Termination:

Although the Company has not expressed any intent to do so, it has the right under the Plan, to the extent permitted by law, to discontinue its contributions or to terminate the Plan in accordance with the provisions of ERISA at any time. The Company also has the right under the Plan, to the extent permitted by law, to amend or replace the Plan for any reason. In the event of termination of the Plan, which is at the sole discretion of the Board of Directors of the Company, all contributions credited to participants' accounts will be fully vested and will be distributed to the participants in the manner provided by the Plan.

2 Summary of Significant Accounting Policies, Continued

Risk and Uncertainties:

The Plan invests in various investments. The Plan offers alternatives that mitigate participant risks, including the opportunity to diversify investments across numerous participant-directed fund elections; however, the underlying investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risks associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits and participants' individual account balances.

Contributions:

Contributions from the Plan participants and the related employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. ARC contributions are recorded in the year for which the related compensation is paid.

3 Tax Status

On January 5, 2017, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities.

The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access as of the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following is a description of the valuation methodologies used by the Plan for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds are based on quoted market prices and are classified in Level 1 of the fair value hierarchy.

Self-Directed Brokerage Accounts:

Accounts primarily consist of mutual funds whose values are determined by obtaining quoted market prices from a nationally recognized exchange and are classified in Level 1 of the fair value hierarchy.

4 Fair Value Measurements, Continued

Collective Trust Funds:

Fair values of the collective trust funds are based upon the net asset value (“NAV”) of the funds reported by the fund managers as of the Plan’s financial statement date. These investments are measured at fair value using NAV per share (or its equivalent) as a practical expedient.

Each collective trust held by the Plan, except for the Galliard Stable Value Fund X (“Galliard Fund”), provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The Galliard Fund does calculate its NAV daily, but provides for redemptions only following a 12-month notice period. No unfunded commitments exist for any of the collective trust funds. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.
