1. Description of Plan

The following description of the Finnegan, Henderson, Farabow, Garrett & Dunner, L.L.P. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Finnegan, Henderson, Farabow, Garrett & Dunner, L.L.P. (the Firm). Employees who have attained the age of 21 are eligible to participate in the Plan on the date of their employment.

The Plan excludes employees who have met the eligibility requirements to participate in Finnegan, Henderson, Farabow, Garrett & Dunner, L.L.P. Profit Sharing Plan (the Profit Sharing Plan), as defined in the plan document. In addition, the Plan excludes interns, summer associates, nonresident aliens, international guests, leased employees, and individuals hired in an office which is not located in the United States that is eligible to participate in a local governmental or privately sponsored retirement program. The Plan was established in 1997. The Plan was most recently restated effective January 1, 2014. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Firm pays the administrative expenses of the Plan other than certain recordkeeping and investment management fees that are included with net appreciation in fair value of investments on the accompanying Statement of Changes in Net Assets Available for Benefits.

Contributions

Each pay period, participants may make pre-tax salary deferral or post-tax Roth contributions to the Plan in amounts between 2% and 50% of their annual compensation, as defined in the plan document, subject to limits established by the Internal Revenue Service (IRS). Additionally, participants who are at least 50 years of age by the end of the respective calendar year are eligible to make catch-up contributions to the Plan. For 2024, the maximum amount of catch-up contributions was \$7,500. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a 4% pre-tax elective deferral and an annual increase of 1% each January, unless an affirmative election is made otherwise. The Plan does not provide for employer contributions to be made on behalf of its participants.

Participant Accounts

Participant's account are credited with the participants' contributions (pre-tax and/or Roth), rollover contributions, if any, and earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct their investments by investing in one or more of the investment options available in the Plan.

Vesting

Participants are immediately vested in their voluntary contributions and the actual investment return thereon.

Notes Receivable From Participants

The Plan may make loans to participants in an amount not exceeding the lesser of \$50,000 or 50% of the participant's account at the time of the loan. The loans bear interest at the prevailing U.S. bank prime rate of interest plus 1% at the time of making the loan, and the repayment period cannot exceed five years, unless the purpose of the loan is in connection with the purchase of a primary residence. In this case, the repayment period is up to 30 years. All loans are secured by a portion of the participant's account equal to the amount of the loan. All outstanding loans as of December 31, 2024 and 2023 were issued at interest rates between 4.25% and 9.50%.

Payment of Benefits

On termination of service, participants may elect a lump sum payment, annual installments or partial distributions. If the participant's vested account is greater than \$1,000 but no more than \$7,000, the participant's entire vested account shall be rolled into an individual retirement account designated by the Retirement Plans Committee. If a participant's vested account is less than \$1,000, the participant's entire vested account shall be distributed as a lump sum payment. Such distributions are made no later than 60 days after the end of the plan year in which the participant's termination of service occurs. In addition, the Plan allows for hardship distributions if certain criteria are met.

Transfers (to) From the Profit Sharing Plan

In addition to this Plan, the Firm also sponsors the Profit Sharing Plan. An employee of the Firm may not be an active participant in both plans. Therefore, once participants from this Plan meet the eligibility requirements and become participants in the Profit Sharing Plan, their active participation in this Plan ceases. Accordingly, the respective participant account balances are transferred from the Plan to the Profit Sharing Plan. This is reflected as transfers to the Finnegan, Henderson, Farabow, Garrett & Dunner, L.L.P. Profit Sharing Plan on the accompanying Statement of Changes in Net Assets Available for Benefits. Conversely, when participants change to a class of employee ineligible for the Profit Sharing Plan, their active participation in the Profit Sharing Plan ceases, and their account balances are transferred from the Profit Sharing Plan to the Plan. This is reflected as transfers from the Finnegan, Henderson, Farabow, Garret & Dunner, L.L.P. Profit Sharing Plan on the accompanying Statement of Changes in Net Assets Available for Benefits.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for the fully-benefit responsive contract which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 for details on inputs, valuation techniques and fair value measurement level within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

The Plan's investment in the fully benefit-responsive investment contract was reported at contract value. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they initiated permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans reclassified as distributions based on the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory and certain optional provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 8, 2025, the date the accompanying financial statements were available to be issued.

3. Fair Value Measurements

The Plan follows U.S. GAAP for measuring, reporting and disclosing fair value. These standards apply to all the assets and liabilities that are measured, reported and/or disclosed on a fair value basis.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consisting of common collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner

Self-directed brokerage accounts: These accounts include investments in mutual funds and exchange-traded funds and are valued based on the quoted market prices of the investments held by the Plan at year-end. As these prices are available on active markets, these fair value measurements are classified as having used Level 1 inputs.

The plan administrator is responsible for the determination of fair value. Accordingly, it preforms periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan administrator has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fully Benefit-Responsive Investment Contracts

As of December 31, 2023, the Plan held a fully benefit-responsive guaranteed investment contract, Vanguard Retirement Savings Trust (VRST), for which contributions were maintained in a collective trust account. The Plan no longer invested in VRST as of December 31, 2024. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants were permitted to direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer but was not less than zero. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) material plan amendments (including partial or complete termination of the Plan or merger of the Plan with another plan); (2) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited exemption under ERISA; (3) changes in the Plan's prohibition or competing investment options and (4) the closing of a business unit of the plan sponsor or the bankruptcy of the plan sponsor. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable of occurring.

5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by an affiliate of the trustee, as defined by the Plan. Transactions in such investments qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for investment management services of funds managed by the trustee are party in interest transactions. These fees are netted with investment income.

Fees for fund investment managers are included in net appreciation (depreciation) in the fair value of the investment. Prior to October 1, 2024 certain administrative recordkeeping fees were paid to the Trustee through revenue sharing which was included in net appreciation (depreciation) in the fair value of the investment. Effective October 1, 2024, the Plan transitioned to new investment fund share classes with lower fees and an annual fee deducted in quarterly installments from participant accounts. The Plan or Plan Sponsor may make payments to the Trustee for administrative expenses not covered by revenue sharing or the annual participant fee.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan has obtained its latest determination letter on June 3, 2016, in which the Internal Revenue Service (IRS) stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date this letter was received. The plan administrator believes that the Plan is currently designed, and being operated, in accordance with the applicable requirements of the IRC.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024, the Plan's investment in the Vanguard Institutional Index Fund Inst'l Shares, Vanguard Target Retirement 2045 Trust II and Vanguard Target Retirement 2050 Trust II totaled \$25,743,937, each representing greater than 10% of net assets available for benefits. As of December 31, 2023, the Plan's investment in the Vanguard Institutional Index Fund Inst'l Shares, Vanguard Institutional Target Retirement 2045 Fund and Vanguard Institutional Target Retirement 2050 Fund totaled \$24,455,493, each representing greater than 10% of net assets available for benefits.

9. Information Certified by Trustee

Accordingly, Vanguard Fiduciary Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

10. Qualified Nonelective Contributions

Certain participants enrolled in the Plan did not have their deferral contribution elections timely applied. A corrective qualified nonelective contribution of \$1,767 for the year ended December 31, 2024 is recorded as an employer contribution on the Statement of Changes in Net Assets Available for Benefits.
