### **Opinion**

We have audited the financial statements of the Henry Ford Health System Ambassador 403(b) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, as well as the related notes to the financial statements.

**NOTE A — DESCRIPTION OF THE PLAN**

**General**

The following brief description of the Henry Ford Health System Ambassador 403(b) Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan was adopted on January 1, 1999, and was amended and restated, effective January 1, 2022. The Plan is a tax-sheltered annuity pension plan established for the employees of Henry Ford Health System (“HFHS”) and certain affiliates under section 403(b) of the Internal Revenue Code (the “Code”). All employees become eligible to participate in the Plan on the first payroll date following their date of hire and become eligible for employer matching contributions following 12 months of employment.

All new HFHS employees hired after December 31, 2017, except for employees eligible for The HAP & Populance 401(k) Plan or the P-COR, L.L.C. Retirement Plan (which are separate defined contribution pension plans sponsored by affiliates of HFHS), become participants of the Plan, provided that they are not eligible to participate in the Henry Ford Health System Retirement Savings Plan (which is a separate defined contribution pension plan sponsored by HFHS).

In October 2024, HFHS combined with Ascension Michigan (“Ascension”). Approximately 17,000 employees of Ascension commenced participation in the Plan in the fourth quarter of 2024. These employees were permitted to roll over their balances from employee benefit plans sponsored by Ascension to the Plan.

**Asset Transfers**

The ability of certain participants of the Henry Ford Health System Heritage 403(b) Plan (the “Heritage 403(b) Plan”), a separate defined contribution pension plan sponsored by HFHS, to direct deferrals of their compensation to the Heritage 403(b) Plan ends once these participants become eligible for the Plan. At that time, these participants’ balances are transferred from the Heritage 403(b) Plan to the Plan. The amounts of net assets transferred during the years ended December 31, 2024 and 2023 were \$9,345,186 and \$1,461,335, respectively.

**Contributions**

The Plan allows participants to elect to defer a portion of their compensation up to the maximum amount currently allowed by law, plus any make-up contributions as allowed for by the Internal Revenue Service (the “IRS”) and the Plan document.

**NOTE A — DESCRIPTION OF THE PLAN (CONTINUED)**

**Contributions (continued)**

The amount of the participant's deferred compensation is treated as a participant elective contribution and allocated to that participant's elective account. HFHS makes qualified automatic contributions equal to 100 percent of a participant's elective deferrals, not to exceed one percent of compensation, plus 50 percent of a participant's elective deferrals in excess of one percent of compensation, up to six percent of compensation.

The Plan also has a second account for eligible participants, which is funded by employer contributions. For Plan years beginning in 2023, the second account (the "Supplemental Account") provides for HFHS to make, at its sole discretion, Supplemental Account contributions to be allocated among active participants as a uniform percentage of their compensation. In order to be eligible for the Supplemental Account contribution, a participant must (1) have earned a year of vesting service in that Plan year and (2) be employed by HFHS on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Supplemental Account contribution rates were 1.75 percent and 1.50 percent, respectively.

**Benefits**

Each participant's account is credited with the participant's contributions and the investment funds' earnings or losses, net of plan expenses. The distribution to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account. Distributions are allowed at age 59½ or upon retirement, disability, death, or termination of service.

**Vesting**

Participants are immediately vested in their contributions and the earnings thereon. Qualified automatic contributions, supplemental contributions, and transitional credit contributions become fully vested after two years of vesting service, pursuant to the terms of the Plan document.

**Forfeitures**

Forfeitures may be used to reduce employer contributions. HFHS employer contributions were reduced by \$3,263,680 and \$3,206,105 from forfeited nonvested accounts during the years ended December 31, 2024 and 2023, respectively. The balance available as of December 31, 2024 and 2023 was \$1,540,070, and \$825,439, respectively.

**Investment Options**

Upon enrollment in the Plan, participants may direct contributions in any of several investment options.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts their full vested balances. No more than two loans per participant may be outstanding at one time, and loans must be a minimum of \$1,000.

**Plan Administration**

Empower Trust Company, LLC serves as the trustee for the Plan. Empower Retirement serves as the Plan's recordkeeper.

**NOTE B — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investments**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

The Plan's investments in shares of registered investment companies and the underlying investments in self-directed brokerage accounts are valued at quoted market prices, which represent the net asset value of shares held by the Plan as of the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses on sales of securities are based on average costs. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are recorded at cost plus accrued interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant note receivable balance is reduced and a benefit payment is recorded. A valuation allowance for credit losses is not considered necessary as of December 31, 2024 or 2023.

**Fair Value Measurements**

The Plan uses fair value measurements in the preparation of its financial statements, which utilize various inputs, including those that can be readily observable, corroborated, or are generally unobservable. The Plan utilizes market-based data and valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Additionally, the Plan applies assumptions that market participants would use in pricing an asset or liability, including assumptions about risk.

The measurement of fair value includes a hierarchy based on the quality of inputs used to measure fair value. Financial assets and liabilities are categorized into this three-level fair value hierarchy based on the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The various levels of the fair value hierarchy are described as follows:

- Level 1 — Financial assets and liabilities whose values are based on unadjusted quoted market prices for identical assets and liabilities in an active market that the Plan has the ability to access
- Level 2 — Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable for substantially the full term of the asset or liability
- Level 3 — Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement

**Fair Value Measurements (continued)**

The use of observable market data, when available, is required in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

**Payment of Distributions**

Plan distributions to participants are recorded when paid.

**Administrative Expenses**

Reasonable and necessary expenses related to the administration of the Plan are payable out of Plan assets, as determined by HFHS.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, as well as disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various securities, including registered investment companies. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Subsequent Events**

The Plan's management has evaluated subsequent events through October 9, 2025, the date that the accompanying financial statements were available to be issued.

**NOTE D — PLAN TERMINATION**

Although it has expressed no intention to do so, HFHS has the right to terminate the Plan, subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). In the event the Plan is terminated, the net assets available to provide benefits would be distributed to the participants in proportion to their respective account balances after payment of expenses properly charged against the Plan.

**NOTE E — INCOME TAX STATUS**

The Plan has not applied for a determination letter from the IRS that would state that the Plan's design was in compliance with the applicable requirements of the Code because the IRS does not currently issue determination letters for retirement plans established under section 403(b) of the Code. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. In addition, the Plan administrator is not aware of any uncertain tax positions or unrecognized tax benefits as of December 31, 2024 or 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE F — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of a brokerage account managed by a party related to the Plan's trustee. Therefore, transactions involving these investments qualify as party-in-interest transactions.
