INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Compressor Engineering Corporation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Compressor Engineering Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Capital Bank and Trust Company ("CBTC") as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- the information in the accompanying financial statements related to assets held by and certified to CBTC agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Compressor Engineering Corporation 401(k) Profit Sharing Plan’s and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Compressor Engineering Corporation ("Company") 401(k) Profit Sharing Plan ("Plan"), formerly Compressor Engineering Corporation Cash or Deferred Arrangement (401(k)) Profit Sharing Plan and Trust, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan for employees of the Company and its wholly-owned subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Employees become eligible to participate in the Plan after they have completed one year of employment service, attained the age of 21 years, and have worked 1,000 hours in a single Plan year.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions - Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers multiple funds as investment options for participants. Contributions are subject to certain limitations.

The Company may make a discretionary pretax matching contribution. Each participant's contribution is based upon a percentage of annual compensation or a specified dollar amount which is determined by the individual and is limited to the lesser of 15% of the participant's compensation for the year or the maximum allowable as determined by IRS limits. Additionally, the Company may make discretionary profit-sharing contributions in an amount to be determined by the Board of Directors. There were no Company profit-sharing contributions for 2024.

Vesting - Each participant's contributions and allocated earnings thereon are fully vested and non-forfeitable. Participants' benefits become vested with respect to Employer contributions based upon the number of years of service with the Employer as designated in the Plan agreement. A participant is 100 percent vested after six years of credited service.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to 5 years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest determined by the Plan Administrator based on prevailing interest rates. The interest rate remains fixed throughout the duration of the loan. Principal and interest is paid ratably through after-tax payroll deduction.

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,829 and \$40,041, respectively. These amounts are included in Money market trusts and cash on the accompanying Statements of Net Assets Available for Benefits. These accounts may be used to reduce future employer contributions, pay administrative expenses, or be allocated to remaining participants. Forfeitures of \$19,768 were used to reduce employer contributions in 2024.

Payment of Benefits - On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or equal installments on a monthly or quarterly basis over a period not exceeding 20 years. The participant may also elect to roll funds into another retirement account.

2. SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accounting records of the Plan and the Form 5500 prepared by Capital Bank and Trust are maintained and presented on the cash basis. The accompanying financial statements are presented on the accrual basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income are recognized when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants are recorded based on the date the contributions are separated from a participant's pay by the Company, which is the pay date. Contributions from the Company are recorded in the year earned to coincide with the year the Company records the contributions in its financial statements. Rollover contributions from participants are recorded based on the date the contributions are received by the custodians.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

All significant expenses of maintaining the Plan are paid by the Employer. Participants are responsible for certain transaction fees, including but not limited to, withdrawal and loan fees. The Plan expensed brokerage and recordkeeper fees totaling \$24,949 for 2024.

Estimates

The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Date of Management's Review

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The money market trusts and cash, mutual fund, and self-directed brokerage from participants amounts included in the accompanying 2024 and 2023 Statements of Net Assets Available for Benefits and the earnings from these investments included in the Statement of Changes in Net Assets Available for Benefits have been certified as complete and accurate by Capital Bank and Trust Company ("CBTC"), Irvine, California. In addition, the information contained in the Schedule of Assets (Held at End of Year) has also been certified as complete and accurate by CBTC.

5. RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by The Capital Group Companies. These transactions qualify as party-in-interest transactions. Fees paid to The Capital Group Companies amounted to \$24,949 for the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive benefits based on their account balances accumulated to the date of Plan termination.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying financial statements. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity can access at the measurement date; Level 2 inputs consist of inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly; and Level 3 inputs consist of unobservable inputs for the asset or liability. Level 1 is given the highest priority while Level 3 is given the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure fair value of its investments. All investments held by the Plan as of December 31, 2024 and 2023 are deemed to be Level 1 assets.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset values of the shares held by the Plan at year end.

Self-directed brokerage accounts: Consist primarily of cash accounts (both interest and non-interest bearing), individual corporate common stocks and mutual funds, valued at closing prices reported on the open market.

Money market trusts and cash: Valued at net asset values of funds held by Plan at year end.
