Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ironroad, Inc. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Ironroad, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, as amended, is a salary reduction plan covering substantially all persons who were eligible employees of Ironroad, Inc. (the "Company") on January 1, 1997. Effective January 1, 2002, the Plan is intended to constitute a multiple employer plan subject to Section 413(c) of the Internal Revenue Code (IRC) for participants of any participating employer. The employee's eligibility requirements range from 18 to 21 years of age and completion of up to one year of service as specified by the participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may enter into a salary reduction agreement with the Company or any participating employer whereby the Company is authorized to reduce pre-tax or after-tax earnings (as defined in the Plan), or any part thereof, by such percentage as the participant shall specify. This salary reduction is subject to certain limitations as set by the Plan administrator and the Internal Revenue Service.

The Plan allows for each participating employer to contribute a profit sharing amount and a matching contribution as determined by the respective Plan document. These contributions are credited to the participant in accordance with the participant's investment elections.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting provisions for each participating employer profit sharing and matching contributions and earnings thereon vary between participating employers; however all participants are fully vested upon reaching six years of credited service.

Payments of Benefits

On termination of service due to termination of employment, death, disability or retirement, a participant is entitled to receive a lump sum amount equal to the value of his or her vested account. In the event of a participant's death, the entire account balance is automatically paid to the participant's beneficiary. Benefit payments to participants are recorded upon distribution. If a terminated participant's balance exceeds \$1,000 but is less than \$5,000, and the participant fails to make an election to receive a lump sum amount or a direct rollover to a participant selected plan, a distribution will be paid by the Plan administrator as a direct rollover to an individual retirement account designated by the administrator. In addition, hardship, early retirement, and in-service distributions are permitted if certain criteria are met.

1. Description of the Plan (Continued)

Forfeited Accounts

Forfeitures of nonvested Company contributions and allocated earnings are used to pay for plan expenses or to reduce future Company contributions to the Plan. Forfeitures used for the years ended December 31, 2024 and 2023 were \$70,193 and \$27,821, respectively. Unallocated forfeitures at December 31, 2024 and 2023 were \$84,463 and \$100,583, respectively.

Notes Receivable from Participants

The Plan allows participants to borrow from their vested account. Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the vested balance of their account, with a term of one to five years, unless the proceeds are used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% on the effective date of the loan. Principal and interest are paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in various investment options offered by the Plan. Employer contributions follow the same investment options elected. Participants may change their investment options daily. The investment options are diversified in conformity with the ERISA diversification requirement.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fully benefit-responsive investment contracts are reported at contract value. Contract value approximates fair value at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and the insurance company (see Note 6).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Payment of Expenses

All administrative expenses may be paid out of the Plan unless paid by the Employer. Such expenses shall include any expenses incident to the functioning of the administrator, including but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. The Company elected to pay a portion of the expenses of the Plan during 2024 and 2023.

3. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Party-In-Interest Transactions

Certain Plan investments are managed by The Lincoln National Life Insurance Company. This company was Custodian for the years ended December 31, 2024 and 2023, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Total fees paid to Lincoln National Life Insurance were \$340,429 and \$124,969 for the years ended December 31, 2024 and 2023, respectively. The Plan has various other providers for advisory and recordkeeping services. Total fees paid to other providers were \$137,527 and \$265,659, respectively.

5. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplementary schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment gain from all investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by The Lincoln National Life Insurance Company, Custodian of the Plan.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other meansIf the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies the Plan used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. There are no unfunded commitments or significant redemption restrictions at December 31, 2024 and 2023.

Money market fund: Valued at the daily closing price as reported by the fund. The money market is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

7. Investment with Insurance Company

The Plan has a fully benefit-responsive stable value fund with The Lincoln National Life Insurance Company (Lincoln), Custodian of the Plan, totaling \$1,913,987 and \$1,401,818 at December 31, 2024 and 2023, respectively. The contributions are maintained in a general investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by Lincoln, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. This type of investment is considered a deposit liability with no defined maturities and is fairly valued at contract value; therefore, the contract value is estimated to be the fair value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan is changed so as to significantly affect Lincoln's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract requirements or (5) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment has a portfolio investment rate design in which all deposits in the investments are credited with the same interest rate on a daily basis, with no set maturity. Such interest rates are reviewed on a semi-annual basis for resetting and are effective on the first day of the first and seventh months of the year. Average yield and crediting rate for the years ended December 31, 2024 and 2023 was 2.77% and 2.54%, respectively.

8. Risks and Uncertainties

The Plan invests in various investment options. These investment options are exposed to risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants shall become 100% vested in their accounts.

10. Delinquent Participant Contributions

Participant deferrals in the amount of \$2,060 and \$8,158 were not remitted to the Plan by the Company within the appropriate time period prescribed by law for the years ended December 31, 2023 and 2022, respectively. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of these occurrences and is taking corrective action.

11. Excess Contributions Payable

For the Plan year ended December 31, 2024 and 2023, distributions of \$39,764 and \$57,583, respectively, were required to return excess contributions to certain participants in order to satisfy the relevant nondiscrimination provisions of the Plan.

12. Subsequent Events

Management evaluated the activity of the Plan through October 8, 2025 (the date the financial statements were made available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
