### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

**Note 1 - Plan Description:**

The following description of the Bacon, Farmer, Workman Engineering and Testing, Inc., (“Company” or “Sponsor”) 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions, which is available from Plan management.

**General**

The Plan was formed on January 1, 2003 (inception of the Plan). The Plan is a qualified, defined contribution plan covering all eligible employees of the Sponsor’s controlled group who are age 21 or older. Ineligible employees consist of employees who are members of a collective bargaining unit, leased employees, and nonresident aliens. An employee becomes eligible to participate in the Plan on their employment commencement date. Participants may enter the Plan on the first day of the calendar month once the time eligibility criteria has been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor’s management team oversees governance of the Plan. They determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Plan Sponsor.

**Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may also contribute up to 100% of after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee contributions are not to exceed the Section 402(g) Internal Revenue Code (the IRC) limitation for the calendar year. Newly hired employees will be automatically enrolled in the Plan at an 8% deferral of their compensation unless they indicate a desire not to contribute or elect to enroll at a different percentage. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make a discretionary matching contribution equal to 50% of deferrals up to 12% of the participant’s eligible compensation after July 1, 2023. The Company’s matching contribution is invested as directed by the participant.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers participants several different investment choices, including mutual funds and a money market fund.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, and an allocation of Plan earnings net of any Plan expenses. Allocations are based on participant account balances and current contributions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, based upon a graduating schedule. A participant is vested 20% after two years and 20% for each additional year of service.

**Note 1 - Plan Description (Continued):**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Participant Loans - Defaulted**

Defaulted loans are loans resulting from the failure of a participant to make the required loan repayment on an outstanding loan. These loans are considered a distribution to the participant for which a Federal 1099 tax form is issued. For 2024, defaulted loans total \$26,360.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions in 2024.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$46,827 and \$19,034, respectively. Forfeitures can be used to offset Plan expenses or to reduce matching contributions. During 2024, \$7,369 was used to pay for Plan expenses.

**Note 2 - Accounting Policies:**

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Note 2 - Accounting Policies (Continued):**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivables from participants are included in administrative expenses and charged directly to the participant's account.

**Note 3 - Income Tax Status:**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and several amendments have been made to the Plan. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 4 - Plan Termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 5 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued based on fair market value; this fund is based on cash held at year-end.

**Note 6 - Related Party Transactions:**

Certain Plan investments are shares of mutual funds provided through Fidelity. Fidelity is the record keeper and trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 7 - Information Prepared and Certified by the Trustee:**

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, investment income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to Plan management and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**Note 10 - Subsequent Event:**

**Note 1 - Plan Description:**

The following description of the Bacon, Farmer, Workman Engineering and Testing, Inc., (“Company” or “Sponsor”) 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions, which is available from Plan management.

**General**

The Plan was formed on January 1, 2003 (inception of the Plan). The Plan is a qualified, defined contribution plan covering all eligible employees of the Sponsor’s controlled group who are age 21 or older. Ineligible employees consist of employees who are members of a collective bargaining unit, leased employees, and nonresident aliens. An employee becomes eligible to participate in the Plan on their employment commencement date. Participants may enter the Plan on the first day of the calendar month once the time eligibility criteria has been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor’s management team oversees governance of the Plan. They determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Plan Sponsor.

**Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may also contribute up to 100% of after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee contributions are not to exceed the Section 402(g) Internal Revenue Code (the IRC) limitation for the calendar year. Newly hired employees will be automatically enrolled in the Plan at an 8% deferral of their compensation unless they indicate a desire not to contribute or elect to enroll at a different percentage. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make a discretionary matching contribution equal to 50% of deferrals up to 12% of the participant’s eligible compensation after July 1, 2023. The Company’s matching contribution is invested as directed by the participant.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers participants several different investment choices, including mutual funds and a money market fund.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, and an allocation of Plan earnings net of any Plan expenses. Allocations are based on participant account balances and current contributions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, based upon a graduating schedule. A participant is vested 20% after two years and 20% for each additional year of service.

**Note 1 - Plan Description (Continued):**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Participant Loans - Defaulted**

Defaulted loans are loans resulting from the failure of a participant to make the required loan repayment on an outstanding loan. These loans are considered a distribution to the participant for which a Federal 1099 tax form is issued. For 2024, defaulted loans total \$26,360.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions in 2024.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$46,827 and \$19,034, respectively. Forfeitures can be used to offset Plan expenses or to reduce matching contributions. During 2024, \$7,369 was used to pay for Plan expenses.

**Note 2 - Accounting Policies:**

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Note 2 - Accounting Policies (Continued):**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivables from participants are included in administrative expenses and charged directly to the participant's account.

**Note 3 - Income Tax Status:**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and several amendments have been made to the Plan. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 4 - Plan Termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 5 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued based on fair market value; this fund is based on cash held at year-end.

**Note 6 - Related Party Transactions:**

Certain Plan investments are shares of mutual funds provided through Fidelity. Fidelity is the record keeper and trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 7 - Information Prepared and Certified by the Trustee:**

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, investment income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to Plan management and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**Note 10 - Subsequent Event:**

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
