We have performed audits of the financial statements of Chicago Sun-Times Media Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Chicago Sun-Times Media Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Chicago Sun-Times Media, Inc. (the "Company") who are regularly scheduled to complete 1,000 hours of service during a plan year or who have completed 1,000 hours of service within a 12-month period of service. The Plan does not cover nonresident aliens who received no earned income from an employer that constitutes income from services within the United States, independent contractors, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

Chicago Sun-Times Media, Inc. is the Plan's sponsor. The Plan is administered by a benefit plan committee, which is appointed by the board of directors.

Empower Annuity Insurance Company and Empower Trust Company, LLC are the Plan's trustees.

#### **Contributions**

The Plan provides for employee pretax and Roth 401(k) salary deferral contributions of no less than 1 percent and up to a maximum of 50 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may designate all or a portion of their contributions as Roth 401(k) contributions, which are after-tax contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make annual discretionary matching contributions to employees eligible to participate in the Plan who have met a minimum service period of one year. Annual discretionary matching contributions are approved by the benefits plan committee and are based on eligible compensation. In 2024, the Company made \$192,645 of total discretionary contributions to the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

Employer matching contributions are fully vested at all times and are not subject to forfeiture for any reason.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Participants can have only two loans currently outstanding from the Plan at any time. Notes receivable are collateralized by the participant's account balance and bear interest at rates that are commensurate with prevailing market rates determined by the plan administrator. The notes generally have a term of 5 years or less. Loans for the purchase of a principal residence can be paid over a reasonable period of time that may not exceed 15 years. Principal and interest are paid ratably through payroll deductions.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's spouse or beneficiary, in the case of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or defer payment until normal retirement age. Vested account balances of less than \$1,000 are automatically distributed in a single lump sum upon termination. Vested account balances between \$1,000 and \$5,000 are distributed to an individual retirement plan unless the participant elects to receive the distribution directly. Active participants may also begin taking penalty-free distributions from the Plan upon reaching the age of 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company and Empower Trust Company, LLC or their affiliates. Empower Annuity Insurance Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Empower Annuity Insurance Company Guaranteed Income Fund is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Subsequent to year end, the Company had a workforce reduction as a result of a voluntary buyout that impacted participants in the Plan. As a result of this reduction, the Company is consulting with its legal counsel regarding whether a partial plan termination occurred. If a partial plan termination occurred, the affected participants will become 100 percent vested in their account balances. Affected participants that terminated prior to the partial termination remain subject to the applicable vesting rules at the time of termination.

**Note 3 - Certified Information**

Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, the "Trustees") hold the Plan's investments and participant notes receivable and execute all related transactions during 2024. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodology has been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets. There were no unfunded commitments or redemption restrictions on the investments described below.

**Note 5 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Unallocated Contract**

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.5 percent. When establishing interest crediting rates for this product, Empower considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

**Note 6 - Unallocated Contract (Continued)**

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
