## Report of Independent Auditors

To the Participants and Plan Administrator of  
Premier 401(k) Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Premier 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024 and 2023

### **1. Description of Plan**

The following description of the Premier 401(k) Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. Premier Hotels & Resorts Guam, Inc. dba RIHGA Royal Laguna Guam Resort (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution plan covering all employees of the Company who are at least 18 years of age and have completed three months of service except for union employees, leased employees and others as indicated in the Plan.

The Company is the plan administrator and is responsible for the general administration of the Plan. ASC Trust, LLC (ASC) is the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Each year, participants may contribute up to the maximum amount of their compensation allowable under the provisions of the Internal Revenue Code (the Code). Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company contributes fixed profit-sharing contributions at 2% of eligible participant compensation after completing at least 1,000 hours of service within 12 consecutive months and attaining age 18 and older.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's profit-sharing contribution and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

# Premier 401(k) Retirement Savings Plan

## Notes to Financial Statements, continued

### 1. Description of Plan, continued

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contributions is based on years of vesting service as follows:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year	30%
2 years	40%
3 or more years	100%

The participant is eligible for the Company's profit-sharing contributions if at least 1,000 hours of service are completed during twelve consecutive months.

A participant will become fully vested in discretionary matching, if any and profit-sharing contributions account balance upon death, total and permanent disability or termination of employment on or after normal retirement age.

#### Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts may first be applied to pay any administrative expenses and then applied to reduce employer contributions. There were no forfeitures used to reduce Company contributions in 2024. Unallocated forfeiture balances as of December 31, 2024 were approximately \$16,000. There were no forfeitures at December 31, 2023.

#### Participant Loans

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and not less than \$1,000. Loan terms range from one to five years or up to 30 years for the purchase of a principal residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance in the preceding 12-month period, even if the amounts have been repaid. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing U.S. prime interest rate plus one percent (1%) and shall remain fixed for the life of the loan. Principal and interest is paid ratably through monthly payroll deductions over not more than five years, except for loans to purchase a principal residence. If a participant terminates employment with the Company, the loan balance will become due and payable in its entirety unless directly rolled over (if otherwise permitted) to another employer's plan. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

## Premier 401(k) Retirement Savings Plan

### Notes to Financial Statements, continued

#### **1. Description of Plan, continued**

##### **Payment of Benefits**

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant may elect to receive an amount equal to the vested value of the participant account in a lump-sum payment.

Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting hardship withdrawal.

In-service withdrawals are not permitted.

##### **Administrative Expenses**

The Plan's administrative expenses are paid either by the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Contributions**

Participant contributions are recorded in the year in which the participant contributions are withheld from compensation. Employer fixed profit-sharing contributions are recorded in the year eligible participant earned the related compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

### Notes to Financial Statements, continued

#### **2. Summary of Significant Accounting Policies, continued**

##### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, without an approved leave of absence for a period exceeding one year and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Subsequent Events**

Management has evaluated subsequent events through October \_\_, 2025, the date on which the financial statements were available to be issued.

#### **3. Investments**

The investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by ASC.

#### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 - Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Following is a description of the valuation techniques and inputs used for each general type of investments measured at fair value by the Plan.

*Common/Collective Trust Funds:* The common/collective trust fund investments are valued at their fair value that is readily determinable, published and is the basis for current transactions. These funds are classified within level 1 of the valuation hierarchy.

*Registered Investment Companies:* Registered investment companies consist primarily of mutual fund investments. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common/collective trust funds consist of separate investment profiles that provide an appropriate mix of investments that have the potential to produce the desired return while reducing volatility in the overall value of the portfolio. The profiles primarily invest in registered mutual funds, exchange-traded funds and collective trust funds. These investments have no redemption restrictions.

#### **6. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **7. Party-in-Interest Transactions**

The Plan holds units of common/collective trust funds managed by ASC. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

#### **8. Income Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Subsequent to this opinion from the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2020.
