Note 1           Description of the Plan

On June 1, 2012, Liberty Truck Center, Inc. (“Sponsor” and “Company”), a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, adopted a retirement plan known as the Liberty Truck Center & Tafton Fuel Stop 401k Plan (“Plan”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following Participating Employers initially adopted the Plan: Tafton Fuel Stop, Inc. and Rocky Restaurants, LLC.

Effective July 1, 2022, the following Plans merged with the Plan: Raceway Restaurants, Inc. 401k Plan, Raceway Management Co., Inc. 401k Plan, Singh Realty LLC & Liberty Bean 401k Plan. Accordingly, \$2,215,687 was transferred from these plans into the Liberty Truck Center & Tafton Fuel Stop 401k Plan. Also, effective July 1, 2022, the following Participating Employers adopted the Plan: Liberty Bean, LLC, Raceway Hospitality, LLC, Raceway Management Co., Inc, Raceway Management NY, Inc, Raceway Restaurants, Inc., and Singh Realty, LLC.

Effective January 1, 2023, the plan was amended to change the eligibility requirements from twelve (12) months of service to three (3) months of service. Also, effective February 1, 2023, the plan was further amended to change the Plan name from Liberty Truck Center & Tafton Fuel Stop 401K Plan to Onvo 401k Plan.

In December 2022 Securing a Strong Retirement Act (Secure 2.0) was passed into law. For Plan years beginning January 1, 2023, the Plan is operating in accordance with the mandatory provisions. Secure 2.0 included both mandatory and optional provisions, the Plan Administrator will determine the optional provisions to elect.

The Committee appointed by the Sponsor is the administrator of the Plan and determines the appropriateness of its Plan’s investment offering, monitors investment performance and reviews with the Plan’s Trustees.

The Plan provides that an eligible participant may elect to defer a specific percentage of their annual compensation, as defined in the Plan, not to exceed \$23,000, \$30,500 for participants ages 50 or older, adjusted annually for cost-of-living changes. Participants may also contribute amounts representing distributions from other qualified benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a Safe Harbor Plan; as such the Company will contribute a Safe Harbor matching contribution for participant’s who satisfy the applicable eligibility requirements. The Safe Harbor matching contributions are 100% of the participant’s salary deferrals that do not exceed 4% of the participant’s compensation. The Company may also contribute a flexible discretionary matching contribution.

Note 1 Description of the Plan (Continued)

The abovementioned employer's contributions, along with participant's contributions, plan earnings (losses) and applicable expenses will be credited / debited to each participant's account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan provides that participants may borrow from their vested account balance, a minimum of \$500 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest when the loan is taken out. Principal and interest is paid ratable through payroll deductions.

Forfeitures of non-vested accounts were \$0 and \$0 for years ended December 31, 2024 and 2023, respectively. Forfeitures can be used to reduce Plan expenses and reduce Employer Contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested account balances were \$45 and \$45, respectively.

A more detailed explanation of the Plan, including but not limited to eligibility, vesting, loan, and benefit provisions, is provided in the Onvo's Inc 401k Plan Summary Plan Description.

Note 2 Summary of Significant Accounting Policies

Date of Management Review: Pursuant to FASB ASC 855 Subsequent Events were evaluated through September 25, 2025 which is the date the financial statements were available for issue.

Basis of Accounting: The financial statements of the plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are administered under a trust agreement with Reliance Trust Company. The Plan's investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by Reliance Trust Company. Investments in mutual funds are valued based on quoted Net Asset Values (NAV) of the shares held by the Plan at year end. The mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. The Fund must publish their daily net assets value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

See Note 4 for further discussion of Fair Value measurements.

Note 2      Summary of Significant Accounting Policies (Continued)

Interest Income: Interest Income is recorded on the loan amounts on the accrual basis.

Dividend Income: Dividend Income is recorded based on the ex-dividend date and is reported by Reliance Trust Company.

Net Appreciation in Fair Value of Investments: Includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Employer Contributions: Safe Harbor matching contributions are made and are based upon amounts actually computed throughout the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent asset and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation of fair value of investments.

Note 3      ERISA 103 (a)(3)(C) – Certification of Investments

Certain information related to the Investments at Fair Value disclosed in the accompanying financial statements and supplemental schedule, including investments and note receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair values of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the Trustee of the Plan).

Note 4 Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for Investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. As of December 31, 2024 or 2023, the Plan did not have any Level 2 or 3 inputs.

The valuation methodologies used for assets measured at fair value are discussed further in Note 2.

Note 7      Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Note 8      Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10            Income Tax Status

The Prototype Plan Sponsor, ADP, LLC, has received a favorable opinion letter dated October 6, 2020 in which the Internal Revenue Service states that their Non-Standardized Prototype Plan, as adopted by the plan sponsor, is acceptable under the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Tax Plan Administrator believes the Plan is no longer subject to income tax examination for years prior to 2021.

Note 11            Plan Benefits and Termination

Although not under obligation to make contributions to the fund, the Plan's Sponsor has not expressed any intent to discontinue contributions thereto or terminate the Plan subject to the provision of ERISA. In the event of termination of the Plan all amounts credited to employee accounts will remain fully vested and paid as soon as administratively practicable after termination.
