We have performed audits of the financial statements of Jenoptik North America 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Description of the Plan

The following description of the Jenoptik North America 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 2004 and was amended and restated effective June 1, 2022. The Plan is sponsored by Jenoptik North America, Inc. (the Company or Plan Administrator). The Plan is a defined contribution plan covering all eligible employees of the Company and its subsidiaries, including Jenoptik Automotive North America, LLC; Jenoptik Optical Systems, LLC; Traffipax, LLC; and Jenoptik Advanced Systems, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The trustee of the Plan is Reliance Trust Company (the Trustee). The Plan's recordkeeper is ADP Retirement Services. The Company has given Reliance Trust Company the authority to hold the assets of the Plan and to invest, control, and disburse all the assets of the Plan in accordance with the Plan agreement.

Effective January 1, 2023, the Trioptics, Inc. 401(k) Plan merged into the Plan. The net assets of \$545,428 were transferred in January 2023, which included \$17,290 of outstanding loans. All eligible employees of the Trioptics, Inc. 401(k) Plan became eligible immediately to participate in the plan.

Eligibility

Under the terms of the Plan agreement, substantially all employees of the Company, except for union employees and non-resident aliens, are able to participate in the Plan if they have completed three months of service and are age 21 or older. Once eligible, participants may enter the Plan on the first day of each month and participants are immediately eligible for all contribution types.

Effective January 1, 2023, the Plan was amended to exclude leased employees and decrease the eligibility requirements to 20.5 years old.

Contributions

Each year, participants may contribute up to 90% of their compensation, as defined by the Plan agreement, subject to Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan also allows for Roth contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make matching contributions to all contributing participants. During the years ended December 31, 2024 and 2023, the Company contributed an amount equal to 50% of a participant's contributions up to 6% of the participant's annual compensation.

Discretionary nonelective contributions (profit-sharing contributions) may be made at the discretion of the Company. There were no profit-sharing contributions during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and the employer contributions, as well as an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary nonelective contributions (profit-sharing contributions) portion of their accounts is based on periods of service in accordance with the following schedule:

An employee is considered to have completed one period of service for purposes of vesting upon the completion of each 12-month period from the employee's first day of employment completed at any time during a Plan year. Additionally, participants will be 100% vested in employer matching and discretionary nonelective contributions if the participant is employed on or after their normal retirement age, which is defined as 65 years of age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period) or 50% of their vested account balance. Participants may not exceed two loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through monthly payroll deductions over a period not to exceed five years, unless the loan is used to purchase a primary residence in which case the loan term may not exceed 15 years.

Payment of Benefits

Distributions from the Plan are available to participants or their beneficiaries at retirement, as a result of permanent disability, upon termination of employment, or death. Distributions may also be made to participants upon attainment of age 59½ and due to financial hardship, as defined in the Plan agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,065 and \$54,190, respectively. Forfeitures arising from terminated participants with less than a fully vested interest in the Plan are used to pay administrative expenses and used to reduce future Company contributions to the Plan. During the years ended December 31, 2024 and 2023, forfeitures used by the Plan totaled \$129,242 and \$63,364, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan will pay some or all Plan-related expenses. The expenses charged to the Plan, such as audit fees, investment management fees, and Plan administrative fees may be charged pro-rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. In addition, certain expenses are charged to some participant accounts based upon their use of a Plan feature or receipt of a distribution. Certain investment-related expenses are included in net appreciation of fair value of investments. All other expenses of the Plan for the years ended December 31, 2024 and 2023 were paid by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued. There were no subsequent events impacting the Plan that require recognition or disclosure in the financial statements.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, the framework for measuring fair value, provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - These accounts comprise common stock, mutual funds, fixed income securities, and exchange traded funds. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

Collective Investment Trust (CIT) - This asset is valued at the NAV of units held. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The CIT is a direct filing entity. There are no unfunded commitments or redemption restrictions related to the CIT as of December 31, 2024.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee. Participant loan and distribution processing fees are paid to ADP Retirement Services, the recordkeeper, by participants. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers, including third-party administrator fees, investment advisory fees, and audit fees. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings (losses) on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

7. Tax Status

The Plan uses a pre-approved defined contribution plan document sponsored by ADP Retirement Services. ADP Retirement Services received an opinion letter from the IRS, dated October 6, 2020, which states that the pre-approved document, as then-designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Delinquent Participant Contributions

During the Plan years ended December 31, 2017 and December 31, 2021, participant contributions totaling \$24,504 and \$88, respectively, were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Company is in the process of completing a voluntary fiduciary correction program filing (VFCP) with the DOL.

These non-exempt transactions do not affect the tax status opinion of the Plan and the Company intends to pay all potential fines imposed.
