## Independent Auditor's Report

To the Plan Administrator

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of American Florist Supply, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



## Notes to the Financial Statements

December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN

The following description of the American Florist Supply, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of American Florist Supply, Inc. (the Company or Plan Sponsor). The Plan was adopted on January 1, 2001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2018, the Plan was restated and amended to redefine eligible compensation and implement changes required by the Internal Revenue Code (IRC) to be a qualified retirement plan. Effective July 1, 2022, the Plan was amended and restated to bring the Plan in compliance with recent legislative and regulatory changes set forth by the Internal Revenue Service (IRS). Subsequent to December 31, 2024, the Plan was restated and amended on September 1, 2025 to increase automatic employer deferrals by 1 percent for every succeeding anniversary date to a maximum of 10 percent.

**Contributions** - Participants may contribute up to 90 percent of pretax annual compensation, as defined by the Plan, and are eligible to make salary deferrals upon completing two months of service. All newly eligible employees are subject to automatic enrollment in the Plan, contributing 3 percent of eligible compensation, unless otherwise elected. In addition, the Plan allows participants to make Roth 401(k) contributions subject to certain IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants are eligible for employer matching contributions upon completing one year of service and working at least 1,000 hours. Participants are also eligible for discretionary nonelective profit sharing contributions upon attaining age 21, completing one year of service, and working at least 1,000 hours. For the plan year ended December 31, 2024, the Company made matching contributions of 35 percent on the first 6 percent of the participant's compensation that participants contributed to the Plan through salary deferrals. The Company did not make a non-elective profit sharing contribution for the plan year ended December 31, 2024.

Participants who have attained the age of 50 before the close of the calendar year are eligible to make additional catch-up contributions to the Plan in accordance with and subject to limitations of the Plan and the IRC.

Participants direct the investment of their contributions and employer contributions to the Plan into various investment options offered by the Plan.

## Notes to the Financial Statements

**Participant accounts** - Each participant's account is credited with the participant's contributions, Company matching contributions, the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20 percent vested after two years of credit service and continues to vest in increments of 20 percent annually until 100 percent vested after six years of credited service. A participant's interest in their account shall become fully vested if employment terminates due to death, disability or normal retirement age (65).

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of the participant's vested account balance or \$50,000. Loan terms are up to five years, except for loans to fund the purchase of a principal residence, for which the loan may be repaid over a reasonable period that may exceed five years, as determined by the plan administrator. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - Upon reaching normal retirement age (defined as 65 years) or anytime thereafter, or upon death or disability (as defined) prior to retirement or termination of employment, benefits become available for disbursement under the Plan. Participants may also elect to make certain in-service withdrawals from the Plan upon reaching age 59 ½, subject to certain federal and state withholding requirements.

Participants may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the life expectancy of the participant or applied to the purchase of an annuity contract. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Hardship withdrawals** - In accordance with a uniform and nondiscriminatory policy adopted by the plan administrator, a participant may withdraw a portion of the vested balance to meet immediate and heavy financial needs as defined by the IRC, subject to certain limitations outlined in the Plan.

**Forfeitures** - Forfeitures may be used to pay administrative expenses of the Plan or to reduce the employer matching contribution. For the years ended December 31, 2024 and 2023, no forfeitures were used to pay administrative expenses. During 2024, there were forfeitures of \$13,746 which were allocated against employer matching contributions.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates** - The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Actual results could differ from those estimates. Any adjustments applied to estimate amounts are recognized in the year such adjustments are determined.

**Investment valuation and income recognition** - The Plan's investments are held in various mutual funds. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair value measurements** - The Plan currently records, on a recurring basis, the fair value of its investments. U.S. GAAP defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.
- Level 2 - Inputs to the calculation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs based on the Plan's assessment of the assumptions that market participants would use in pricing the asset or liability.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value, on a recurring basis, as well as the general classification pursuant to the valuation hierarchy. There have been no changes in the methodology used on December 31, 2024 and 2023.

*Mutual Funds* – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the investments could result in a different fair value measurement at the reporting date.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant fails to make a payment when a loan is due under the terms of the loan, that participant will be in default. In the event of default, the loan shall become due and payable immediately, and interest will continue to accrue until the entire loan balance is repaid. The Plan will take all reasonable actions to collect the balance owed on the loan. Under certain circumstances, the loan in default could be considered a distribution from the Plan and could be considered income to the participant. In any event, failure to repay a loan will reduce the benefit to which a participant would otherwise be entitled from the Plan.

**Payment of benefits** - Benefit payments are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to investment advisory services and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events** - The plan administrator has evaluated all subsequent events through the date which the financial statements were available to be issued, October 7, 2025, and has determined that there are no subsequent events, except for the Plan restatement disclosed in Note 1, that requires disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic, *Subsequent Events*.

### **4. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income from notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

### **5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Fees incurred by the Plan to the trustee for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Administrative expenses paid to the Plan's recordkeeper and investment advisors included in administrative expenses on the statement of changes in net assets are party in interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

The Plan also issues loans to participants, which are secured by the balances in the participant's accounts. These transactions qualify as party in interest transactions as that term is defined in Section 3(14) of ERISA.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

### **7. TAX STATUS**

The Plan has adopted the ADP Prototype Profit Sharing Plan, which received an IRS opinion letter dated October 6, 2020, which stated that the Prototype Plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **9. RECONCILIATION WITH FORM 5500**

Schedule H Parts I and II of Form 5500 are in substantial agreement with the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and there are no reconciling items.
