Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the TMAG 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) DESCRIPTION OF THE PLAN

The following description of the TMAG 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. Reliance Trust Company is the trustee of the Plan.

General

The Plan is a defined contribution and profit sharing plan. The Plan is designed to comply with Section 401(a) and the regulations thereunder of the Internal Revenue Code of 1986 (the “Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all full-time employees of TMAG Holdings, LLC (the “Company”). Employees are eligible to become a participant when they have reached age 18 and have completed 6 months of consecutive service, as defined in the plan agreement.

Contributions/Investment Options

Participants may contribute up to 70% of their eligible compensation, as defined by the Plan, not to exceed the maximum amounts established by federal law. The Company may make a discretionary matching contribution to the Plan. In 2024, the Company made matching contributions equal to 50% of the first 4% of a participant’s contributions. The Company may make a discretionary non-elective contribution based on each participant’s eligible compensation, as defined by the Plan. Participants may direct their contributions and employer contributions to selected investments as made available and determined by the plan sponsor. The Plan currently offers a stable value fund (common/collective trust) and various registered investment company investment options. Participants may change their investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s 401(k) contributions, the Company’s contributions, and the allocation of (1) plan earnings and (2) plan expenses. Allocations are based on participants’ account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company’s discretionary non-elective contributions plus actual earnings thereon. Vesting in the remainder of their account is based on the following schedule:

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Notes Receivable from Participants

Participants may borrow a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at Prime plus 1.00% (ranging from 4.25% to 9.50% at both December 31, 2024 and 2023). Loan terms range over a period not exceeding 5 years, except for loans to purchase a principal residence, which can exceed 5 years. Principal and interest are paid ratable through payroll deductions. Upon termination, retirement, or death, the participant or beneficiary has the option to pay off the outstanding loan balance. If the participant or beneficiary elects to not pay off the loan, the outstanding loan balance is converted to a distribution. A participant may have only one loan outstanding at a time.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or beneficiary, as applicable) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a rollover into another qualified retirement plan.

As of December 31, 2024 and 2023, there were no unpaid vested benefits to participants who had requested withdrawal of his/her account.

Hardship distributions may be made to participants under certain conditions.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Forfeitures

The Company's contributions and earnings thereon which become forfeited as a result of any benefit payment or withdrawal provisions may be used to reduce the Company's contributions or to pay plan expenses. During 2024, the Plan used \$5,326 of forfeitures to reduce the Company's contributions. In 2024, the Plan did not use forfeitures to pay plan expenses. At December 31, 2024 and 2023, there was \$7,889 and \$2,406, respectively, of nonvested forfeited amounts.

Administration of Plan Assets

The Plan's trustee invests the contributions received, as well as interest and dividend income, and makes distributions to participants.

Operating Expenses

Some of the expenses of maintaining the Plan may be paid by the Company. Fees are assessed on participant-directed transactions within the Plan and are charged directly to the participant's account.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan agreement.

Investments

Investments in registered investment companies are carried at fair value, determined using year-end quoted market prices in active markets. Investments in the common/collective trust are recorded at fair value using net asset value (NAV) as a practical expedient.

Income Recognition

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation (depreciation) in investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Distributions to Participants

Distributions are recorded when paid.

Risks and Uncertainties

Plan participants may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Date of Management's Review of Subsequent Events

Management has evaluated subsequent events through October 3, 2025, the date which the financial statements were available to be issued.

(3) FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In estimating fair value, the Plan utilizes valuation techniques that are consistent with the market approach, the income approach, and/or the cost approach. Such valuation techniques are consistently applied. Inputs to valuation techniques include the assumptions that market participants would use in pricing an asset or liability. Fair values may not represent actual values of assets and liabilities that could have been realized on the measurement date or that will be realized in the future. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

Accounting Standards Codification Topic 820, "Fair Value Measurement," establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset and liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The Plan uses appropriate valuation methods based on the available inputs to measure the fair value of its assets and liabilities.

The following is a description of the valuation methodologies used for assets at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits, as well as the general classification of such assets pursuant to the valuation hierarchy.

Registered Investment Companies

The fair values of registered investment companies are based on year-end quoted prices in active markets.

Common/Collective Trust

The fair value of the common/collective trust is based on the NAV per unit, as a practical expedient. The NAV is based upon the value of the underlying assets owned by the account, minus its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) TAX STATUS

The Plan is a pre-approved plan offered through the Plan's third-party administrator. The IRS has determined and informed the Plan's third-party administrator by a letter dated October 6, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan and related trust are designed and are currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

(6) PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Company did not timely remit participant contributions and loan repayments totaling \$64,411. These untimely submissions constitute prohibited transactions as defined by ERISA. The Company remitted the late contributions to the trustee during 2024.
