### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Dilworth Paxson LLP 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dilworth Paxson LLP 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Dilworth Paxson LLP 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan with a cash or deferred salary reduction arrangement originally effective July 1, 1989. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective April 25, 2023. The Plan covers certain employees and equity partners of Dilworth Paxson LLP (Dilworth or Company), the Plan Sponsor. The Plan excludes leased employees, nonresident aliens, non-equity attorneys, and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA). Dilworth's Pension Plan Committee is responsible for the oversight of the Plan. The Pension Plan Committee determines the appropriateness of the Plan's investment offerings for participant self-direction based on consultation with an investment advisor who is a co-fiduciary and monitors investment and performance of the third-party professional and service providers.

**Eligibility**

All eligible Dilworth employees and equity partners may participate in the salary reduction arrangement in the Plan after the attainment of age 21 and the completion of three months of service. All Dilworth employees eligible for the Plan, except equity partners, are eligible for an employer matching contribution after satisfying the above-stated requirements. All Dilworth employees eligible for the Plan and equity partners are eligible for an Employer discretionary profit sharing contribution upon the completion of two years of service if employed on the last day of the Plan year and if they had completed 1,000 hours of service during the Plan year. Non-Equity attorneys are covered by another plan sponsored by Dilworth.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code of 1986, as amended (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or as after-tax Roth 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

For those employees who participate in the salary deferral arrangement, Dilworth makes a qualified matching contribution of 50% of deferral contributions up to 1.5% of compensation for its eligible employees. Dilworth may elect to contribute a discretionary profit sharing contribution based on a cross-tested formula to the Plan. Pursuant to this formula and the requirements to meet the top-heavy regulations, Dilworth paid additional contributions of \$55,153 for the year ended December 31, 2024. Dilworth also made a discretionary profit sharing contribution for qualifying participants of \$1,057,708 for the year ended December 31, 2024.

**Contributions (Continued)**

Participants may also contribute eligible rollover amounts representing distributions from other qualified defined benefit or defined contribution plans or IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRC limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the appropriate employer's matching contribution if required, an allocation of the appropriate employer's discretionary profit sharing contribution and top-heavy contribution if made, and an allocation of Plan earnings or losses. Participant accounts are charged with certain specific administrative transaction expenses such as loan and distribution fees or third party investment advisory fees that are paid from the account of the individual participant. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Employees of Dilworth are immediately vested in the employer matching and profit sharing contribution portion of their accounts, plus actual earnings thereon. Top-heavy contributions on behalf of Dilworth employees are subject to a graded vesting schedule. Vesting is 20% with two years of service and 100% with three or more years of service. Notwithstanding the above, a participant receiving top-heavy contributions is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from certain accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions or by other arrangement with Dilworth.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiary in the case of death) may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name unless otherwise directed by the participant (or his or her beneficiary).

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce future Employer contributions. Forfeited nonvested accounts totaled \$48,225 and \$37,205 at December 31, 2024 and 2023, respectively. Previously forfeited matching contributions of \$2,394 were used to reduce Employer contributions for December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable are recorded as distribution on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments and an allocation of administration costs relating to attorneys who terminate service with Dilworth and are engaged in the active practice of law with another firm or as a sole practitioner are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

AdvisorTrust, Inc., the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and all investment information, except for Self-Directed Brokerage Accounts, presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Self-Directed Brokerage Accounts:* Investment types within the accounts are common stock, mutual funds, exchange traded funds, corporate debt instruments, and U.S. government securities. All are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period presented. Securities traded in markets that are not considered active are valued based on quoted market prices, broker or dealer quotations, or alternative pricing sources with reasonable levels of price transparency. Securities that trade infrequently and, therefore, have little or no price transparency are valued using investment manager's best estimates.

*Mutual Funds and Money Market Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan Sponsor is placing reliance on an individually-designed plan determination letter dated June 8, 2017, received from the Internal Revenue Service (IRS) issued to the Plan Sponsor indicating that the Plan is qualified under Section 401 of the IRC and, therefore, the corresponding Plan trust is exempt from taxation under IRC section 501(a). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's third-party administrator/recordkeeper is Professional Capital Services, LLC. The Plan investments are held by AdvisorTrust as of December 31, 2024 and 2023. AdvisorTrust is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 9 TRANSFERS FROM AND TO THE PLAN**

Dilworth has also established the Dilworth Paxson LLP 401(k) Savings Plan for Non-Equity Attorneys. If a participant in the Dilworth Paxson LLP 401(k) Savings Plan for Non-Equity Attorneys becomes an equity partner, his or her balance in that plan is then transferred to this Plan. In addition, if a participant of the Dilworth Paxson LLP 401(k) Savings Plan is no longer an equity partner, but remains employed by Dilworth, his or her balance is transferred from this Plan to the Dilworth Paxson LLP 401(k) Savings Plan for Non-Equity Attorneys. In 2024, \$305,660 was transferred to this Plan from Dilworth Paxson LLP 401(k) Savings Plan for Non-Equity Attorneys. No transfers from other plans were received by Dilworth Paxson LLP 401(k) Savings Plan in 2024.
