To the Board of Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Anteriad, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from Principal Trust Company, a qualified institution as of December 31, 2024 and 2023, and for the years the ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following description of the Anteriad, LLC 401(k) Profit Sharing Plan (the Plan) provides general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution profit sharing plan covering all eligible employees of Anteriad, LLC (the Company), formerly MeritB2B, LLC. The Plan was established on January 1, 2000 and restated January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (Code) with a cash or deferred arrangement qualified under Section 401(k) of the Code.

On April 19, 2022, the Plan was amended to change the Plan name to Anteriad, LLC 401(k) Profit Sharing Plan.

Eligibility - Each full-time employee of the Plan Sponsor, who is not covered by a collective bargaining agreement, is eligible to participate in the Plan on the first day of the month coincident with or next following the date of hire and attainment of 21 years of age.

Contributions - Participants may direct the Plan Sponsor to deposit any dollar amount or whole percentage up to 100% of their annual compensation directly into their plan accounts on a before-tax or after-tax basis, subject to Internal Revenue Service limitations. Highly compensated employees may not contribute more than 10% of their annual compensation. This limitation was eliminated effective January 1, 2023.

The Plan allows for discretionary employer matching contributions to be made. Employees are eligible for the Plan's discretionary matching contribution if they are employed as of the last day of the Plan year and, effective January 1, 2014, employees must also be credited with at least 1,000 hours of service during the Plan year. The Plan's discretionary matching contribution for Plan year 2024 was 2% of each pre-tax dollar contributed by a participant.

The Plan also includes a discretionary employer profit sharing contribution which is allocated pro-rata to eligible participants. Employees are eligible for the Plan's profit sharing contribution if they are employed as of the last day of the Plan year and credited with at least 1,000 hours of service. There were no profit sharing contributions in 2024 and 2023. Employee and employer contributions are accounted for as exchange transactions.

NOTE 1. DESCRIPTION OF PLAN (continued)

Participant Accounts - Each participant's account is credited or charged with the participant's contribution and allocations of the Company's matching contributions and net earnings or losses on investments. Allocations are based on participant net earnings and account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited balances of terminated participants' nonvested accounts can be used to add to nonelective contributions, add to matching contributions, reduce nonelective contributions, reduce matching contributions and pay Plan expenses. Forfeitures totaled \$2,981 and \$4,543 for the years ended December 31, 2024 and 2023, respectively.

Vesting - Participants are immediately vested in their contributions plus net earnings thereon. Vesting in the Company discretionary matching and profit sharing contribution portion of their accounts plus net earnings thereon is based on years of continuous service. A participant is 33% vested after one year of credited service, 66% vested after two years of credited service, and fully vested after three years of credited service. Participants are fully vested upon attaining retirement age, or becoming totally and permanently disabled, or at death.

Payment of Benefits - Upon termination of service, death, retirement, disability or normal or early retirement, a participant may elect to receive their entire undistributed vested interest in the Trust Fund (reduced by any security interest held by the Plan by reason of an outstanding loan to the participant) which shall be available to be distributed to him or her in a single, lump sum cash payment.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments in registered investment companies and pooled separate accounts are stated at fair value, which generally represent quoted marked prices in the active market. The fixed annuity contract is carried at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

See Note 9 for discussion of fair value measurements.

Administrative Expenses - Anteriad, LLC, the plan sponsor, pays significant costs of the plan's operation including plan administration and office expenses.

Receivables - Plan management has determined that the receivables are collectible and, therefore, no credit losses are required.

Participants Notes Receivable - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

NOTE 3. INFORMATION CERTIFIED BY THE TRUSTEE

As of December 31, 2024 and 2023, and for the years then ended, the financial information included in the Plan financial statements, except for participant notes receivable, employer contributions receivable, contributions, benefits paid to participants and administrative expenses, has been derived from information certified as complete and accurate by the custodian, Principal Trust Company in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, as amended.

NOTE 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Trust subject to the provisions of ERISA. In the event of Plan termination, each participant or beneficiary will become one hundred percent (100%) vested and have a nonforfeitable right to their accounts, after providing for all of the expenses of the plan at termination.

NOTE 5. TAX STATUS

The Plan adopted a prototype plan document sponsored by Prime Pension, Inc., who received an opinion letter from the Internal Revenue Service (the IRS) dated June 30, 2020, which states that this prototype document satisfied the applicable requirements of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the opinion letter, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is exempt from federal income taxes under Section 501(a) of such code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5. TAX STATUS (continued)

Accounting principles generally accepted in the United States of America (GAAP) requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6. PARTICIPANT NOTES RECEIVABLE

Participants may borrow up to fifty percent (50%) of their vested account balance, with a minimum of \$1,000 and a maximum of \$50,000. Loan terms generally range from one to five years. The loans are secured by the vested balance in the participant's account. During the year, the interest rate charged on the outstanding loans ranged from 4.25% to 9.50%. Principal and interest are paid through payroll deductions.

Interest collected on these loans, which is credited directly to the participant's account, totaled \$18,292 and \$14,617 for the years ended December 31, 2024 and 2023, respectively. These amounts are included in interest income on the statement of changes in net assets available for benefits. Under the provisions of the loan agreement, any legal fees and related costs incurred in collecting delinquent loan payments are charged directly to the delinquent participant account. There were no administrative fees for the years ended December 31, 2024 and 2023.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian and trustee of the Plan. Additionally, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party in interest transactions under ERISA.

Certain administrative duties are provided by the employer, Anteriad, LLC, for which no fees have been charged to this Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

NOTE 9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: The registered investment companies' investments are valued at the net asset value (NAV) of shares held by the Plan at the year end and are classified within level 1 of the valuation hierarchy.

Pooled separate accounts: Prices/unit values for pooled separate accounts investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

NOTE 10. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a Group Fixed Annuity Contract issued by Principal Life Insurance Company (Principal Life). Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Contract value is also often referred to as “Book Value”. The contract is affected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Principal Life considers this contract to be benefit responsive.

The Principal Life group fixed annuity contract is a fixed annuity contract issued by Principal Life that guarantees a fixed rate of interest. A composite crediting rate contractually guaranteed by Principal Life is credited to account balances. The net crediting rate is after the deduction of fees for administrative and recordkeeping services provided to the Plan, however the Principal Guaranteed Option requires no such fees. This net crediting rate was a 5.15% effective annual rate, until November 30, 2024. The rate reset to 4.85% effective December 1, 2025 and will be reset semiannually thereafter.

The contract accounts for 16% of net assets available for benefits at December 31, 2024.
