Note 1 - Plan Description

The following description of the Genox Transportation, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering all eligible employees of Genox Transportation, Inc. (the plan administrator) and Genox West Transportation LLC (collectively, the Company) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 2017 and has since been amended and restated.

Two employees of the Company serve as the trustees of the Plan. The Standard Insurance Company (Standard) serves as the asset custodian of the Plan's assets.

Eligibility

The plan is provided for all eligible employees of the Company, as defined in the plan document. Employees must have completed 3 months of service with the Company. Eligible employees shall enter the Plan on the first day of the calendar month coincident with or next following the date the eligibility requirements are met.

Contributions

Participants elect to have amounts withheld from their paychecks and contributed to the Plan by the Company. Participants may contribute up to 100% of their eligible compensation in pre-tax deferrals and/or Roth deferrals as defined, subject to the limitations of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Generally, if a participant receives a distribution from another qualified plan, as defined in the IRC, as amended, the participant can deposit or rollover those funds into the Plan. New participants shall be subject to the automatic enrollment provisions of the Plan. The employer automatically withholds 3% of eligible compensation each pay period contributed as pre-tax elective deferrals, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee.

The Company makes fixed matching contributions equal to 50% of the first 6% of the participant's eligible compensation.

The Company may also make non-elective contributions as determined by the Company. Company contributions are made in the ratio that each participant's compensation bears to the total compensation of all eligible participants. To receive an allocation of Company discretionary non-elective contributions, participants must be employed by the Company on the last day of the plan year. For the year ended December 31, 2024, the Company did not make nonelective contributions.

All of the forgoing contributions are subject to limits as set by federal law.

Payment of Benefits

Distributions may be made to participants or their beneficiaries upon termination of employment, retirement, disability or death, as applicable. Under certain circumstances, participants may withdraw the value of their account while still employed for reasons of financial hardship, upon the attainment of age 59½ and for other such reasons. Terminated participants whose balances are less than \$7,000 will be automatically distributed. For such balances exceeding \$7,000, subject to certain requirements, participants may leave their account balance in the Plan.

Participant Loans

Participants are allowed to borrow up to the lesser of \$50,000 or 50% of their vested balance. The minimum loan is \$1,000. Loans bear a reasonable rate of interest as determined by the plan administrator based on similar commercial loans. Loans must be repaid over no more than a five-year period with the exception of a loan for the participant's principal residence that may have a repayment period beyond five years and shall not exceed ten years. Principal and interest are paid not less frequently than quarterly or ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Vesting

Participants are always fully vested in their own contributions and all earnings thereon. Participants vest in Company contributions at the rate of 20% for each year of service until fully vested, beginning on the second anniversary after the date of hire. Participants are fully vested in Company contributions after six years of credited service.

Participant Accounts

Each participant's account is credited with the participant's own contributions, employer contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the plan document.

Forfeitures

Forfeitures of nonvested employer contributions, if any, shall be used to reduce employer contributions and can be applied to reduce administrative expenses charged to the Plan, for the plan year in which they occurred or thereafter. As of December 31, 2024, and 2023, there were \$215,779 and \$142,346, respectively, in forfeiture nonvested accounts available for future use. There were no forfeitures used for the year ended December 31, 2024.

Note 2 - Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments of the Plan, except for the fully benefit-responsive investment contract reported at contract value, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as the unrealized gains or losses on the investments held at the end of the year.

Payment of Benefits

Benefits paid to participants or beneficiaries are recorded when paid.

Administrative Expense

Administrative expenses incurred in connection with the operation of the Plan are paid by the Plan, unless paid by the Company, at its discretion.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. In general, notes receivable from participants are considered in default if a scheduled payment has not been received in the quarter following the calendar quarter in which the payment was due. Defaulted notes are treated as distributions based upon the terms of the plan document when a distributable event has occurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

Subsequent Events

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued. See Note 10.

Note 3 - Information Certified by the Asset Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Standard as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to financial statements as to investments, investment income, and all information in the supplemental schedule of assets (held at end of year), excluding notes receivable from participants, is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: These investments are valued at their net asset value (NAV) as reported by the issuer based on quoted market prices of the underlying investments, when available, net of certain expenses. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5 - Fully Benefit Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract with Standard, which is called the Standard Stable Asset D. Standard maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed from time to time, as determined by the account and will never be below 1% annually.

The contract meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Standard may terminate the contract with 30 days advance notice from the plan sponsor which may result in a market value adjustment. The plan sponsor may choose to pay the market adjustment directly, if applicable, so that participants' contract values are not affected.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract by the plan sponsor for any reason other than full plan termination, which requires at least 30 days advance notice or (2) spin-offs, divestitures, layoffs or other plan sponsor events that cause a significant withdrawal from the Plan. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

Note 7 - Federal Income Tax Status

The pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan document was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter.

The plan administrator became aware of certain operational deficiencies relating to the Plan's definition of compensation for employee deferrals and employer match. The plan administrator, with the assistance of Standard, is in the process of making the necessary corrections and will be utilizing available forfeitures to fund any additional contributions that are required to bring the Plan back into compliance with the plan document. Aside from this matter, the plan administrator, through its adoption of the pre-approved plan document, believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-In-Interest Transactions

The Plan's fully benefit-responsive investment contract is offered through a group annuity contract with Standard. The transactions with this investment qualify as party-in-interest transactions and are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

Note 9 - Non-Exempt Transactions

As reported on supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$33,822 of participant contributions and \$877 of participant loan repayments to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102. The untimely remittances relate to the 2023 and 2024 plan years. During 2024, the plan administrator remitted lost earnings of \$886 related to late remittances on \$24,626 of participant contributions and \$544 of loan repayments. The plan administrator is in the process of calculating lost earnings on the remaining untimely remittances.

Note 10 - Subsequent Event

Effective September 1, 2025, the Plan amended the definition of compensation to exclude bonuses, non-statutory stock options and compensation paid after termination .
