## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of LandDesign, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information

included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**DECEMBER 31, 2024**

**Note 1 - Description of Plan:**

The following brief description of the LandDesign, Inc. 401(k) Retirement Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan agreement for more complete information.

**General:**

The Plan is a profit sharing and defined contribution plan covering substantially all employees of LandDesign, Inc. (the “Company”) who are 21 years of age or older. Employees are eligible to enter the plan on the quarterly enrollment dates of January 1, April 1, July 1, and October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions:**

Participants may contribute a percentage of their annual wages subject to annual limitations imposed by the Internal Revenue Service. These contributions can be made as pre-tax deferrals or Roth (after-tax) deferrals. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan allows the employer to make a non-elective safe harbor contribution of three percent of each participant’s compensation annually. In addition, the Board of Directors of the Company may decide to contribute any additional amount. Total contributions may not exceed the maximum amount deductible from the Company's income for such year under Section 404 of the Internal Revenue Code as amended or any successor statute.

**Forfeitures:**

Forfeited amounts are maintained in a fund for restoration of account balances of returning employees. These restorations are subject to certain limitations. Forfeitures for employees who do not return to the company may be used by the Company for future contributions paid by the employer. The balance in the unallocated forfeitures account was \$20,636 and \$3,168, respectively, for years ended December 31, 2024 and 2023.

**Note 1 - Description of Plan (continued):**

**Notes Receivable from Participants:**

Each participant is eligible to borrow from the individual's vested account balance. The value of all loans taken out by a single employee may not exceed the lesser of: (1) \$50,000, reduced by the highest outstanding Plan loan balances during the year preceding the date of the loan, or (2) 50 percent of the value of the participant's vested interest in the account. The minimum loan allowed is \$1,000. Loans are secured by the balance of the participant's account and must be repaid by salary deductions in equal payments for each pay period. Interest is charged based on a prevailing rate calculated by the average rate used for similar personal loan transactions by several commercial banks in the general geographic area of the Plan. Notes receivable from participants as of December 31, 2024 have interest rates ranging from 4.25% to 9.50%.

**Participant Accounts:**

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of the Plan's earnings and administrative expenses. Allocations are based on the participant's eligible compensation or account balances, as defined in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:**

The Plan's vesting schedule provides for a 25 percent increment for each year of service provided to the Company by the participant. After the completion of four years, the participant is entitled to 100 percent of the Company's contributions and earnings thereon. Participants are entitled to 100 percent of their voluntary contributions plus actual earnings on those contributions. A participant whose employment with the Company is terminated prior to the completion of four years is entitled to benefit from the Company's contributions and earnings thereon at a percentage as set forth by the vesting schedule provided in the plan document. A participant who retires at the normal retirement age or becomes permanently disabled is 100 percent vested.

**Payment of Benefits:**

Upon termination of service, a participant's total vested interest will be distributed in a lump sum to the participant if the balance is less than \$5,000. Participants who terminate and have balances in excess of \$5,000 may continue as participants of the Plan.

**Termination of Plan:**

The Company shall have the right at any time to terminate the Plan. Upon such termination, all amounts credited to participant's accounts will become 100 percent vested and non-forfeitable and contributions to the Plan will cease. The trust shall be continued and benefits be distributed at the same time and in the same manner as if the Plan had not been terminated.

## **Note 2 - Summary of Significant Accounting Policies:**

### **Fair Value and Valuation of Financial Instruments:**

The Plan's investments are stated at fair value as reported by the trustee, Bank of America, N.A., at December 31, 2024 and 2023, and were all valued using Level 1 inputs. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. The Plan did not have any outstanding derivative instruments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

### **Use of Accounting Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

### **Benefits Paid to Participants:**

Benefits paid to participants are deducted when paid.

### **Administrative Expenses:**

Certain costs associated with the operation of the Plan are paid from the Plan and recorded as an expense. Other costs are paid by the Company.

**Note 3 - Federal Income Taxes:**

The Internal Revenue Service has determined and informed the Company by a letter dated February 26, 2004, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statement. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The tax administrator believes it is no longer subject to income tax examination for the years prior to 2021.

**Note 4 - Party-in-Interest Transactions:**

At any given time, certain Plan investments may be shares of mutual funds managed by Bank of America, N.A., trustee as defined by the Plan and, therefore, those transactions qualify as party-in-interest. Total fees for accounting, consulting, and other professional services totaled \$117,320 for the year ended December 31, 2024.

**Note 5 - Financial Data Certified by the Asset Custodians:**

Information regarding the Plan assets and transactions as of and for the years ended December 31, 2024 and 2023 was certified by the asset custodian, Bank of America, N.A., in accordance with 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The following information certified by the Custodian was used in the preparation of the 2024 and 2023 financial statements and supplemental schedule.

**Note 6 - Fair Value Measurements:**

The Plan used Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurement". FASB ASC 820 defines the fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets. Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority. The Plan uses valuation techniques based on the available inputs to measure the fair value of its investments.

**Note 6 - Fair Value Measurements (continued):**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.
