### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of The Refresco USA 401(k) Savings & Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

December 31, 2024 and 2023

### (1) Description of Plan

#### (a) General

The following description of The Refresco USA 401(k) Savings & Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions. The Plan is a defined contribution savings and investment plan under Section 401(k) of the Internal Revenue Code covering substantially all full-time employees 18 years or older. Employees are eligible for an employer match after 0 to 90 days of service with Refresco Beverages US Inc. (or formerly Cott Beverages, Inc.). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 1, 2024, the Plan was amended and restated. At this time, The Plan changed from John Hancock Trust Company, LLC (“John Hancock”), to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) as Trustee. All plan assets moved during December 2024.

Effective December 1, 2024 the employer matching contribution formula under Principal was restated as discretionary. The Company elected to keep the matching contribution formula at 50% of elective deferrals not in excess of 6% of eligible compensation.

#### (b) Participant Accounts

Participant accounts are credited with the participant contributions, employer contributions, fund transfers and participant loan repayments. Each participant’s account is credited with the participant’s contribution and allocation of plan earnings (losses). Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### (c) Contributions

Employees hired after January 1, 2019 and that are not covered under a collective bargaining agreement are automatically enrolled at 1% of eligible compensation upon 90 days of meeting eligibility requirements. The participant’s deferrals will automatically increase on an annual basis up to a maximum deferral of 6% of eligible compensation. Additionally, active participants with deferral rates less than 6% will escalate annually until reaching the maximum deferral rate of 6%. All participants are entitled to elect employee contributions to be on a pre-tax basis or as a Roth 401(k) contribution, subject to certain limitations under the Internal Revenue Code. Active participants can contribute up to 90% of earnings to the Plan in the form of basic contributions, up to a maximum of \$23,000 for 2024. Contributions in excess of those allowed by Internal Revenue Code Section 401(k)(3) are reflected as excess participant contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan has been established under Section 401 of the Internal Revenue Code. Therefore, employee contributions, except for Roth 401(k) contributions, are not subject to Federal income withholding tax, but are taxable when withdrawn from the Plan.

#### (c) Contributions - Continued

The Company contributes matching contributions to eligible non-union employees of the Plan equal to 50% of elective deferrals not in excess of 6% of eligible compensation. The Company also contributes matching contributions to eligible union employees based on the terms in the respective collective bargaining agreements. The Company may provide a discretionary contribution made at the discretion of the Board of Directors of the Company. The Board of Directors of the Company elected to make a discretionary contribution based on 2024 financial results at 3% of eligible compensation for employees located at Paw Paw, Truesdale, and Waco locations totaling approximately \$385,000 for the year ended December 31, 2024. Additionally, the Company elected to make discretionary profit-sharing contributions at 2% of monthly employee eligible compensation to San Bernardino union employees. Additional discretionary profit-sharing contributions made to San Bernardino union employees were approximately \$138,000 for the year ended December 31, 2024.

#### (d) Vesting

Participant contributions to the Plan plus actual earnings or losses thereon are fully vested at all times. A participant whose account balance includes amounts transferred from the San Bernardino Plan or the St. Louis Plan as a result of the merger of such plans into the Plan shall vest in the participant's share of matching contributions, discretionary matching contributions and profit-sharing contributions and earnings and losses thereon in accordance with the schedule below. All other participants whose account balances do not include amounts transferred from the San Bernardino Plan, the St. Louis Plan, or the Greendale Plan shall vest in the participant's share of matching contributions, discretionary matching contributions and profit-sharing contributions and earnings and losses thereon which were contributed to the Plan prior to January 1, 2008 or on or after January 1, 2017 in accordance with the following schedule:

#### (d) Vesting - Continued

All other participants whose account balances do not include amounts transferred from the San Bernardino Plan, the St. Louis Plan, or the Greendale Plan shall vest in the participant's share of matching contributions, discretionary matching contributions and profit-sharing contributions and earnings and losses thereon which were contributed to the Plan on or after January 1, 2008 and were hired prior to January 1, 2017 in accordance with the following schedule:

Participants will vest 100% upon attainment of age 65, or in the event of death or disability while employed by the Company.

#### (e) Investment Options

At December 31, 2024 and 2023, the Plan provided participants mutual funds, common/collective trust funds, and stable value funds as investment options in which to invest their contributions.

#### (f) Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000, or 50% of their account balance. The minimum amount of any loan is \$1,000. The term of the loan shall not exceed 5 years except for loans to purchase a primary residence, in which case the term of the loan shall not exceed 15 years. The maximum number of outstanding loans is 2. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% (8.50% at December 31, 2024) as of the date of loan origination. Principal and interest is paid rateably through payroll deductions.

#### (g) Benefit Payments

Vested benefits of retired, disabled, or terminated employees are distributed in several methods as elected by the participant or, when applicable, the participant's beneficiary. The methods of distribution include single lump-sum payments; or provided the participant's vested account exceeds \$7,000, in periodic monthly, quarterly or annual installments; or in periodic partial-sum payments, in accordance with non-discriminatory and objective standards and procedures consistently applied by the administrator.

Upon termination of service, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may take in-service withdrawals upon attainment of age 59 ½ or for immediate and heavy financial hardship needs, as defined in the plan document.

#### (h) Forfeitures

Forfeited nonvested amounts at December 31, 2024 and 2023 were approximately \$619,000 and \$310,000, respectively. These are included in the Plan's investments and are available to reduce future employer contributions and pay administrative expenses. Forfeited nonvested amounts used to reduce employer contributions and pay administrative expenses were approximately \$395,000 for the year ended December 31, 2024.

#### (i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. Upon a complete or partial termination of the Plan, the account of each affected participant will fully vest. The form and timing of payment will be as determined under the Plan at the time of plan termination.

### (2) Summary of Significant Accounting Policies

#### (a) Basis of Presentation and Use of Estimates

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"). The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of increases and decreases in net assets during the reporting periods. Actual results could differ from those estimates.

#### (b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### (c) Contributions

Participant and employer matching contributions are recorded in the period during which payroll deductions are withheld from the participants' earnings.

### (2) Summary of Significant Accounting Policies - Continued

#### (d) Administrative Costs

Substantially all administrative expenses of the Plan are paid by the Plan. Additionally, participant returns are reported net of investment management fees and other administrative expenses.

#### (e) Benefit Payments

Benefits are recorded when paid.

#### (f) Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued and unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative costs and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### (g) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### (3) Information Certified by Trustees

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal and John Hancock, the Plan's Trustees have certified that the following data included in the accompanying financial statements is complete and accurate:

- Total investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023.
- Total investment income, and related investment activity as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- The Schedule of Assets (Held at End of Year) as of December 31, 2024, included in the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements.

### (4) Fair Value of Financial Instruments

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, defines fair value as the exchange prices that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Additionally, FASB ASC Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The unobservable inputs reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

#### ***Mutual Funds***

The mutual fund accounts are valued at fair value based on published market prices as of the close of business on the last business day of the plan year, which represent the net asset value (“NAV”) of the shares held by the Plan and as such are generally categorized as Level 1.

#### ***Common/Collective Trusts***

The collective trust fund are valued at the NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

***Stable Value Fund***

The Refresco Stable Value Fund is composed of fully benefit-responsive guaranteed investment contracts and is valued at the NAV. The Stable Value Fund is a conservative investment option that seeks to provide preservation of principal, a reasonably stated monthly return and a high level of liquidity for participant-initiated withdrawals and exchanges. The fund seeks to maintain a stable asset value. The returns for the various investments that make up the Fund are blended together to provide participants with an aggregate return. The Fund is a dedicated separate account that is available only to participants in the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Guaranteed Interest Account

Effective February 3, 2014, the Plan provided the New York Life Guaranteed Interest Account (“GIA”), managed by New York Life Trust Company (“NYLTC”), as an investment option to participants of the Plan. The GIA is a group annuity contract which consists of a broadly diversified fixed income portfolio within New York Life Insurance Company’s (“NYLIC”) general account and is intended to provide a stable crediting rate consistent with preservation of principal. Interest is accrued daily and credited monthly to the GIA and reflects the crediting rate declared in advance and guaranteed by NYLIC.

The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account. The interest crediting rate may not be reset more frequently than semi-annually after the first contract year. The crediting rate is subject to a minimum rate provision as provided in the group annuity contract, but may never fall below 1% after deduction for any expenses. Participant-initiated transactions are permitted on a daily basis.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment, however, the plan administrator deems these employer-initiated events are not probable to occur.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of terminations is received by NYLTC at least 30 days but not more than 60 days prior to the intended termination date. At contract termination, the Plan may elect to receive either an immediate lump sum distribution subject to a market value adjustment or receive a contract value distribution in 6 annual installments over a period of 5 years.

Effective December 1, 2024, the Plan elected to liquidate its investment in the New York Life Guaranteed Interest Account (“GIA”). As a result, the GIA was closed to new contributions and participant transfers after that date, and the account balance will remain invested until liquidation is completed in accordance with the contract terms. Participant account balances invested in the GIA as of December 1, 2024 will continue to accrue interest at the credited rate until final distribution.

Under the terms of the liquidation agreement, the balance will be distributed in six annual installments, with the first installment released on December 2, 2024 and subsequent installments to be released on December 2 of each year thereafter until fully liquidated.

#### (5) Guaranteed Interest Account - Continued

Effective December 1, 2024, the Plan provided the Principal Fixed Income Guaranteed Option (“GIA”), a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian, as an investment option to participants of the Plan. The GIA is intended to provide a stable crediting rate consistent with preservation of principal. Interest is accrued daily and credited monthly to the GIA and reflects the crediting rate declared in advance and guaranteed by Principal Life. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract.

The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account. The interest crediting rate may not be reset more frequently than semi-annually after the first contract year. The crediting rate is subject to a minimum rate provision as provided in the group annuity contract, but may never fall below 1% after deduction for any expenses. Participant-initiated transactions are permitted on a daily basis.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value and without any surrender charge. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment, however, the plan administrator deems these employer-initiated events are not probable to occur.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of terminations is received by Principal at least 30 days in advance, and will be subject to a surrender charge.

#### (6) Tax Status

Effective December 1, 2024, the Plan adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified. Prior to December 1, 2024, the Plan had an individually designed plan document. The IRS determined and informed the Company by letter dated September 14, 2022, that the Plan and the related trust were designed in accordance with the applicable requirements of the IRC. Although the Plan had been amended since receiving the determination letter, the plan administrator believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

#### (6) Tax Status - Continued

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (7) Related Party Transactions

Fees paid by the Plan for trustee and recordkeeping services amounted to approximately \$306,000 for the year ended December 31, 2024. Fees paid to the investment advisor totaled approximately \$106,000 for the year ended December 31, 2024. These fees qualify as party-in-interest transactions and are recorded in administrative costs in the accompanying Statement of Changes in Net Assets Available for Benefits.

John Hancock, Principal and their affiliates perform services for, sell products to and manage and maintain certain investments for the Plan for which fees are charged to the Plan. While the Plan pays most of the fees, a portion is paid by the plan sponsor. Party-in-interest transactions also include notes receivable made to participants. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### (8) Subsequent Events

Plan management has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 1, 2025, the date the financial statements were available to be issued.
