### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Bell Partners Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

## Notes to Financial Statements

---

### 1. Description of Plan

The following description of the Bell Partners Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Bell Partners Inc. and Bell Flatirons TRS, LLC (collectively, the "Company" or "Employer"). Employees who have completed 30 days of service are eligible to participate in the Plan beginning with the first day of the month coinciding with or following the date on which the eligibility requirements are met. Employees become eligible for the Company's safe harbor matching contributions upon completion of 3 continuous months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### **Contributions**

Participants may elect to contribute a percentage up to 75% of their pre-tax and/or after-tax ("Roth") compensation, as defined, not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Company will make a safe harbor matching contribution of 100% of the first 3%, plus 50% of the next 2% of annual compensation. As of December 31, 2024 and 2023, the Plan has recorded a receivable of approximately \$310,000 and \$245,000 related to the annual true-up of the Company's safe harbor matching contribution provisions.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant's account is credited with the participant's and the Company's contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

The Plan provides for immediate vesting in the participant's contributions and the Company's safe harbor matching contributions, plus earnings thereon.

#### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum distribution equal to the participant's vested account balance. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, as defined by the Plan.

### 1. Description of Plan (Concluded)

#### **Notes Receivable from Participants**

A participant may borrow from the Plan a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the vested account balance in the participant's account and bear interest at prime plus 1%. Principal and interest are repaid ratably through payroll deductions.

#### **Administrative Expenses**

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. The Plan absorbs substantially all direct expenses of the Plan including certain trustee, asset, and investment advisory fees. Distribution and notes receivable fees are paid out of affected participants' accounts.

#### **SECURE 2.0 Act**

Effective July 2025, the Plan adopted certain provisions of the SECURE 2.0 Act including provisions that allow for participants to take withdrawals in the event of a federally declared disaster, in situations of domestic abuse, and in the event of a qualified birth or adoption, up to certain dollar limits.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

### 2. Summary of Significant Accounting Policies (Concluded)

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through September 26, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity").

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC ("FMR"). The IRS has determined and informed FMR by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants' accounts will remain fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

The Plan holds certain investments managed by Fidelity, the trustee of the Plan, and, as such, these transactions qualify as party-in-interest. Fees paid by the Plan to Fidelity for administrative services were approximately \$72,900 in 2024.

Fees paid by the Plan to Compass Financial (LPL Financial) and its affiliates for advisory services were approximately \$35,000 in 2024.

Fees paid by the Plan to The Lampo Group for advisory services were approximately \$25,500 in 2024.

Fees paid by the Plan to Smith Leonard PLLC for audit services were approximately \$10,000 in 2024.

Other fees paid by the Plan for investment advisory services were approximately \$1,500 in 2024.

The Plan receives funding through an agreement with Fidelity for an ERISA expense account that is to be used for retirement plan expenses. During 2024, approximately \$63,600 was deposited into this account, and \$51,100 was used to reduce administrative expenses. As of December 31, 2024 and 2023, approximately \$66,800 and \$45,100 was available to use for future administrative expenses.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market and mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, held in the fund, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
