## Independent Auditor's Report

To the Plan Administrator of  
PMGG LLC 401(k) Profit Sharing Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PMGG LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of PMGG LLC 401(k) Profit Sharing Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits needs not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 – to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PMGG LLC 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**Note 1 –Summary of Significant Accounting Policies**

The significant accounting policies followed by the Plan are summarized below.

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions could affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported additions to and deductions from net assets. Actual results could vary from the estimates that were assumed in preparing the financial statements.

*Investments Valuation and Income Recognition*

Published net asset values per share, are used to value investments. Investments during 2024 consist of funds of a collective investment trust that are valued at fair value based on NAV. For 2023 investments consisted of mutual funds valued at fair value based on quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative costs*

The administrative costs charged to the Plan are paid by the Plan or the Plan Sponsor at the Plan Sponsor's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent events

The Plan's management has evaluated the financial statements for subsequent events occurring through September 22, 2025, the date the financial statements were available to be issued.

**Note 2 – Description of Plan**

The following description of the PMGG LLC 401(k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was commenced and made effective January 1, 2020. The plan was most recently amended and restated effective January 1, 2024. The Plan effective September 10, 2024, switched from Mid Atlantic Trust Company to Lincoln National Life Insurance. The Plan is a defined contribution plan covering all employees of PMGG LLC who are at least 21 years of age and have completed one year of service. For discretionary employer profit-sharing contributions, participants must complete one year of service and be at least 21 years old. The Plan, which provides for retirement, death, and disability benefits, is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees can elect to defer up to 100% of their annual compensation- (pretax or Roth), subject to certain limitations and as allowed under Section 401(k) of the Internal Revenue Code. The plan allows for 1% automatic deferrals if the employee does not elect a different deferral or refuse participation in the plan. The plan does not have an auto escalation though. In addition, participants may also make qualifying rollover contributions to the Plan. Employer profit-sharing contributions are discretionary and are limited by the maximum amount deductible under the Internal Revenue Code. The allocation requirements for an Employer profit-sharing contribution are on a pro rata formula.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Under the Plan, employee contributions are 100% vested at the time of contribution. The employers' profit-sharing contributions are also 100% vested at the time of contribution until the plan amendment effective January 1, 2024 when the employer contributions are subject to the following vesting schedule:

0-1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

Forfeited Accounts

As of December 31, 2024 and 2023, there was no balance in forfeited accounts. Forfeited accounts are available to reduce future employer contributions to the Plan. For the years ended December 31, 2024 and 2023 no forfeitures were used to reduce employer contributions.

Payment of Benefits

Generally, in the event of retirement, disability or death, a participant's balance may be withdrawn. The participant may elect to receive the balance of his or her account in a lump sum, partial payment, annuity contract, or installment payments. An employee who terminates employment prior to the normal retirement date is entitled to vested benefits in his or her individual account.

Participant Accounts

The Plan maintains participant-directed investment accounts on behalf of each participant. A participant's account is credited with the participant's contributions, Plan Sponsor contributions, and investment earnings based on the investment options elected. Benefits to which a participant is entitled is the benefit that can be provided by participant's vested account.

Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the interest of all participants becomes fully vested and non-forfeitable.

**Note 3 - Fair Value Measurements**

The Plan has categorized its assets that are measured at fair value based on a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodologies include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective investment trusts (CITs) are valued daily by summing the market value of all their underlying assets and liabilities, then divided by the total number of investment units. This "unit price" represents the value of an investor's portion of the fund's assets and is determined by the price of the investments the fund holds. CITs are not categorized under the fair value hierarchy based on the practical expedient.

Mutual funds – Valued at the published net asset value (NAV) of shares held by the Plan. (Level 1)

**Note 4 – Tax Status**

The Plan utilized the Paychex, Inc. Prototype Non-Standardized Profit-Sharing Plan which obtained its latest determination letter dated April 4, 2014, in which the Internal Revenue Service stated the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code through September 9, 2024. Beginning September 10, 2024, the Plan utilized the Ascensus, LLC, Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which obtained its latest determination letter dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 5 – Party-In-Interest Transactions**

Certain Plan investments were managed by Mid Atlantic Trust Company through September 9, 2024. Mid Atlantic Trust Company is the custodian as defined by the Plan and, therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Beginning September 10, 2024, Lincoln National Life Insurance managed the plan. Plan audit and accounting fees are paid by the Employer/Plan sponsor. Certain administrative functions are performed by officers and employees of the Plan sponsor. These employees are also Plan participants. No such officers or employees received compensation from the Plan.
