NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Loretto Employee 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Loretto Management Corporation and participating providers (Loretto) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Compensation and Benefits Committee is responsible for the oversight of the Plan. Fidelity Management Trust Company (Fidelity) serves as the trustee and Fidelity Workplace Services (FWS) is the recordkeeper of the Plan's assets.

Eligibility

Employees are eligible for elective deferrals upon date of hire. Employees become eligible for discretionary employer matching contributions after completing three months of service with Loretto and non-elective employer contributions after completing one year of service as defined in the Plan document.

Contributions

Each year, participants may contribute up to 100% of their compensation subject to certain limits established by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants have the option to elect to have Roth contributions made to the Plan. Roth contributions are included in a participant's taxable gross income for the year in which the contribution is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 35 days of employment unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a portfolio of investments based on the participant's normal retirement date until changed by the participant. Participants' deferral rates are automatically increased by 1% each year, up to a maximum of 9%, unless they opt to contribute a different percentage.

The Plan allows for additional discretionary matching employer and profit-sharing amounts to be contributed at the option of Loretto's Board of Directors. Additional matching contributions are equal to 50% of the employee's first 5% of contributions up to a maximum of 2.5%. For the years ended December 31, 2024 and 2023 matching contributions were \$843,284 and \$649,636, respectively. There were no profit-sharing contributions made for 2024 or 2023.

Participant Accounts

Participants direct the investment of their contributions and Loretto's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, their share of Loretto's contributions, and an allocation of both the Plan's actual earnings (losses) and the Plan's administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately 100% vested in their contributions, employer's past safe harbor contributions plus actual earnings (losses) thereon. Participants will become 100% vested in employer contributions other than safe harbor contributions upon completing three years of service, as defined in the Plan document. A participant is also 100% vested upon reaching normal retirement age, or in the event of death or disability while employed by Loretto.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, a partial withdrawal or periodic payments. Distributions are also permitted in the event of financial hardship, as defined by the Plan document, and for participants who have attained age 59½. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime rate, determined quarterly, as defined by the Plan document. Loans must be repaid in at least quarterly installments over a maximum term of 5 years for personal loans and 10 years for the purchase of a participant's primary residence. Principal and interest are paid ratably through automatic deductions from the participant's bank account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Fair Value Measurements

GAAP provides the framework for measuring fair value and disclosing fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under GAAP are described as follows:

- *Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- *Level 2*: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts total to \$13,106 and \$67,612, respectively. Forfeitures of non-vested Loretto contributions are used to pay administrative expenses or to reduce Loretto's contributions. No forfeitures were used to pay administrative expenses in 2024. Forfeitures were used to pay administrative expenses of \$149 in 2023. Forfeitures used to reduce Loretto contributions were \$152,580 and \$112,508 in 2024 and 2023, respectively.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan, as provided in the plan document. Certain expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodology used for assets measured at fair value.

- *Mutual funds*: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although Loretto has not expressed any intent to do so, it has the right to terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of ERISA and the Internal Revenue Code (the Code).

6. INCOME TAX STATUS

The Plan is exempt from Federal income taxes under the provisions of Section 501(a) of the IRC. The pre-approved plan received an IRS Determination Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

7. PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee of the Plan and FWS is the recordkeeper of the Plan's assets. As such, transactions between Fidelity, FWS, and the Plan qualify as party-in-interest transactions.

The Plan allows current employees who are participants to receive notes receivable under specific circumstances. As such, transactions between the participants that have loans and the Plan also qualify as party-in-interest transactions.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
