#### **Note 1: Description of Plan**

The following description of the Lumos Labs, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan established on January 1, 2009, and was subsequently amended and restated on March 28, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of the Company.

The Company is the Plan administrator and retains the services of a third-party to assist in the administration of the Plan. Through December 31, 2024, the Plan’s trustee and third-party administrator was Fidelity Management Trust Company (“Fidelity”).

**Eligibility:** The Plan provides benefits for employees of the Company, who are age 21 or older and not covered by a collective bargaining agreement, interns, temporary, certain nonresident aliens, or leased employees. Entry into the Plan occurs on the first day of the month on or after meeting eligibility requirements. An employee may elect not to participate in the Plan.

The Plan includes an automatic enrollment provision where newly hired employees will be automatically enrolled into the Plan on the next first day of the month. Those automatically enrolled have their deferrals set at a 6% elective deferral. An employee may elect not to participate in the Plan.

**Participant contributions:** Each year participants may contribute up to 90% of eligible compensation as defined in the Plan, up to the maximum allowed under section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions, subject to statutory limits. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the allocation of their contributions to various investment options offered by the Plan. Participants may change their investment options daily. Deferrals consist of pre-tax and/or Roth contributions.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** The Plan provides for investments to be directed by participants into a number of investment options held by the trustee. Participant investment options include a variety of mutual funds, a money market fund, and a self-directed brokerage link account. Most Plan investments are units of funds managed by the recordkeeper, therefore, these investments and most investment transactions are party-in-interest transactions. Earnings of each investment fund are allocated to participants' accounts in proportion to each participant's share of that fund.

**Vesting:** Participants are immediately fully vested in their contributions, as well as all earnings on those contributions and rollovers of funds from other qualified retirement plans and earnings thereon.

**Notes receivable from participant:** Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or up to 100% of their vested account balance. The maximum amount is 50% of their vested account balance, up to \$50,000. Note terms range from 1-5 years, but may not exceed 5 years, except for notes used for the purchase of a primary residence, which may be repaid over a longer period but not to exceed 10 years. The notes are secured by the balance in the participant's account and bear a reasonable interest rate, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Participants may only have one outstanding note at a time. In November 2023, the Plan was amended so that upon termination of service, the outstanding note balance for a terminated participant shall continue to be payable in accordance with the provisions of the note rather than be due in full and immediately payable upon termination.

**Payment of benefits:** On termination of service due to death, disability, retirement, or separation from service, participants may receive benefits in a lump sum or in partial withdrawals, in accordance with the Plan. Unless otherwise instructed by the participant, terminated participants with vested account balances up to \$7,000 will receive a lump sum cash payout. Participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested account balances ranging from \$1,000 to \$7,000 will automatically be rolled over to an individual retirement account ("IRA").

As an active participant in the Plan, a participant may, upon attaining age 59 ½ request the distribution of his or her balance. In addition, a participant may apply for a hardship withdrawal, if he or she is experiencing an immediate and heavy financial need as defined by the specific criteria in the Plan document.

**Forfeitures:** Forfeitures are retained in the Plan and will first be used to pay administrative expenses. The amount of forfeitures remaining in the Plan is immaterial as of December 31, 2024 and 2023. For the year ended December 31, 2024, forfeitures used to pay Plan expenses were not material.

**Administrative expenses:** The Company pays the administrative costs of the Plan associated with any professional services provided to the Plan. Administrative expenses recorded in the Plan represent trustee fees, other recordkeeping fees paid directly from the Plan to the Plan's trustee and the cost of communications to the participants. Note and distribution fees and any special handling costs are deducted directly from participants' accounts.

#### **Note 2: Significant accounting policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions are recorded when withheld and distributions are recorded when paid.

**Investment valuation and income recognition:** In accordance with GAAP, the Plan's investments are stated at their fair values. The shares of registered investment companies (mutual funds and self-directed brokerage link account) are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. The money market fund is valued at cost plus accrued interest, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

**Fair value measurements:** The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Net appreciation (depreciation) in fair value of investments:** The earnings, expenses, realized gains or losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

**Investment management fees and operating expenses:** Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through the date that the financial statements were available to be issued, which is the date of the independent auditors' report.

### **Note 3: Fair value**

The Plan performs fair value measurement in accordance with ASC 820 which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities that the entity has the ability to access;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value ("NRV") or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4: Investments**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, the trustee of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The following information included in the financial statements and supplemental schedule were provided by and certified by the Plan's trustee as complete and accurate:

- Investments, at fair value as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Notes receivable from participant as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income (loss), and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year presented.

#### **Note 5: Party-in-interest transactions**

At December 31, 2024 and 2023, the Plan held for investment approximately \$11,303,000 and \$9,544,000, respectively, in Fidelity funds. Fidelity, the Plan's custodian and trustee, served as Plan fiduciary and investment manager to the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **Note 6: Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 7: Income tax status**

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent to receiving this opinion letter, the prototype plan was amended. The Plan administrator believes that the amended prototype plan, as adopted by the Company, is operating in compliance with the requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8: Risks and uncertainties**

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.

#### **Note 9: Partial termination**

Under ERISA, a partial plan termination may occur if a significant percentage of the plan participants are terminated because of an action taken by the plan sponsor. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues according to the plan provisions.

During 2024, as a result of a reduction of the Company's workforce, the Plan experienced a partial plan termination as defined by ERISA. All terminated employees who were participants in the Plan were fully vested in their account balances at the date of the partial plan termination.

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed audits of the financial statements Lumos Labs, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. #### **Note 1: Description of Plan**

The following description of the Lumos Labs, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan established on January 1, 2009, and was subsequently amended and restated on March 28, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of the Company.

The Company is the Plan administrator and retains the services of a third-party to assist in the administration of the Plan. Through December 31, 2024, the Plan’s trustee and third-party administrator was Fidelity Management Trust Company (“Fidelity”).

**Eligibility:** The Plan provides benefits for employees of the Company, who are age 21 or older and not covered by a collective bargaining agreement, interns, temporary, certain nonresident aliens, or leased employees. Entry into the Plan occurs on the first day of the month on or after meeting eligibility requirements. An employee may elect not to participate in the Plan.

The Plan includes an automatic enrollment provision where newly hired employees will be automatically enrolled into the Plan on the next first day of the month. Those automatically enrolled have their deferrals set at a 6% elective deferral. An employee may elect not to participate in the Plan.

**Participant contributions:** Each year participants may contribute up to 90% of eligible compensation as defined in the Plan, up to the maximum allowed under section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions, subject to statutory limits. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the allocation of their contributions to various investment options offered by the Plan. Participants may change their investment options daily. Deferrals consist of pre-tax and/or Roth contributions.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** The Plan provides for investments to be directed by participants into a number of investment options held by the trustee. Participant investment options include a variety of mutual funds, a money market fund, and a self-directed brokerage link account. Most Plan investments are units of funds managed by the recordkeeper, therefore, these investments and most investment transactions are party-in-interest transactions. Earnings of each investment fund are allocated to participants' accounts in proportion to each participant's share of that fund.

**Vesting:** Participants are immediately fully vested in their contributions, as well as all earnings on those contributions and rollovers of funds from other qualified retirement plans and earnings thereon.

**Notes receivable from participant:** Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or up to 100% of their vested account balance. The maximum amount is 50% of their vested account balance, up to \$50,000. Note terms range from 1-5 years, but may not exceed 5 years, except for notes used for the purchase of a primary residence, which may be repaid over a longer period but not to exceed 10 years. The notes are secured by the balance in the participant's account and bear a reasonable interest rate, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Participants may only have one outstanding note at a time. In November 2023, the Plan was amended so that upon termination of service, the outstanding note balance for a terminated participant shall continue to be payable in accordance with the provisions of the note rather than be due in full and immediately payable upon termination.

**Payment of benefits:** On termination of service due to death, disability, retirement, or separation from service, participants may receive benefits in a lump sum or in partial withdrawals, in accordance with the Plan. Unless otherwise instructed by the participant, terminated participants with vested account balances up to \$7,000 will receive a lump sum cash payout. Participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested account balances ranging from \$1,000 to \$7,000 will automatically be rolled over to an individual retirement account ("IRA").

As an active participant in the Plan, a participant may, upon attaining age 59 ½ request the distribution of his or her balance. In addition, a participant may apply for a hardship withdrawal, if he or she is experiencing an immediate and heavy financial need as defined by the specific criteria in the Plan document.

**Forfeitures:** Forfeitures are retained in the Plan and will first be used to pay administrative expenses. The amount of forfeitures remaining in the Plan is immaterial as of December 31, 2024 and 2023. For the year ended December 31, 2024, forfeitures used to pay Plan expenses were not material.

**Administrative expenses:** The Company pays the administrative costs of the Plan associated with any professional services provided to the Plan. Administrative expenses recorded in the Plan represent trustee fees, other recordkeeping fees paid directly from the Plan to the Plan's trustee and the cost of communications to the participants. Note and distribution fees and any special handling costs are deducted directly from participants' accounts.

#### **Note 2: Significant accounting policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions are recorded when withheld and distributions are recorded when paid.

**Investment valuation and income recognition:** In accordance with GAAP, the Plan's investments are stated at their fair values. The shares of registered investment companies (mutual funds and self-directed brokerage link account) are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. The money market fund is valued at cost plus accrued interest, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

**Fair value measurements:** The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Net appreciation (depreciation) in fair value of investments:** The earnings, expenses, realized gains or losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

**Investment management fees and operating expenses:** Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through the date that the financial statements were available to be issued, which is the date of the independent auditors' report.

### **Note 3: Fair value**

The Plan performs fair value measurement in accordance with ASC 820 which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities that the entity has the ability to access;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value ("NRV") or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, the trustee of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

#### **Note 5: Party-in-interest transactions**

At December 31, 2024 and 2023, the Plan held for investment approximately \$11,303,000 and \$9,544,000, respectively, in Fidelity funds. Fidelity, the Plan's custodian and trustee, served as Plan fiduciary and investment manager to the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **Note 6: Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 7: Income tax status**

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent to receiving this opinion letter, the prototype plan was amended. The Plan administrator believes that the amended prototype plan, as adopted by the Company, is operating in compliance with the requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8: Risks and uncertainties**

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.

#### **Note 9: Partial termination**

Under ERISA, a partial plan termination may occur if a significant percentage of the plan participants are terminated because of an action taken by the plan sponsor. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues according to the plan provisions.

During 2024, as a result of a reduction of the Company's workforce, the Plan experienced a partial plan termination as defined by ERISA. All terminated employees who were participants in the Plan were fully vested in their account balances at the date of the partial plan termination.
