Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of the Plan's investments, which is based on the custodian's certified fair value. We evaluated the key factors and assumptions used to develop the fair value of investments in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We received excellent cooperation from all personnel and encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No misstatements were detected as a result of audit procedures.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 10, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Independence

Sisterson's Quality Control Document identifies the policies and procedures established to provide reasonable assurance that all Sisterson personnel maintain independence in all required circumstances, perform all professional responsibilities with integrity, and maintain objectivity in discharging professional responsibilities. As defined by the profession, independence is the ability to act with integrity and objectivity. On an annual basis, all professional personnel must disclose any circumstances and relationships that create a threat to independence. During the planning phase of the audit, we must also evaluate whether there are any changes to the firm's independence with the Plan. Based on these procedures, we believe that there are no independence issues between Sisterson and the Plan.

Peer Review Results

Every three years, Sisterson is subject to a peer review of the system of quality control in place for the accounting and auditing practice of the firm. The most recent peer review was conducted in November 2022 and resulted in an opinion that the system of quality control for the accounting and auditing practice of the Firm has been suitably designed and complied with. Firms can receive a rating of *pass*, *pass with deficiency(ies)* or *fail*. Sisterson & Co. LLP has consistently received a peer review rating of *pass*.

We have performed audits of the accompanying financial statements of Connors Group Safe Harbor 401(k) Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from Voya Institutional Trust Company, a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of Connors Group Safe Harbor 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide supplemental retirement benefits for employees of Connors & Associates LLC dba Connors Group (“Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Permanent employees who are at least 21 years of age become eligible to participate in the Plan through salary deferrals and safe harbor contributions on the first day of the month coinciding with, or following their date of hire. Participants in the Plan become eligible for employer matching contributions upon the completion of six months of service. Temporary employees are eligible to participate upon performing 1,000 hours of service.

Contributions

Contributions for any calendar year are subject to limitations (\$23,000 for 2024 and \$22,500 for 2023) imposed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 by the end of the Plan year are eligible under IRC to make additional catch up contributions (limited to \$7,500 in 2024 and 2023). Deferred salary contributions are classified as employee contributions in the statements of changes in assets available for benefits. The Plan includes an automatic deferral provision of 5% initially, increasing to 10% at 1% per year, unless the participant opts out. In addition, participants who receive qualified distributions from another qualified plan may be able to rollover such distributions into the Plan. Participant rollover contributions totaled \$829,544 and \$175,924 during 2024 and 2023, respectively

The Company makes a safe harbor contribution equal to 4% of participant deferrals on an annual basis. In addition, the Company may, in its sole discretion, make discretionary matching contributions to the Plan on behalf of all participants. Discretionary matching contributions of \$1,138 and \$108,000 were made to the Plan during 2024 and 2023, respectively. Safe harbor contributions and discretionary matching contributions are classified as employer contributions on the statements of changes in assets available for benefits.

NOTE 1 - PLAN DESCRIPTION (continued)

Participant accounts

Each participant's account is increased for employee deferred salary contributions and employer contributions, reduced for withdrawals, and increased or decreased for an allocation of Plan earnings (losses) based on the investment options elected by the participant, net of allocated administrative expenses.

Vesting and forfeited amounts

Participants are always 100% vested in deferral contributions, safe-harbor matching contributions and any earnings thereon. Participants vest in the Company's discretionary contributions at the following rates:

- One year of service - 20%
- Two years of service - 40%
- Three years of service - 60%
- Four years of service - 80%
- Five years of service - 100%

Participants will forfeit the portion of their accrued benefit that is not vested upon termination of employment with the Company. The forfeitures are used to reduce future employer contributions or pay administrative expenses of the Plan. During 2024, \$61,601 of forfeitures were utilized to cover employer contributions to the Plan. No forfeitures were utilized for such purposes during 2023. Forfeited non-vested accounts totaled \$0 and \$33,775 as of December 31, 2024 and 2023, respectively.

Distribution of benefits

The entire account balance is paid in a lump sum to the participant, or designated beneficiary, in the event of death, retirement, permanent disability, or termination of employment with the Company. In the event of hardship, a participant may also be permitted to withdraw all or a portion of deferred salary contributions and employer contributions, in accordance with Plan provisions.

The Plan allows for automatic distributions for terminated participants with account balances under certain dollar thresholds, when the participant has not requested a different treatment. Vested account balances of less than \$5,000 are automatically distributed to terminated participants.

Administrative expenses

The Plan's provisions provide that administrative costs be paid out of the Plan, except to the extent that the Company has elected to pay part or all of such costs.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of changes in assets during the reporting period. Actual results could differ from those estimates.

Investments

Investments in mutual funds are reported at their fair value as reported to the Plan administrator by the custodian of the Plan’s assets and are measured by quoted market prices. The Plan’s investment in the Voya Fixed Account is a fully benefit-responsive investment contract and is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment transactions are accounted for on the trade date (date the order to buy or sell is executed). Interest and dividend income are recorded as earned. All gains and losses (realized and unrealized) on investments recorded at fair value, bought and sold as well as held during the year, are included in net appreciation in fair value of investments reported within the statements of changes in assets available for benefits. Gains, losses, and interest income incurred on investments reported at contract value are included in interest and dividend income within the statements of changes in assets available for benefits.

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Contributions

Employee contributions are recorded when withheld from the participant's compensation. Employer match contributions are recorded at that same time. Additional employer discretionary contributions are recorded when approved.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 10, 2025, the date on which the financial statements were available to be issued.

Reclassifications

Certain amounts previously reported in the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 presentation.

NOTE 3 - CERTIFICATIONS

All information related to investment assets, investment transactions, and related income as of and for the years ended December 31, 2024 and 2023, is disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, and is certified as complete and accurate by Voya Institutional Trust Company, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 4 - INVESTMENTS

The Plan provides participants the opportunity to direct both participant and employer contributions into separate investment funds. However, investment managers have the authority to make investment decisions within each fund.

Fair value measurements

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on the extent of market observability:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments reported as Level I include mutual funds.

Level II – Pricing inputs are other than quoted market prices included in Level I, however, are observable indirectly for the investment. The Plan does not carry any Level II investments.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan does not carry any Level III investments.

Fixed account

As of December 31, 2024 and 2023, the Plan holds a fully benefit-responsive investment in the Voya Fixed Account, offered by Voya Retirement Insurance and Annuity Company (“VRIAC”), an affiliated entity of the Plan’s custodian.

The fixed account is included in the financial statements at contract value. The fixed account is an obligation of each custodian’s general account, which supports all insurance and annuity commitments. All payment guarantees of contractual interest and redemption of invested funds are based on the financial strength and claims-paying ability of the respective custodian, who is solely responsible for all obligations under its contracts.

The nature of the fixed account is such that Plan participants may withdraw assets without restrictions; however, the custodian may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The occurrence of an event that limits the ability of the investment to transact at contract value between the custodian and a participant holding the investment is not probable.

The fixed account guarantees principal, and a guaranteed minimum interest rate ("GMIR") for the life of the contract, as well as featuring two declared interest rates: a current rate, determined quarterly or monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The GMIR may vary by participant based on the date the participant established an account under the respective fixed account contract.

The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract. The current rate, the guaranteed minimum floor rate, and the GMIR are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to the investment daily yields the then current credited rate.

Each custodian's determination of credited interest rates reflects a number of factors, which may include mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, each custodian assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to the investment option and promising a minimum interest rate during the accumulation period and also throughout the annuity payout period, if applicable.

NOTE 5 - INCOME TAX STATUS

The Plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that Voya Retirement prototype plan, as adopted by the Company on May 27, 2022, was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is being operated in accordance with the terms of the Plan.

In accordance with U.S. GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for periods prior to 2021.

NOTE 6 - TERMINATION

Although not expressing any intention to do so, the Plan sponsor reserves the right to terminate the Plan at any time. In the event of termination of the Plan, the interest of participants affected by the termination and their beneficiaries under the Plan shall be non-forfeitable.

NOTE 7 - RELATED PARTY TRANSACTIONS

The Plan's fixed contract investment is issued by VRIAC. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for custodial services to Voya Financial qualify as party-in-interest transactions and amounted to \$52,651 and \$36,085 for the years ended December 31, 2024 and 2023, respectively.
