REPORT OF INDEPENDENT AUDITORS

To the Administrative Committee of
the Knox Community Hospital Employee Health Plan

Opinion

We have audited the financial statements of the Knox Community Hospital Employee Health Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (cash basis) of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (cash basis) for the year ended December 31, 2024, in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Basis of Accounting

The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Plan management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Knox Community Hospital Employee Health Plan (Plan) provides only general information. Participants and others should refer to the plan document and summary plan description (SPD) for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits for all eligible employees of Knox Community Hospital ("Sponsor" or "Employer"). The Plan was established on April 1, 2004. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Prior to 2020, the Plan covered medical, dental and prescription drug benefits. Effective, January 1, 2020, the Plan was amended to include other component plans including an employer paid life insurance plan, voluntary life insurance plans, accidental death and disability plan, voluntary short-term disability plan, employer paid long-term disability plan, accident indemnity, critical illness indemnity, hospital indemnity, an employee assistance program, vision plan, a wellness program, a telemedicine program and a general-purpose flexible spending account (FSA).

Eligibility

All active employees of the Employer that work at least 32 (part-time) hours per pay period or a minimum of 72 hours (full-time) per pay period are eligible to join the Plan.

Benefits

The Plan provides medical, dental, vision, life insurance, disability, indemnity, employee assistance, wellness benefits, telemedicine, FSA, and prescription drug benefits to participating employees and their spouses and dependents. The medical, dental, prescription, wellness program, FSA, and telemedicine are self-insured for most claims. However, a stop loss insurance policy is maintained by the Plan for medical coverage which reimburses the Plan once paid claims exceed \$250,000 per individual. There is no annual aggregate stop loss limit for the Plan.

The vision, life insurance, disability, indemnity and employee assistance benefits are fully insured through third-party providers.

Contributions

The medical, dental and prescription plans are self-funded by contributions from the Sponsor and its employees. Contributions for the medical plan are also received by inactive employees under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions of Federal law. The employee contribution for the medical, dental and prescription plans are determined by the Sponsor. The Sponsor contributes the amount necessary, in excess of the participants' contributions, to timely fund all claims as they are presented for payment.

The Sponsor funds basic life insurance and accidental death and dismemberment premiums for full time employees to cover one year of employee's annual salary and one and a half years of annual salary for directors. Long-term disability premiums are funded by the Sponsor. The Sponsor also funds the employee assistance program, wellness program, and the telemedicine program.

Employees can voluntarily elect to participate in the short-term disability, FSA, voluntary basic and universal life insurance, accident indemnity, critical illness indemnity and hospital indemnity plans. The premiums for these plans are funded by the employees.

Benefits Provided by Sponsor

The Employer provides healthcare services to participants of the Plan. Fees paid by the Plan are the same as those charged to individuals outside of the Plan.

Plan Termination

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

Other

Although it has not expressed an intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under that basis, the only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements. Noncash transactions are not recognized in the financial statements.

Although the cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Estimates

The preparation of financial statements in conformity with the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and disclosures including benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent items. Actual results could differ from those estimates.

Tax Status

The Plan is operated in a manner whereby any tax implications are borne by the Sponsor.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expense

The Employer pays a significant amount of the Plan's administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

3. BENEFIT OBLIGATIONS

The Plan's benefit obligations consist of the estimated amounts of claims incurred but not reported at December 31, 2024 and 2023. These amounts are estimated by the Plan based on historical claim information. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates in the near term would be material to the financial statements.

The following tables present the components of the Plan's benefit obligations and the related changes in the Plan's benefit obligation. Health costs incurred by participants and their beneficiaries and dependents are covered by the Plan. It is the present intention of the Sponsor and the Plan to continue as a self-funded trust for coverage of benefits.

4. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others.

The Employer provided healthcare services during the year as denoted in the statement of changes in net assets available for benefits (cash basis) for the year ended December 31, 2024. Some of the professional fees and administrative expenses of the Plan were paid by the Sponsor.

The Plan paid fees to Mutual Health Services for claims administration and utilization review fees during the year. Life Insurance Company of North America, Cigna, Trustmark Voluntary Benefit Solutions, ComPsych Corporation, and Vision Service Plan all received premiums for fully-insured plans. Telemedicine Management, Inc. d/b/a SwiftMD and ReviveHealth received fees for telemedicine benefits. Gallagher Benefit Services received fees for consulting services. Blue & Co., LLC serves as the independent auditor of the Plan.
