Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Verst Group Logistics Companies 401(k) Retirement Savings Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Related Party Transactions

Certain Plan investments are shares of mutual funds managed by the custodian (or affiliates of the custodian) of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Several employees of Verst Group Logistics (the "Plan Sponsor") provide administrative service to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan sponsor for the services of the employees to the Plan.

Certain expenses and costs of administering the Plan were paid for by the Plan sponsor, and accordingly are not reflected in the Plan's financial statements

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Notes Receivable from Participants

For reporting purposes, participant loans are classified as notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Event Evaluation

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of Verst Group Logistics Companies 401(K) Retirement Savings Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Verst Group Logistics, J.C. Buckles Transfer Company, and Zenith Logistics ("the Companies"). An eligible employee is one who has worked for three consecutive months with one such hour of service in each month and who has attained the age of eighteen. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Companies may make matching contributions equal to a discretionary percentage, to be determined by the Companies, of the participants' salary reduction. For the year ended December 31, 2024, the Companies elected to match 100% of the participants' contributions up to 3% of the participants' gross wages.

For eligible employees of the National Conference of Firemen and Oilers Local 320, SEIU, the Companies are required to match 100% of the first 2% of the participants' contributions for the year ended December 31, 2024. Additionally, for the year ended December 31, 2024, for those participants that elect to defer, regardless of his or her deferral percentage, the Companies will contribute another 5% of compensation to the Plan.

Effective January 1, 2017, the Plan was amended to allow a profit sharing contribution to the plan for all employees that completed one hour of service during the plan year. Such contribution will be allocated in an amount designated by the Companies to be allocated to each eligible employee. For the plan year ended December 31, 2024, the Companies elected to make a profit sharing contribution of \$253,155. This contribution was funded from existing forfeitures outstanding.

VERST GROUP LOGISTICS COMPANIES 401(K) RETIREMENT SAVINGS PLAN

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (Continued)

A participant may voluntarily make salary deferral contributions up to 100% of their pre-tax compensation, as defined by the Plan. Effective January 1, 2014, participants also have the option to make post-tax ("Roth") salary deferral contributions. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For December 31, 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500.

Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. A participant may change the amount of his elective deferred contributions as of each payroll period during the Plan year. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

Rollover Contributions

Participants may roll over the taxable portion of funds previously held for their account in another qualified employee benefit plan to this Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Companies' contributions and an allocation of the Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant vests ratably beginning after two years of service with 100 percent vesting being attained after six years.

Payment of Benefits

Upon a participant's retirement after age 65, death, total and permanent disability, other termination of employment with the Companies or termination of the Plan, the participant's account is distributed in a single lump sum.

In-service distributions are permissible for the Plan for participants that have attained the age of 59 ½.

In conditions of "financial hardship," a participant may apply to the Plan administrator for approval to withdraw that portion of his 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Forfeitures

Forfeitures consist of contributions by the Companies for employees who were ineligible or terminated. At December 31, 2024 and 2023, \$253,155 and \$165,063 of unallocated forfeitures were contained in the Plan, respectively. This amount can be used to reduce future employer contributions or pay plan expenses. Employer contributions were reduced by \$165,063 for the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Generally, loans range in term from one to five years.

NOTE 3 FAIR VALUE MEASUREMENTS

Generally Accepted Account Principles' ("GAAP") provisions for Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under applicable GAAP accounting for Fair Value Measurements and Disclosures:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

Mutual funds: Value at the net asset value ("NAV") of shares held by the plan at year end.

Common collective trusts: Valued based on the NAV of units of a collective trust as published by the trustee.

Common collective trusts are investment funds formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarchy. When measuring the fair value of such funds, the NAV, as provided by the fund sponsor, is corroborated with observable inputs provided by pricing services for the securities. In certain instances, NAVs may require adjustments to more appropriately reflect the fair value. No adjustments to NAVs were required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
