### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed the audits of the financial statements of CareFlite 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

#### *General*

The CareFlite 401(k) Plan (the Plan) is a defined contribution plan established by CareFlite (the Company or Employer) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

There are no age or service requirements for eligibility in the Plan. All employees of the Company are eligible to participate except residents of Puerto Rico and non-resident aliens who do not receive any earned income from the Company which constitutes United States sourced income. The pilots are union members whose contract states they will participate in the same benefits as all other employees and are included in the Plan. Eligible Plan participants may begin making contributions as of the first day of each month.

The duties of the Plan administrator are to oversee the operations of the Plan and to provide for prudent investment of plan assets. Accordingly, the Plan administrator has been granted discretionary authority concerning investment and management activities.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *Plan Administration*

Under the Plan agreement, Fidelity Management Trust Company (the trustee) is responsible for the custody of all trust assets and the record keeping for Plan participants.

#### *Contributions*

Each year participants may contribute up to 50% of pretax annual compensation on a pretax basis or on an after-tax Roth basis, as defined in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans.

New employees are automatically enrolled to contribute 3% of their salary to the Plan unless they opt out of participating or elect a different percentage to contribute. Unless the employee elects otherwise, deferrals for each employee having automatic enrollment contributions made on their behalf are automatically increased 1% annually until such time as the deferral percentage is 10%.

The Company will make matching contributions to the Plan each year, within the limits of Internal Revenue Service (IRS) regulations. For the year ended December 31, 2024, the Company matching contribution is equal to 75% of the first 6% of eligible compensation contributed for employees that have completed one year of service; 100% of the first 6% of eligible compensation contributed for employees that have completed five or more years of service; and 125% of the first 6% of eligible compensation for employees that have completed ten or more years of service. The Company may also make a discretionary matching contribution. No additional matching contribution was made for the year ended December 31, 2024.

An employee is eligible to participate in the service-weighted additional matching contribution portion of the Plan if they complete a minimum of 12 months of service. Service for purposes of eligibility includes service with the predecessor employers of Texas Health Resources, Baylor Health Care System, and Methodist Hospitals of Dallas.

Effective January 1, 2023, the Plan amended the Plan Documents for the matching employer contributions to calculate the match each payroll period. Previously the matching employer contributions was calculated for the contribution period of each plan year in accordance with the Plan Documents.

### ***Participant Accounts***

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching, as well as the participant's share of the investment income, appreciation (depreciation) and any related administrative expenses. The benefit to which a participant is entitled is limited to the amount of the participant's vested account balance.

### ***Vesting***

Participants are always fully vested in their elective contributions and rollovers, if any, plus actual earnings thereon. Vesting in all employer contribution portion of accounts, plus actual earnings thereon, is as follows:

Participants become fully vested upon death, disability, reaching retirement age (65) or upon termination of the Plan.

### ***Forfeited Accounts***

The non-vested portion of the Company's contributions and related earnings of terminated employees may be used to reduce administrative expenses of the Plan, reduce future Company contributions, or reduce qualified non-elective contributions in accordance with the Plan document. At December 31, 2024 and 2023, there were \$13,736 and \$19,454 of non-vested accounts, respectively. During 2024, the Company used forfeitures of \$133,768 to reduce employer matching contributions.

### ***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. In addition, in-service and hardship distributions are permitted if certain criteria are met subject to a \$500 minimum threshold.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates that are commensurate with local prevailing rates as determined by the Plan administrator and is fixed for the term of the loan (not to exceed 5 years unless such loan is for the purchase of a participant's primary residence). Principal and interest is paid ratably through payroll deductions. Additionally, loans bear a \$100 loan origination fee. No additional amounts may be borrowed until any prior loan has been repaid.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan to any of the investment funds offered at the discretion of the Plan Administrator, and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Matching and discretionary matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Investment Valuation and Income Recognition***

The plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation and depreciation in fair value of its investments which consists of the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Benefit Payments***

Benefit payments to participants are recorded when paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies* - Investments in registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common/Collective Trusts (CCT)* - Common/collective trust is valued at the NAV of units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCT is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 5. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management & Research Company (FMRC). Fidelity Management Trust Company, an affiliate of FMRC, is the trustee of the Plan, and Fidelity Investments Institutional Operations Company, Inc., a division of FMRC, provides recordkeeping and administrative services to the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Company pays directly any other fees related to the Plan's operations. The Plan issues loans to participants that are secured by the vested balance of the participants account the above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 7. Tax Status

The Plan uses a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### 9. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

We have performed the audits of the financial statements of CareFlite 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

#### *General*

The CareFlite 401(k) Plan (the Plan) is a defined contribution plan established by CareFlite (the Company or Employer) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

There are no age or service requirements for eligibility in the Plan. All employees of the Company are eligible to participate except residents of Puerto Rico and non-resident aliens who do not receive any earned income from the Company which constitutes United States sourced income. The pilots are union members whose contract states they will participate in the same benefits as all other employees and are included in the Plan. Eligible Plan participants may begin making contributions as of the first day of each month.

The duties of the Plan administrator are to oversee the operations of the Plan and to provide for prudent investment of plan assets. Accordingly, the Plan administrator has been granted discretionary authority concerning investment and management activities.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *Plan Administration*

Under the Plan agreement, Fidelity Management Trust Company (the trustee) is responsible for the custody of all trust assets and the record keeping for Plan participants.

#### *Contributions*

Each year participants may contribute up to 50% of pretax annual compensation on a pretax basis or on an after-tax Roth basis, as defined in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans.

New employees are automatically enrolled to contribute 3% of their salary to the Plan unless they opt out of participating or elect a different percentage to contribute. Unless the employee elects otherwise, deferrals for each employee having automatic enrollment contributions made on their behalf are automatically increased 1% annually until such time as the deferral percentage is 10%.

The Company will make matching contributions to the Plan each year, within the limits of Internal Revenue Service (IRS) regulations. For the year ended December 31, 2024, the Company matching contribution is equal to 75% of the first 6% of eligible compensation contributed for employees that have completed one year of service; 100% of the first 6% of eligible compensation contributed for employees that have completed five or more years of service; and 125% of the first 6% of eligible compensation for employees that have completed ten or more years of service. The Company may also make a discretionary matching contribution. No additional matching contribution was made for the year ended December 31, 2024.

An employee is eligible to participate in the service-weighted additional matching contribution portion of the Plan if they complete a minimum of 12 months of service. Service for purposes of eligibility includes service with the predecessor employers of Texas Health Resources, Baylor Health Care System, and Methodist Hospitals of Dallas.

Effective January 1, 2023, the Plan amended the Plan Documents for the matching employer contributions to calculate the match each payroll period. Previously the matching employer contributions was calculated for the contribution period of each plan year in accordance with the Plan Documents.

### ***Participant Accounts***

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching, as well as the participant's share of the investment income, appreciation (depreciation) and any related administrative expenses. The benefit to which a participant is entitled is limited to the amount of the participant's vested account balance.

### ***Vesting***

Participants are always fully vested in their elective contributions and rollovers, if any, plus actual earnings thereon. Vesting in all employer contribution portion of accounts, plus actual earnings thereon, is as follows:

Participants become fully vested upon death, disability, reaching retirement age (65) or upon termination of the Plan.

### ***Forfeited Accounts***

The non-vested portion of the Company's contributions and related earnings of terminated employees may be used to reduce administrative expenses of the Plan, reduce future Company contributions, or reduce qualified non-elective contributions in accordance with the Plan document. At December 31, 2024 and 2023, there were \$13,736 and \$19,454 of non-vested accounts, respectively. During 2024, the Company used forfeitures of \$133,768 to reduce employer matching contributions.

### ***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. In addition, in-service and hardship distributions are permitted if certain criteria are met subject to a \$500 minimum threshold.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates that are commensurate with local prevailing rates as determined by the Plan administrator and is fixed for the term of the loan (not to exceed 5 years unless such loan is for the purchase of a participant's primary residence). Principal and interest is paid ratably through payroll deductions. Additionally, loans bear a \$100 loan origination fee. No additional amounts may be borrowed until any prior loan has been repaid.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan to any of the investment funds offered at the discretion of the Plan Administrator, and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Matching and discretionary matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Investment Valuation and Income Recognition***

The plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation and depreciation in fair value of its investments which consists of the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Benefit Payments***

Benefit payments to participants are recorded when paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies* - Investments in registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common/Collective Trusts (CCT)* - Common/collective trust is valued at the NAV of units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCT is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management & Research Company (FMRC). Fidelity Management Trust Company, an affiliate of FMRC, is the trustee of the Plan, and Fidelity Investments Institutional Operations Company, Inc., a division of FMRC, provides recordkeeping and administrative services to the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Company pays directly any other fees related to the Plan's operations. The Plan issues loans to participants that are secured by the vested balance of the participants account the above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 7. Tax Status

The Plan uses a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### 9. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
