INDEPENDENT AUDITORS' REPORT

To the Trustees of
H.D. Hudson Manufacturing Company Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of H.D. Hudson Manufacturing Company Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of H.D. Opinion

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the H.D. Hudson Manufacturing Company Retirement Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan that covers all employees of H.D. Hudson Manufacturing Company and its subsidiary, Root-Lowell Manufacturing Company (collectively, the Company). There is no service or age requirement to become eligible to participate in the Plan. Eligible employees enter the Plan and become participants on the same day after becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may elect to contribute a percentage of his/her annual compensation, as defined by the Plan, on a pretax basis up to the maximum allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants who attain the age of 50 before the end of the year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The automatic enrollment includes an annual escalation of 1%, up to 10% of eligible compensation, unless the participant affirmatively elects to not participate. Contributions are automatically invested in a designated balanced fund until changed by the participant.

The Company makes matching contributions of 25% of the first 6% of base compensation that a participant contributes to the Plan. The Company also makes a safe harbor non-elective contribution of 3% of the participant's compensation. All contributions are subject to certain IRS limitations.

Participants direct the investment of their account balances into a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, company-matching and safe harbor non-elective contributions, and an allocation of plan earnings (losses), and charged with administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus the actual earnings thereon, company matching contributions, and in any safe harbor non-elective contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and interest rates will be based on the prime rate of interest published by the Wall Street Journal as of the date of the loan plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Funds may be withdrawn from a participant's account upon the occurrence of one of the following: hardship, attainment of age 59-1/2, QDRO, death, total disability, termination of employment, transfer of employment, or attainment of age for required minimum distribution. Upon termination of service, a participant may elect to either receive distribution of a lump-sum amount equal to the value of the participant's account, or to transfer the value of the participant's account into another qualified plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments on the statements of changes in net assets available for benefits.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$13, respectively. These amounts are to be used to reduce future company contributions or pay plan expenses. During the years ending December 31, 2024 and 2023, company contributions or plan expenses were reduced by \$1,643 and \$6,290, respectively, from forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

NOTE 3 – CERTIFIED INVESTMENTS

All information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

NOTE 4 – INCOME TAX STATUS

The Internal Revenue has reviewed and approved the Non-Standardized Pre-Approved Profit Sharing Plan With CODA (upon which this plan is based) in a letter dated June 30, 2020. The Plan has been amended since receiving the letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

For the years ended December 31, 2024 and 2023, certain plan investments are managed by the custodian, Principal and, therefore, these transactions qualify as party in interest transactions. Total fees paid by the Plan to Principal amounted \$39,246 and \$44,957 for the years ending December 31, 2024 and 2023, respectively.

Rehmann Financial Group LLC provided investment advisory services over the investments in the Plan for the years ended December 31, 2024 and 2023, and related transactions qualify as party in interest transactions. Fees paid by the Plan to Rehmann Financial Group LLC totaled \$17,720 and \$20,495 for the years ended December 31, 2024 and 2023, respectively.

Of the total recordkeeping, custodial, and advisory fees paid by the Plan for 2024 and 2023, \$39,246 and \$44,957, respectively, is included in administrative expenses on the statements of changes in net assets available for benefits. All other investment related fees are included in net

appreciation in fair value of investments on the statements of changes in net assets available for benefits.

NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are presented as level 1 in the fair value measurements table.

Units of common/collective trusts: Value based on the NAV of units of the common/collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The common/collective trusts can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There are no unfunded commitments.

Units of pooled separate accounts: Valued at NAV of the units of pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is probable that the fund will sell for an amount different from the reported NAV. The pooled separate accounts can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There are no unfunded commitments.

NOTE 7 – GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES

The Plan entered into a benefit-responsive investment contract with Principal Trust Company (Principal) totaling \$386,721 and \$378,837 for the years ended December 31, 2024 and 2023, respectively. The Principal Fixed Income Guaranteed Option Fund (the Fund) was backed by the general account of Principal or Principal Life Insurance Company (Principal Life). While Principal or Principal Life declared rates periodically and backed the principal and interest, any guarantees were subject to the claims-paying ability of the insurance company. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Funds contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

The Fund choice was a non-tradable obligation of Principal. The investment's contract or proceeds could not be assigned or sold to another party without the consent of Principal.

As described in Note 2, because the Fund was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund contract. Contract value, as reported to the Plan by Principal, represented contributions made under the contract, plus earnings at guaranteed credit rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate was based on a formula agreed upon with the issuer, but it could not be less than 0.05%. The crediting rate as of December 31, 2024 and 2023, was 1.55%. The rate is reset semiannually. The Fund did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (a) amendments to the Plan documents (including complete or partial-plan termination or merger with another plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probably occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the date of the independent auditors' report, October 8, 2025, which is the date the financial statements were available to be issued.
