Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Opex Corporation 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of Plan

The following description of the Opex Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Opex Corporation (the Company) as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

To be eligible for participation in the Plan, employees must have attained the age of 21 and not (1) be governed or have their compensation governed by a union contract; or (2) be nonresident aliens who do not receive earned income from the employer that constitutes U.S. source income; or (3) be treated as an independent contractor. Eligible employees are automatically enrolled unless the employee elects not to participate. To be eligible for the non-elective contribution, employees must also attain one year of service as defined.

Contributions

Each year, participants may contribute a minimum of 3 percent of pretax annual compensation. Participants may make deferrals to the Plan on an after-tax basis in accordance with the Roth 401(k) provisions of the Economic Growth and Tax Reconciliation Act of 2001, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make a matching and non-elective contribution on behalf of each participant in an amount to be determined each year by the Company.

During 2024, the Company matched 40 percent of the first 5 percent of compensation that a participant contributed to the Plan. For 2024, the Company elected to make a \$1,350,000 non-elective contribution to be paid in 2025. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's contributions and b) plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of continuous service as follows:

Years of Service	Vested Percentage
Less than 2	0%
2	20%
3	40%

5	80%
6 or more	100%

Participants' accounts are fully vested upon death, disability, or reaching their early retirement date, as defined.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount. In-service withdrawals are also allowed if certain conditions are met, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$160,615 and \$398,861, respectively. These accounts may be used first to reduce administrative expenses of the Plan and any remaining amount will be allocated to each eligible participant's account in the ratio that each eligible participant's compensation bears to the total compensation of all eligible participants, as defined by the Plan.

Forfeited Accounts, Continued

In March 2024, forfeitures in the amount of \$78,068 were used to offset employer match true up contribution for 2023 plan year. In April 2024, forfeitures in the amount of \$362,015 were used to offset non-elective contribution related to the 2023 plan year. In May 2025, forfeitures in the amount of \$42,044 were used to offset employer match true up contribution for 2024 plan year.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees of the Plan determine the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Expenses incurred in the administration and operation of the Plan shall be paid by the Plan unless the plan sponsor, at its discretion, elects to pay them. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Contributions

Contributions from plan participants and the Company matching and non-elective contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the assets or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the registered investment companies. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Lincoln held the Plan's investment assets and executed investment transactions as of December 31, 2024, and from August 28, 2024 to December 31, 2024.

(5) Investment Contracts with Insurance Company

The Plan has fully benefit-responsive investment contracts with Lincoln and Voya totaling \$15,651,213 and \$17,699,880 at December 31, 2024 and 2023, respectively. Lincoln and Voya maintain the amounts allocated to the contracts in general investment accounts. The accounts are credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based upon a formula agreed upon with the issuer but may not be less than the guaranteed minimum.

The amount crediting interest rate and average yield for the guaranteed interest account for the term of the contract is 1.0%.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, and Lincoln, respectively, represents contributions made under the Plan contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

(6) Related Party Transactions and Party-In-Interest Transactions

For the period January 1, 2024 to August 27, 2024, certain plan investments and insurance company general account contracts were managed by Voya. Voya was the trustee as defined by the Plan and, therefore, the transactions qualify as party-in-interest transactions, which are exempt under the prohibited transactions rules.

The Plan's insurance company general account contract as of December 31, 2024 was managed by Lincoln. Lincoln became the Plan trustee effective August 28, 2024. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment or administrative expenses as described in Note 2.

Administrative expenses paid by the Plan amounted to \$334,675 for the year ended December 31, 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

(8) Tax Status

The Plan used a prototype plan document sponsored by Voya through August 28, 2024. The IRS has determined and informed Voya by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the IRC.

Effective August 29, 2024, the Plan adopted a pre-approved plan document sponsored by Lincoln Retirement Services Company LLC. Lincoln Retirement Services Company LLC has received a letter from the IRS dated June 30, 2020, which states the prototype plan document was designed in accordance with applicable sections of the IRC. The opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is designed and is currently being operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
