Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Blue Ridge Hospice Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit).The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, bases on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

For the Years Ended December 31, 2024 and 2023

1 – DESCRIPTION OF PLAN

The following description of the Blue Ridge Hospice Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established September 1, 2001, is a defined contribution 403(b) Plan which provides for participant salary deferrals and employer contributions. The Plan covers all employees of Blue Ridge Hospice, Inc. Employees are immediately eligible to make elective deferral contributions upon employment. Employees become eligible for employer contributions once they have completed one year of service (1,000 hours) and are employed on the last day of the Plan year, unless they have retired on or after they have reached their normal retirement date, have died, or have become disabled. Those employees who work less than 20 hours per week are ineligible for employer contributions. The Plan was last restated effective January 1, 2017, and amended effective January 1, 2020, to address various provisions regarding compensation definitions, deferral provisions, employer contribution participation eligibility, distribution provisions, use of Plan forfeitures, and hardship withdrawals for legal and regulatory compliance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On July 21, 2023, the Plan was amended to add Blue Ridge Independence at Home employees to the Plan. On December 18, 2024, the Plan was amended to exclude bonus from compensation for elective deferrals, matching contributions, and non-elective contributions. Additionally, the amendment stated that for the purposes of Elective Deferrals, Matching Contributions, and Non-Elective Contributions, compensation will include any amounts not available to you in cash in lieu of group health coverage because you are not able to certify that you have other health coverage.

Contributions

Participants may elect to defer a percentage or flat dollar amount of their compensation as defined in the Plan document limited to the maximum amount allowable under the Internal Revenue Code for such Plan year. The Plan also allows for participant Roth elective deferrals. Rollover contributions are permitted from other qualified plans. The Plan has an automatic deferral provision: unless the participant completes a waiver of nonparticipation, participants are automatically enrolled in the Plan upon meeting the above eligibility requirements with 3% deferral rate applied to eligible compensation. The Board of Directors of the Plan Sponsor may approve a discretionary matching contribution on an annual basis which is an amount equal to a percentage of the participant's compensation and/or dollar amount. The Board of Directors of the Plan Sponsor approved a discretionary matching contribution that is equal to eligible participants' contributions but not to exceed 4% of the eligible participants' compensation for the years ended December 31, 2024 and 2023. The Board of Directors of the Plan Sponsor also reserves the right to approve a nonelective discretionary contribution to eligible participants on an annual basis equal to a percentage of the eligible participants' compensation as determined by the Board of Directors, however, no such contributions were authorized for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant account is credited with the participant's elective deferrals, participant rollover contributions, and any employer contributions. Participants have the right to direct contributions and earnings of their account among alternative investment funds provided under the Plan. Participants should refer to the most recent annual report of each investment fund for information on risk factors, asset concentrations, use of derivative financial instruments, and other financial data. Participants may transfer funds between investment options at any time. In addition, each participant's account is credited with their share of appreciation/depreciation in the value of investments and charged with an allocation of administrative expenses paid from plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their employee contributions, plus accrued earnings thereon. Employer contributions are subject to a five-year vesting schedule. Vesting occurs as follows:

Notes Receivable from Participants

The Plan provides that participants can borrow from the Plan. These loans are secured by the balance in the participant's account and bear interest commensurate with prevailing rates. These loans are limited to the lesser of \$50,000 or 50% of the participant's vested account balance with a minimum requirement of \$1,000. Loan principal and interest payments are made in accordance with the note's amortization schedule.

Payment of Benefits

Upon retirement (normal retirement age is 65), death, disability, other termination of employment, hardship, or in-service distribution (after age 59½), as defined, participants or their spouses and/or beneficiaries will receive their account balance under a method allowed by the Plan as disclosed below. If vested balances are less than \$5,000, the Plan Administrator may elect to distribute the entire account balance to the participant without the participant's consent. Distribution methods allowed by the Plan upon separation of employment include:

- Lump sum,
- Annuities, or
- Installment payments over a period of time.

The Plan allows for hardship withdrawals for certain participant needs as defined in the Plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31,228 and \$16,428, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$30,056 from forfeited nonvested accounts, in accordance with plan provisions.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through September 12, 2025, the date the financial statements were available to be issued.

3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts and stable asset fund: Valued at NAV, which is used as a practical expedient for the determination of fair value. The use of NAV as fair value is deemed appropriate as there are no imposed redemption restrictions, and the Plan does not have any contractual obligations to further invest in the account.

- (1) The Stable Asset Fund II invests in high-quality bonds with short to intermediate-term maturities and purchase insurance contracts which aim to provide price stability on a day-to-day basis. All deposits are invested as part of the fund's general assets. Return is determined by the declared interest rate, not by the investment performance of the fund's general assets. All participants in the Plan earn the same interest rate, which is a weighted average of the interest rates on plan assets over the preceding five years. Interest is accrued daily and compounded quarterly.

4 – GUARANTEED INTEREST ACCOUNT AND CONTRACT WITH INSURANCE COMPANY

The Plan Sponsor has had a fixed annuity contract with Variable Annuity Life Insurance Company (VALIC), to provide investment options for Plan participants. Participants could allocate assets into fixed interest investment offered by VALIC which earn interest at a guaranteed rate. As described above, because the general account investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment

contract. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Fixed Account Plus account is credited with interest periodically, but not less than annually. VALIC declares a "current" interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. VALIC intends to continue to credit interest at that same rate for such contributions for an additional calendar year. At the beginning of the third calendar year, such contributions will earn interest at a new declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract. The VALIC fixed account option is supported by the VALIC general account and offers crediting interest rates specified in advance of participant investment. Those rates are as follows:

The Stable Asset Fund II represents an investment option under the Group Annuity contract (Contract) entered into by the Plan with Standard Insurance Company (Standard). Standard maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Standard. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses by Standard. Generally, participants may direct the withdrawal or transfer of all or a portion of their investment at contract value, which is equivalent to fair value. Contract value represents contributions made under the Contract, plus earnings, less withdrawals and administrative expenses. There are no reserves against contract value for the credit risk of the Contract issuer or otherwise. The Plan has determined that the Stable Asset Fund II did not meet the criteria of a fully benefit-responsive investment as of December 31, 2024 and 2023, as defined by ASC 962-325-20.

The contract crediting rate is established at the end of each quarter and is guaranteed for five years. The effective annual crediting rate and yield for the contract was

approximately 3.50% and 3.00% for the years ended December 31, 2024 and 2023, respectively.

Withdrawals in excess of 25% from Stable Asset Fund II are subject to certain restrictions. Withdrawal requests in excess of 25% from Stable Asset Fund II balance may result in balances paid in an amount different from contract value (which is equivalent to fair value) or paid in six annual payments over five years. Standard may defer any withdrawal request for up to six months after receipt of written notice of the withdrawal request and may defer honoring any withdrawal request for any reasonable period if, due to the closing or other disruption of financial markets or exchanges, Standard is unable to prudently liquidate assets necessary to satisfy their quest. A delay caused by market disruption is improbable. Standard may terminate the contract with 30 days advance written notice to the contract owner.

5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7 – TAX STATUS

The Plan has adopted the Unified Trust Company, N.A. 403(b) Volume Submitter Plan. Unified Trust Company N.A. has received a determination letter dated March 31, 2017, that the prototype plan and related amendments qualify as tax-exempt under Internal Revenue Code Section 403(b). An employer who has adopted a prototype plan will also be considered to have a plan qualified under Section 403(b) provided all of the terms of the plan are followed, and the eligibility requirements and contribution or benefit provisions are not more favorable for highly compensated employees than other employees. The Plan has been amended since the date of the determination letter; however, the Plan Administrator believes that the Blue Ridge Hospice Retirement Savings Plan has been operating in compliance with the aforementioned prototype plan and applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been

included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for benefits.

9 – INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024.
