Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Careforth 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of the Careforth 401(k) Plan (the “Plan”) formerly known as Seniorlink 401(k) Plan, provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide employees of Seniorlink Incorporated dba Careforth and Affiliates (the “Company”) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Effective January 1, 2022, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in the 6-year pre-approved plan restatement cycle.

Effective June 1, 2023, the Plan changed its name to Careforth 401(k) Plan.

Eligibility

All employees of the Company, except for student interns, who have completed two months of service and are over the age 18 may begin to make elective deferrals on the first day of the month following eligibility.

The Plan includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of that participant, defer 6% of the participant’s eligible compensation (as defined). These deferrals will be invested in a Vanguard Target Retirement Fund based on the participant’s age at the time of enrollment. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may make pre-tax contributions through salary reductions from 1% to 100% of their annual pre-tax compensation, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in December 31, 2024). The Plan also allows for participants to defer funds into a “Roth” 401(k) deferral. These deferrals are subject to federal income taxes, and the maximum allowable contribution is \$23,000 combined between both the Roth and pre-tax deferral. Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional “catch up” contribution (\$7,500 in 2024). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a money market fund as investment options for participants. The Plan allows rollover contributions from other qualified plans, as defined in the plan document.

Employer Contributions

The Plan permits discretionary Company contributions. The Company made a discretionary contribution of 40% of the first 6% of participant compensation. For the plan year ended December 31, 2024, the Company made matching contributions of \$1,169,123. The Company may also make discretionary profit-sharing contributions on behalf of participants. The Company did not make any profit-sharing contributions for the year ended December 31, 2024.

Participants’ Accounts

Each participant’s account is credited with their respective contribution and its allocation of (a) Company contributions, (b) plan earnings or losses and (c) charged with an allocation of administrative expenses. For the plan year ended December 31, 2024, the participants made contributions of \$4,221,542.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Company's contributions plus actual earnings thereon based on years of continuous service as follows:

Payment of Benefits

Upon termination of employment, retirement, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, installment payments, and partial payments in accordance with Internal Revenue Service ("IRS") regulations and Plan provisions (as defined). Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons, attainment of age 59 ½, and certain other conditions, as defined in the plan document. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest are paid ratably through automatic payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of Company contributions for terminated participants, will serve to reduce the Plan's administrative expenses or future Company contributions. The Company used the forfeiture account to reduce Company contributions by \$54,058 and plan expenses by \$21,300 during the year ended December 31, 2024. The forfeiture account balance was \$1,088 and \$473 as of December 31, 2024 and 2023, respectively.

Other Income

Certain mutual fund expenses, which are charged by the mutual fund companies to the individual participants are credited to the Plan on a quarterly basis. These assets are held in a reserve account and may be used to pay for expenses of the Plan. As of December 31, 2024, there was no balance in the reserve account. As of December 31, 2023, the balance in the reserve account amounted to \$65. During the year ended December 31, 2024, funds credited to the Plan amounted to \$0.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the plan year or at the time of purchase during the plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Company or the Plan, after taking into account forfeitures and recaptured transaction fees.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by The Plan's Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Transamerica Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

Reliance Trust Company was responsible for the certification as of December 31, 2023 and the first half of the year ended December 31, 2024. Transamerica Trust Company was responsible for the certification for the second half of the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are managed by Transamerica and record-keeping, or other administrative fees paid to Transamerica, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, as defined by ERISA. Fees paid by the Plan for record-keeping and investment management services amounted to \$144,395 for the year ended December 31, 2024. Other individually nonmaterial expenses paid to parties-in-interest aggregated \$39,072 for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 5. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a profit sharing retirement plan and trust document. This plan document has been filed with the appropriate agency. The Plan has obtained a determination letter. The Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan is qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities in general are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could, in the near term, materially affect participants' account balances and the amounts reported in the financial statements.

Note 8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That Framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
