General

The Plan is a master welfare plan sponsored by CountryMark Cooperative Holding Corporation (Company) and provides health and other benefits for eligible employees of participating employers. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Payment of Benefits

The Plan provides health benefits (hospital, surgical, dental and major medical) covering all eligible regular employees of the Company and their eligible dependents who elect such coverage. In addition, the Plan provides certain benefits to eligible retirees. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA). Benefits are paid on behalf of eligible participants after they have satisfactorily complied with the claims procedures specified in the Plan.

Dental, vision, long-term disability, accidental death and dismemberment and travel insurance options are all fully insured. Grandfathered retirees who are over age 65 are also eligible for coverage under a fully insured Medicare Advantage Plan.

UMR, Inc. (UMR) processes health and flexible spending claims and The Guardian Life Insurance Company of America processes short-term disability claims. The Plan also includes an Employee Assistance Program and Severance Allowance Policy.

Effective October 2024, the Company contracts with a medical clinic to provide on-site medical and prescription services for Plan participants. Medical expenses incurred by the clinic are included in benefits paid. Administrative fees are also paid to the clinic based upon the contracted agreement between the Company and the clinic.

Stop-Loss Coverage

The Company has entered into a reinsurance agreement where medical and prescription claims in excess of \$250,000 per covered person, are the responsibility of the insurance carrier, with certain exclusions or different limits for specific participants. During 2024 and 2023, these premiums were paid by the Plan, and reinsurance reimbursements from the insurance carrier of \$967,086 and \$662,325, respectively, have been netted against benefits paid on behalf of participants.

Contributions

The Plan is funded daily by the Company through a sweep account. Each daily sweep represents employee and employer contributions.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan maintains its accounts on the basis of cash receipts and disbursements, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements in conformity with cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Plan liabilities for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

Cash

The Plan maintains a zero balance account where funds will sweep daily from the Company's bank account as needed. The outstanding checks will be funded as they clear the bank account.

Postretirement Benefits

Retiree benefits are offered to a closed group of grandfathered retirees over age 65. Grandfathered retirees over age 65 are covered by a fully insured Medicare supplement where the employer will pay a specific amount of the retiree premium, and the participant is responsible for payment of the remainder of the premium. Plan management has determined the obligation for the grandfathered group is not material as of December 31, 2024 and 2023.

Other Plan Benefits

Plan liabilities for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

Plan Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated November 1, 1994, stating that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. Effective May 15, 2015, the tax-exempt status of the VEBA Trust was revoked, and as of that date, the VEBA Trust became a taxable entity.

During 2018, assets held in the VEBA Trust transferred to the Company's bank account, and the Plan filed the final 1041 representing the close-out of the VEBA Trust.

Administrative Expenses

The Plan is administered and managed by the Benefit Committee. The Benefit Committee has employed UMR to perform certain administrative duties for the Plan. Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Plan Benefit Obligations

Health claims incurred but not reported are estimated based upon historic claims experience and claims reported subsequent to the Plan year end.

The Plan's deficiency of net assets compared to benefit obligations at December 31, 2024 and 2023, relates primarily to the claims incurred but not reported, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future increases in the contribution rates for the Company and participants.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons. The Sponsor and participating employers provide certain administrative services at no cost to the Plan.

The Plan paid administrative expenses to the Plan's third-party administrator, UMR, totaling \$293,683 and \$293,131 for 2024 and 2023, respectively. The Plan also paid administrative expenses to True Rx totaling \$138,279 and \$84,559 during 2024 and 2023, respectively, as well as fees to PMR Healthcare for the medical clinic totaling \$128,422 during 2024. Additionally, fees paid to other outside service providers totaled \$22,750 and \$11,532 for 2024 and 2023, respectively.

Premiums paid for fully-insured benefits totaled \$1,217,063 and \$1,144,205 for 2024 and 2023, respectively. Stop-loss policy premiums of \$1,165,057 and \$934,929 were paid during 2024 and 2023, respectively.

Note 6. Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
