### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Workshops, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 16, 2024 (in liquidation) and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to December 16, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 16, 2024 and December 31, 2023, and for the period January 1, 2024 to December 16, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, The Workshops, Inc. approved a plan of liquidation in November 2024, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following description of The Workshops, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a participant-directed defined contribution plan covering all employees of The Workshops, Inc. ("Company"). Employees are eligible to participate following attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was effective January 1, 2020 with participant contributions and Company matching contributions allowed after July 1, 2020.

The Workshops, Inc. approved a plan of liquidation in November 2024, and management determined liquidation is imminent. Effective December 16, 2024, the Plan was terminated and all assets of the plan were either distributed to participants or transferred into another qualified plan with the Company.

Contributions:

The Company allows participants to make both pre-tax contributions and Roth elective deferrals in any amount up to the limitations allowed by the Internal Revenue Code ("IRC").

The Company makes discretionary matching contributions. During the period January 1, 2024 to December 16, 2024, the Company's matching contribution equaled 100% of amounts (up to 3% of compensation) contributed by participants. The Company's matching contributions were \$34,247 during the period January 1, 2024 to December 16, 2024.

Participant Accounts:

An account is maintained in the name of each participant. Each participant's account is credited with the participant's contributions, Company contributions specific to that participant, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

A participant has a 100% non-forfeitable vested interest in his or her account balance at all times, including Company contributions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Payment of Benefits:

A participant or his or her beneficiary, upon termination, death, or retirement, receives his or her vested interest in his or her account in the form of cash or in-kind distributions. Additionally, the Plan has provisions for an active participant to make in-service withdrawals and hardship withdrawals from his or her account, subject to limitations and restrictions.

Investment Options:

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any percentage increments to any of the available investment options.

Participants may change their investment options at any time.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting** – As a result of the Plan termination as described in Note 1, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America.

**Investments** – All investments except an investment contract (Voya Fixed Account) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Voya Fixed Account is not considered fully benefit responsive, and the related contract value approximates fair value. See Note 4 for discussion of fair value measurements.

**Payment of Benefits** – Benefits are recorded when paid.

**Income Recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Fees** – Administrative expenses of the Plan are paid by the Plan or the Company at the option of the Company. Fees paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Note 2. Summary of Significant Accounting Policies (Continued)**

Subsequent Events – The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

**Note 3. Federal Income Tax Status**

The Plan utilizes a Volume Submitter Plan Document. The Internal Revenue Service has informed the provider of the plan document by a letter dated June 30, 2020, that the form of the Plan is acceptable under applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 16, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 4. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- The investment contract is valued at contract value, which approximates fair value, and represents contributions plus interest at a specified rate, less participant withdrawals and fees. This investment is classified as Level 2.
- Investments in registered investment companies are valued based on their quoted closing market prices in active markets for identical investments. These investments are classified as Level 1.

**Note 4. Fair Value Measurements (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Unaudited Information**

Voya Retirement Insurance and Annuity Company ("VOYA"), Custodian of the Plan, holds the Plan's investment assets and executes transactions therein. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the plan administrator received a certification from the Custodian acknowledging the completeness and accuracy of all investments reflected on the statements of net assets available for benefits at December 16, 2024 and December 31, 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 to December 16, 2024 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 6. Party-in-interest Transactions**

Certain Plan investments were shares of funds managed by Voya. Voya is the Custodian as defined by the Plan and, therefore, these investments and related transactions qualify as party-in-interest transactions.
