Independent Auditor's Report

To the Trustees of Corner Table Restaurants 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Corner Table Restaurants 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Corner Table Restaurants 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of the Corner Table Restaurants 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan which was adopted January 1, 2018, as restated January 1, 2021. The Plan is available to employees of Corner Table Restaurants, LLC; 3rd Avenue Hospitality, LLC; TS2 Hospitality, LLC; TS3 Hospitality, LLC; TS4 Hospitality, LLC; TS5 Hospitality, LLC; TS7 Hospitality, LLC and Columbus Avenue Hospitality, LLC (collectively, the Company or sponsors) with the exception of collective bargaining (union) employees and non-resident alien employees as defined in the plan documents who have completed one year of service and are age 21 or older. Entry to the Plan is completed on the first business day of the calendar quarter after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The trustees are responsible for oversight of the Plan. The Plan's trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the trustees. The assets of the Plan are maintained in a trust managed by Principal Life Insurance Company, on behalf of Delaware Charter Guarantee and Trust (d/b/a Principal Trust Company), the custodian of the Plan.

Contributions - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary employer match contribution to the Plan which is determined on the last day of the Plan year. Additional discretionary amounts may be contributed by the Company at the option of the trustees. The matching contribution for the years ended December 31, 2024 and 2023, was \$257,170 and \$218,340, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan.

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits - On termination of service due to death, disability or retirement, participants may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, participants may receive the value of the vested interest in their account as a lump sum distribution. Benefit payments of \$5,000 or less do not require participant consent. The Plan allows for withdrawals in the event of a participant attaining the age of 65. In addition, the Plan allows for hardship distributions if certain criteria are met.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 25 percent vested after two years of credited service and continues to vest in increments of 25 percent until 100 percent vested after five years of credited service, or upon the participant's death or disability. In addition, upon death, disability or attainment of normal retirement age, as defined by the plan document, a participant will become 100 percent vested.

Forfeited accounts - The portion of a participant's account balance that is non-vested upon termination of employment is forfeited and remains in the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31,353 and \$7,160, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Investment valuation and income recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 3, 4 and 6 for discussion of investments and valuation techniques.

The investments in pooled separate accounts are valued at the net asset value (NAV) per unit, as determined by the custodian at year-end. The NAV is used as the practical expedient to estimate fair value and is based on the fair value of the underlying investment held by the fund, less its liabilities, and then divided by the number of shares outstanding.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in net appreciation in the fair market value of investments.

Payment of benefits - Benefits are recorded when paid. Benefit payments for the year ended December 31, 2024 include \$3,004 representing excess contributions from 2023.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments in the accompanying Statement of Changes in Net Assets Available for Benefits.

Subsequent events - Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued and determined that there are no subsequent events that required disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consist of pooled separate accounts valued using the NAV provided by the custodian. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding.

(b) The international funds seek to provide long-term growth of capital by investing in companies based outside of the United States.

(c) Large blend funds are fairly representative of the overall U.S. stock market in size, growth rates, and price. Stocks in the top 70 percent of the capitalization of the U.S. equity market are defined as large cap. The blend style is assigned to portfolios where neither growth nor value characteristics predominate. These portfolios tend to invest across the spectrum of U.S. industries, and owing to their broad exposure, the portfolios' returns are often similar to those of the S&P 500 Index.

(d) The small/mid/specialty funds seek long-term capital appreciation. Under normal circumstances, they invest a majority of their net assets in companies with market capitalization under \$20 billion at the time of the investment.

5. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee & Trust (d/b/a Principal Trust Company), the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

6. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan offers participants an option to invest in the Principal Fixed Income Guaranteed Option Account, a guaranteed investment contract (GIC). The contract underlying this investment option is considered to be fully benefit responsive. Generally, contract value is equal to participant deposits minus participant withdrawals plus credited interest. Contract value may be subject to adjustments in connection with contract holder-directed withdrawals that are subject to a market value adjustment. Under limited circumstances, contract value may be adjusted as a result of a market value adjustment.

Because the GIC meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. The GIC is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The average yield based on actual earnings for the contract for the years ended December 31, 2024 and 2023, for the Principal Fixed Guaranteed Option Account was 0.90 percent. The crediting interest rate to participants for the contract, as of December 31, 2024 and 2023, was 1.00 percent and 0.90 percent respectively.

The custodian makes these guarantees, and although the custodian may credit a higher interest rate, the credited rate will never fall below the lifetime guaranteed minimum of 1.05 percent.

Certain events would limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Companies or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

9. TAX STATUS

Effective January 1, 2018, the Plan adopted the Prime Pensions, Inc. Defined Contribution pre-approved plan and Trust Basic Plan Document. The pre-approved plan received an opinion (or determination) dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the plan sponsor, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor, receives revenue from investment fund service providers for services the plan sponsor provides to the funds. This revenue is used to offset certain amounts owed to the plan sponsor for its administrative services to the Plan. If the revenue received by the plan sponsor from such investment fund service providers exceeds the amount owed for its services, the plan sponsor remits the excess to the Plan's trust on a quarterly basis. The Plan or plan sponsor may make a payment to the plan sponsor for administrative expenses not covered by revenue sharing. The plan sponsor may pay fees relating to the Plan's operations directly.

Certain administrative functions of the plan sponsors are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
