### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Iodine Software LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### (1) Description of plan

The following description of the Iodine Software LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Iodine Software LLC (the "Plan Sponsor"). The Plan includes Artifact Health, Inc. and ChartWise Medical Systems, Inc. as employers with which prior service is recognized. The Plan covers substantially all employees who are twenty-one or older ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated investment until changed by the participant.

The Plan Sponsor may make nonelective or matching contributions to the Plan up to the maximum amounts permitted by the IRC. Plan Sponsor contributions are invested directly in the investment options provided under the Plan as directed by the participant. Contributions are subject to certain limitations. The Plan Sponsor's discretionary matching contributions are based on each participant's contributions calculated as a 50% match up to 6% of the participant's compensation. No discretionary nonelective contributions were approved or made for 2024.

Effective January 1, 2024, the Plan adopted a Qualified Automatic Contribution Arrangement (QACA). Under the QACA provisions, the Employer will contribute an amount equal to the sum of 100% of a Participant's Elective Deferrals that do not exceed 1% of Participant's Compensation, plus 50% of the Participant's Elective Deferrals that exceed 1% of the Participant's Compensation but do not exceed 6% of the Participant's Compensation. The Plan Sponsor makes required employer contributions in accordance with Internal Revenue Code Section 401(k)(13), including a matching contribution and a non-elective contribution, as stipulated by QACA regulations.

(c) Participant accounts

Each participant's account is credited or charged with the participant's contributions, Plan Sponsor contributions, investment earnings (losses) of the investment options selected by the participants, and an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary matching and nonelective contributions are based on years of credited service. A participant is 100% vested upon death, disability, or retirement. Plan Sponsor discretionary matching and nonelective contributions are subject to the following vesting schedule:

Less than 2	0%
2	50%
3	75%
4 or more	100%

Effective January 1, 2024, the Plan was amended to provide for immediate 100% vesting of employer contributions for all participants upon entry into the Plan. As a result, participants are fully vested in employer contributions as soon as they become eligible and enter the Plan, regardless of years of service. This change applies to all employer contributions made on or after the effective date.

(e) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants are secured by the balances in the respective participants accounts and bear interest at fixed rates ranging from 9.75% to 10.5% as of December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Participants may only have two notes receivable outstanding at a time. Principal and interest is collected ratably through payroll deductions.

(f) Payment of benefits

Upon termination of service due to death, disability, normal retirement, or termination of employment, a participant is entitled to receive an amount equal to the vested interest in his or her account payable in lump sum, substantially equal installments, or partial withdrawals form. Distributions are subject to the applicable provisions of the Plan agreement.

In-service withdrawals of all or a portion of a participant's vested account balance may be withdrawn by a participant after reaching age 59 ½. In-service withdrawals of all or a portion of a participant's rollover balance may be withdrawn at any time.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. These accounts will be used to pay administrative expenses and reduce future Plan Sponsor contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$113,296 and \$54,545, respectively. Plan sponsor contributions were reduced by \$29,390 in 2024.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

(i) Administrative expenses

Certain administrative expenses are paid by the Employer; while certain administrative expenses are paid by the Plan. Fees related to the administration of distributions and notes receivable from participants are charged directly to the applicable participants' accounts. Certain fees incurred by the Plan for the investment management services are netted within net appreciation in fair value of the investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### (2) Summary of significant accounting policies

#### (a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### (b) Investment valuation and income recognition

Investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies by utilizing information provided by Voya Institutional Trust Company ("Voya"). See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement.

#### (d) Payment of benefits

Benefits are recorded when paid.

#### (e) Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (f) Events occurring after reporting date

Management of the Plan has evaluated events and transactions that occurred between December 31, 2024, and September 30, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

### (3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value and contract value of investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable for participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya.

### (4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2024 and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Money market fund*: Valued at the closing price reported on the market on which the individual securities are traded.
- (ii) *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Investment contracts with insurance companies

The Plan maintains a Guaranteed Investment Contract ("GIC") related investment option with Voya, the Voya Fixed Account. The contract underlying this investment option is considered to be fully benefit-responsive. As of December 31, 2024 and 2023, the contract value of the investment in the Voya Fixed Account was \$397,472 and \$469,266, respectively.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of the invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including a complete or partial plan merger with another plan) (ii) changes to the Plan's prohibition on competing investment options; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Voya Fixed Account does not permit Voya to terminate the agreement prior to the scheduled maturity date.

### (6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated the non-standardized pre-approved profit sharing plan is designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (7) Related-party and party-in-interest transactions

Certain plan investments are shares of a money market fund and an insurance contract are managed by Voya and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds notes receivable from participants which also qualify as party-in-interest transactions.
