Note 1 – Plan Description

The following provides a brief description of the Kanawha Stone Company, Inc. & Affiliates 401(k) Plan (the “Plan”), formerly known as Kanawha Stone Company, Inc. & Affiliates Profit Sharing Plan. For a more complete description of Plan provisions, participants should refer to the Plan agreement.

General

The Plan is a defined contribution plan formed in April 1975 to provide retirement benefits to employees of Kanawha Stone Company, Inc., Terradon Corporation, and KTC Management, LLC (the Companies). The Plan allows eligible participants to make contributions under a salary deferral (i.e., 401(k)) arrangement and allows the Companies to make matching and other discretionary contributions. Employees are eligible for matching contributions upon meeting certain age and length of employment requirements. Excluded classes of employees include union employees and nonresident aliens as defined in the Plan agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees age 21 or older can defer up to 100% of their annual compensation to the Plan (subject to federal limits) after completing one year of service. Employees can join the Plan on the earlier of the first day of the quarter coinciding with or the next following the date the eligibility requirements are met.

The Companies can make matching contributions equal to a discretionary percentage of the participants’ elective deferrals. The Companies also have the option of making discretionary profit sharing contributions. Matching and other employer contributions forfeited by participants may be used to offset employer contributions. Rollovers from other qualified plans are permitted for new employees.

Participant Accounts

Separate accounts are established for participants who are credited with contributions and investment earnings, and charged with an allocation of the Plan’s administrative expenses. Discretionary contributions are allocated to individual accounts based on each participant’s annual compensation, while forfeitures are based on average account balances, as applicable.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear a fixed interest rate established when the loan originated at 1% over the Prime Rate published in the Wall Street Journal. Principal and interest is paid ratably through weekly and bi-weekly payroll deductions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Investment Options

Participants direct their contributions to be invested primarily in shares of multiple registered investment companies (i.e., mutual funds) and in a common collective trust fund (Note 4). The mutual funds invest in a variety of stocks, bonds and government securities, depending on fund objectives.

Payment of Benefits

In the event of death, disability, retirement, or termination of employment, participants are eligible to receive the fully vested portion of their account balance. Participants may elect to receive benefits in the form of a joint and survivor annuity, lump-sum payment, or partial withdrawals. Hardship withdrawals and in-service distributions are also permitted.

Vesting

Participants are always fully vested in their salary deferral contributions made to the Plan. Participants may also become 100% vested upon early or normal retirement age. Beyond these, vesting percentage is determined by the following schedule and is based on years of service:

Plan Amendment and Termination

The Plan can be amended at any time provided such amendment does not permit the use of Plan assets for any purpose other than the benefit of Plan participants, reduce amounts credited to participant accounts or allow Plan assets to revert to a contributing Company.

Although it has not expressed any intent to do so, the Companies can also terminate the Plan at any time subject to provisions of ERISA. In the event the Plan is terminated, participants immediately become 100% vested in all amounts credited to their accounts.

Note 2 – Summary of Significant Accounting Policies

Forfeited Accounts

Forfeited accounts can be used to pay any administrative expenses and to offset employer contributions and are allocated to participant accounts in the same manner as employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,055 and \$4,797, respectively. In 2024, forfeitures of \$14,744 were utilized to reduce employer contributions and administrative expenses.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus accrued but unpaid interest.

Payment of Benefits

Benefit payments are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan are paid by the Plan and are recorded when incurred.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales are recorded on a trade date basis. Dividends earned on investments are recorded when declared; interest income is recognized when earned. The Plan includes the net appreciation or depreciation and the Plan's gains and losses on investments bought and sold as well as held during the year in its statement of changes in net assets available for benefits under the caption net appreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Prepared by Certified Trustee

Certain information was certified as complete and accurate by Reliance Trust Company (through August 31, 2024) and Principal Trust Company (for period September 1, 2024 through December 31, 2024), the Trustee. This information is as follows:

Note 4 – Common Collective Trust Fund

The Plan invested in the Putnam Fiduciary Trust Company Stable Value Fund, a common collective trust fund (CCT). The CCT invests in high quality guaranteed investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. The fund also invests in security backed investment contracts, money market instruments, cash and cash equivalents, and stable value funds. Certain restrictions on withdrawals from the fund may be delayed due to a disruption of financial markets or exchanges where the fund is unable to settle necessary transactions, and Plan termination withdrawals or other similar employer withdrawal requests for up to twelve months. However, withdrawals are usually available daily.

The common collective trust fund's goal is to preserve principal and achieve high current income through a diversified portfolio of high quality investment contracts, to the extent consistent with the preservation of capital and liquidity and the maintenance of a stable \$1.00 per unit net asset value. There is no assurance that the fund will maintain a stable net asset value. The net asset value of each unit is calculated daily and is determined by subtracting the fund's total liabilities from total assets and dividing by the number of units outstanding. The net asset value (NAV) is used to estimate fair value of a unit in these funds and is not publicly quoted. Participant transactions (purchases and sales) may occur daily. Contributions and redemptions to the fund may be made daily at the current NAV and are considered as made immediately after the daily valuation.

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan

to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Investment Contract

The Plan is invested in the Principal Fixed Income Guaranteed Option issued by the Principal Life Insurance Company. This investment meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

This investment is a single group annuity contract with a fixed rate of interest which is reset on a semiannual basis. The average yield earned by the Plan is the yield earned on the group annuity contract. The average yield for the fund was 4.86% for the year ended December 31, 2024. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

Note 7 – Related-Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds and incur fees for services from the Plan Trustee, investment advisor, or record-keeper and, therefore, these fee transactions qualify as party-in-interest transactions. Fees paid to the Trustee by the Plan for investment management and record-keeping services were \$100,667 for the year ended December 31, 2024.

Note 8 – Tax Status

The Plan has adopted the Non-Standardized Pre-Approved Plan of ADP, LLC. The *IRS* has opined and informed the third-party administrator by a letter dated October 6, 2020, that the non-standardized plan is acceptable under section 401 of the *Internal Revenue Code* for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor and the Plan's tax counsel believe that the Plan is designed and is

currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely-than-not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
