### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Blank Rome Profit-Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Blank Rome Profit-Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

### ***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of Plan**

The following description of the Blank Rome Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering partners, principals, and eligible nonattorney employees of Blank Rome LLP and Blank Rome Government Relations LLC (collectively, the “Firm”). The Plan provides for participation through an employer funded profit-sharing segment and a deferred compensation segment under Section 401(k) of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (“ERISA”).

***Deferred Compensation Segment***

All partners, principals, and eligible nonattorney employees are immediately eligible to participate in the deferred compensation segment of the Plan. The deferred compensation segment provides for participants to elect pretax and Roth contributions, pursuant to a salary reduction program for eligible nonattorney employees and an elective contribution program for partners and principals, not to exceed the limitations under the Code or the Plan.

Effective January 1, 2025, the plan was amended to include an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant makes an affirmative election otherwise.

***Profit-Sharing Segment***

The Plan was amended December 27, 2023 to retroactively reduce the service requirement to one year from the previous two year requirement as of January 1, 2023. All partners, principals, and eligible nonattorney employees that have completed one full year of service (1,000 hours) are eligible to participate in the profit-sharing segment of the Plan. The Plan was amended February 11, 2016 to allow for former employees of Dickstein Shapiro LLP to receive credit for prior service performed for Dickstein Shapiro LLP. Once eligible to participate, the profit-sharing segment provides for participants to share in the Firm’s discretionary profit-sharing contribution for any year in which they complete 500 hours of service and are partners, principals, or employees on the last day of the Plan year.

For the 2024 Plan Year, the authorized discretionary contribution by the firm to the accounts of eligible administrative staff employees is 4.45% of wages up to the maximum *Federal Insurance Contributions Act* (“FICA”) taxable amount and 8.90% on the excess. The 2024 mandatory amounts for partners and principals were calculated based on the partner’s or principal’s earnings and age during the year; for those who were at least 45 years of age, the maximum mandatory contribution was \$46,000; for those who were 40 to 44 years of age, the maximum mandatory contribution was \$43,000; and for those who were under age 40, the maximum mandatory contribution was \$33,000. In 2024, mandatory contributions for all eligible partners are based on earnings adjusted to reflect differences in FICA and self-employment taxes.

Discretionary contributions on behalf of all participants are subject to limitations under the Code and the Plan.

***Vesting***

Participants are fully vested in their account balances.

***Rollovers and Transfers to/from the Plan***

Rollovers into the Plan consist of participant account balances in a qualified plan of another employer or individual retirement account. Transfers to the Plan consist of participant accounts from the Blank Rome Savings Plan (“Savings Plan”) (associates and counsel promoted to partner or principal). Transfers from the Plan are for participants transferring funds to the Savings Plan (late career partners transitioning to senior counsel roles).

***Investment Options***

A participant may invest in a common/collective trust and a number of mutual-fund investment options offered within the Blank Rome LLP Master Trust (the “Master Trust”) (see Note 3). The options also include a self-directed brokerage account. The participant alone decides how to invest these assets. The participant can invest in most listed stocks, options (if approved for options trading), corporate bonds, zero-coupon bonds, U.S. Treasury securities, mortgage securities and U.S. government agency bonds, certificates of deposit, unit investment trusts, foreign securities, and other mutual funds. Participants may invest in life insurance policies and government bonds within a sub-trust as described in Note 8.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Firm’s contributions, and an allocation of Plan earnings and charged with an allocation of administrative expenses, if any. Firm contribution allocations are based on participant wages, as defined. Allocations are based on participant earnings or account balances, as defined in the Plan document. Participant’s accounts are invested at the participant’s election in one or more investment options authorized under the Plan. Investment allocations may be changed by the participant at any time. Each participant’s account is reduced for amounts withdrawn, distributed, or transferred from the Plan for the participant’s benefit.

***Revenue Sharing***

Excess investment related revenue generated by Plan assets is used to cover Fidelity’s cost of various processing, distribution, and recordkeeping services. Fidelity provides a revenue credit to the Plan on a quarterly basis, which is used to cover the Plan’s cost of audit and investment advisory services. To the extent that the balance in the Plan’s revenue credit account exceeds the cost of services rendered to the Plan, excess funds are distributed to Plan participants on a pro-rata basis.

***Benefits***

On termination of service, a participant receives a lump-sum payment from the Plan either in the form of a cash payment or a direct rollover transfer to another qualified employee retirement plan or an individual retirement account. A terminated participant may defer receipt of benefits until attainment of age 72 (age 73 if the participant attained age 72 after December 31, 2022), unless the amount in his or her account is less than the statutory minimum, \$1,000.

Effective September 13, 2017, the Plan was amended to allow for participants who are at least 59 ½ to elect a single in-service distribution in an amount not to exceed 10% of his or her account balance.

The Plan was further amended effective December 10, 2018, to allow for participants who are at least 75 to elect a single in-service distribution in an amount not less than 100% of his or her account balance.

Effective May 1, 2021, the Plan was amended to allow for benefits to be paid out either as a lump-sum distribution or as a series of installments.

Effective July 1, 2022, the Plan was amended to allow participants who attain age 59 ½ to elect to receive a distribution such that the net proceeds from such distribution will be used to fund a health savings account for the benefit of the participant.

On March 27, 2020, the *Coronavirus Aid, Relief, and Economic Security (CARES) Act* was signed in to law. The CARES Act includes several relief provisions available to the Plan and its participants. Plan management has evaluated the relief provisions available to plan participants under the CARES Act and has implemented the following provisions:

- Special coronavirus distributions up to \$100,000.
- Increase the available loan amount to the lesser of \$100,000 or 100% of the participant's vested account balance.
- Extend the period for loan repayments, if applicable, up to one year.

In accordance with the CARES Act, the Plan will be amended to retroactively adopt these provisions no later than December 31, 2025.

***Notes Receivable from Participants***

A participant may borrow a maximum loan amount equal to the lesser of 50% of his or her vested account balance or \$50,000, minus the highest outstanding balance of the participant's loans during the preceding 12 months. The loans are secured by the balance in the participant's account, must be repaid within five years and bear interest at rates established by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participant loans carry interest rates ranging from 4.25% to 9.50% at December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America, and have been consistently applied in the preparation of the financial statements.

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are reflected on a trade-date basis. The net appreciation (depreciation) in the fair value of the Plan's investments consists of realized gains and losses and unrealized appreciation (depreciation) on those investments bought and sold as well as held during the year. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Substantially all expenses of maintaining the Plan are paid out of the Plan's revenue credit account.

***Bonding***

Section 412(a) of ERISA requires the Firm, as fiduciary of the Plan, to maintain a fiduciary bond in the minimum amount of 10% of Plan assets (which is not required to exceed \$500,000). During 2024 and 2023, the Firm's fiduciary bond was in the amount of \$500,000.

**Note 3. Plan's Interest in Master Trust**

Substantially all of the Plan's investments are held in the Master Trust along with investments of the Savings Plan. Each participating plan's interest in the investment funds of the Master Trust is based on account balances of the participants and their elected investment funds. The Master Trust assets are allocated between the two plans by assigning to each plan the specifically identified transactions. Each participating plan has a divided interest in the Master Trust.

The net assets of the Master Trust, as certified by the trustee, Fidelity Management Trust Company (see Note 9), at December 31, 2024 and 2023, are as follows:

#### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures* (“ASC 820”), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1** inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** inputs to the valuation methodology, other than Level 1 inputs, that are based on observable market data. These include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** inputs to the valuation methodology are unobservable and significant to the fair value measurement, reflecting the Plan’s own assumptions

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation techniques employed by the Plan and Master Trust to determine each investment’s fair value use prices and other relevant information generated by market transactions involving identical or comparable assets. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of mutual funds are valued at quoted market prices, which represent the net asset value of the shares held as of the reporting date. Investments in the common/collective trust are composed of units of an underlying trust which primarily is composed of fully-benefit responsive investment contracts and is valued at the net asset value (“NAV”) of units of the underlying trust. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reporting NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions. Self-directed brokerage accounts include investments in common stock, preferred stock, and mutual funds which are valued at quoted market prices, certificates of deposit which are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer, bonds (government, municipal, and corporate) which are valued based on yields currently available on comparable securities of issuers with similar credit ratings, and cash and cash equivalents which are reported at amortized cost which approximates fair value. Life insurance contracts are valued at cash surrender value which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Party-in-Interest Transactions**

Certain of the Plan's investments in the Master Trust are mutual funds and a common/collective trust managed by Fidelity Investments, which is a related party to Fidelity Management Trust Company, the trustee of the Plan. Consequently, these transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7. Tax Status**

The Internal Revenue Service has determined and informed the Plan by a letter dated January 11, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Trustees of the Plan**

The Plan, along with the Blank Rome Savings Plan, has entered into a master agreement with Fidelity Management Trust Company (“Fidelity”) to provide investment services and serve as the principal trustee for the Plan. Four partners of the Firm are the trustees of a sub-trust, which maintains custody of the life insurance contract.

**Note 9. Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The investments of the Plan, other than the life insurance contracts, are held by the principal trustee, Fidelity. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments included in the Plan’s interest in the Master Trust and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023,
- Investment income from the Plan’s interest in the Master Trust and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024,
- Master Trust level detail included in the footnotes herein, and
- Schedule of assets (held at end of year), December 31, 2024, except for the investments in the life insurance contracts, as shown on Schedule H, Line 4i of Form 5500.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Subsequent Events**

Management evaluated subsequent events for the Plan through October 9, 2025, the date the financial statements were available to be issued.

As of July 1, 2025, the plan merged with the Blank Rome Savings Plan and the name was changed to “Blank Rome Retirement Savings Plan”.
