### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DTSV Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 – Description of Plan**

---

*General*

DTSV Group 401(k) Plan (the “Plan”) is a defined-contribution plan covering all salaried and hourly employees of DTSV, Inc., and the following participating employers: Cellavant, Inc., DTSV Services, LLC (dormant), Minerva Capital Management, LLC (dormant), and Next Level Investigations, LLC (collectively, the “Companies”). The Companies share common control or ownership.

Employees are allowed to participate in the Plan on the first of the month following 60 days of service, with exceptions for certain contracts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Fiduciary Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Directors.

On April 9, 2024, the Plan changed Trustees from Ascensus Trust Company to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company.

*Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan. Effective January 1, 2024, the Plan was amended to allow Roth deferrals. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, where certain newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant, with an automatic escalation of 1% each year on January 1, with a cap of 7%. Effective April 1, 2024, the deferral rate for automatically enrolled participants was changed to 3%.

Each year the Companies may contribute separate discretionary matching contributions, using a different percentage for each business unit or location, for participants who are eligible to receive them. The matching contribution is invested in the participants’ selected investment options. Additional profit-sharing amounts may also be contributed at the option of the Companies’ Board of Directors. Such employer contributions are invested in the portfolio of investments as directed by the participants.

Also, for participants who are employed by the Companies as part of a federal government contract that is covered by the Service Contract Act that don’t receive cash-in-lieu, the Companies contribute an amount equal to the difference between the health and welfare allowance under the prevailing wage determination that is incorporated into the federal government contract and the amount of said allowance that is used to pay for other fringe benefits for each participant. Contributions are subject to certain *Internal Revenue Service (IRS)* limitations.

*Participant Accounts*

Each participant's account is credited with the participant's contributions and Companies’ matching contributions, discretionary profit-sharing contributions, non-discretionary contributions, and Plan earnings. Participant accounts are charged with benefit payments, an allocation of administrative expenses that are paid by the Plan, and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan

document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Most participants are vested immediately in their contributions plus actual earnings thereon, as well as in the Companies' contributions. Employees working under contract 19AQMM19CO135 (commonly referred to as "VISA Support Services") who are classified as exempt will be subject to the following vesting schedule for matching contributions: less than one year of service (0%), one but less than two years of service (34%), two but less than three years of service (67%), and three or more years of service (100%).

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$3,984, respectively. These accounts can be used to reduce Plan expenses or future employer contributions. During the year ended December 31, 2024, \$2,481 was used to reduce employer contributions and \$342 was used to reduce Plan expenses.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate published on the date of the loan application. At December 31, 2024, outstanding notes bore interest rates ranging from 3.25% to 8.50%. Principal and interest is paid ratably through payroll deductions.

*Administrative Costs*

Plan administrative expenses may be paid by the Companies of the Plan on a discretionary basis.

*Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In service and hardship withdrawals are permitted, subject to the provisions of the plan.

**Note 2 – Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Valuation of Investment and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the *IRC* are recorded as a liability with a corresponding reduction to contributions.

*Benefit Payments*

Benefits are recorded when paid.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3 – Fair Value Measurements**

The Plan’s investments, except for benefit-responsive investment contracts, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

*Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

*Investments Measured Using the NAV per Share as a Practical Expedient*

The collective investment trust fund issued by Federated Capital Preservation Fund and owned at December 31, 2024 and 2023, is composed primarily of annuity contracts and is valued at the net asset value of units of the collective investment trust fund. Net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The Plan has investments in the Federated Capital Preservation Fund. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and since these contracts are purchase in the open market, are presented at fair value by the Plan. The objective of the fund is to provide stability of principal and high current income. The fund invests primarily in stable value products, including synthetic guaranteed investment contracts (GICs). The percentage of contributions allocated to this fund is determined by the participants.

**Note 4 – Guaranteed Investment Contract with Insurance Company**

---

The Plan has invested in the Guaranteed Option Fund issued by Principal Life Insurance Company. This investment meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The following represents the total contract value of this investment contract held by the Plan:

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

**Note 5 – Related-Party and Party-In Interest Transactions**

---

Certain Plan assets are invested in funds held by the Plan’s trustee and managed by the investment advisor. Therefore, these transactions qualify as party-in-interest transactions. However, these transactions are not considered prohibited transactions. Fees paid to the service providers by the Plan for administrative expenses amounted to \$125,296 for the year ended December 31, 2024.

**Note 6 – Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

**Note 7 – Tax Status**

---

The Plan previously adopted a nonstandardized prototype plan sponsored by Ascensus, LLC. Ascensus, LLC received a favorable opinion letter from the *Internal Revenue Service* dated June 30, 2020, stating that its master prototype plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Effective April 8, 2024, and in conjunction with a change in the Trustee, the Plan adopted a nonstandardized pre-approved profit-sharing plan sponsored by Principal Life Insurance Company. The pre-approved basic savings-plan plus received an *Internal Revenue Service* opinion letter dated June 30, 2020, stating the Plan and the related trust were designed in accordance with the applicable sections of the *Internal Revenue Code (IRC)*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely-than-not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
