1. *DESCRIPTION OF THE PLAN*

The following description of the AMS 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which became effective January 1, 2007, is a defined contribution plan covering all employees of the AMS (Company) who are U.S. citizens, are not covered by a collective bargaining agreement (union), have worked at least 90 days during the first 12 months of employment, or in a later plan year, and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective July 1, 2024, the Plan was amended to permit participants to irrevocably designate a portion or all of the deferral contributions made as Roth 401(k) contributions that are includable in the participant's gross income at the time deferred.

Also, the Plan was amended to permit eligible employees who have satisfied the age and eligibility service requirements under the Plan provisions to roll over any eligible rollover distribution as described in Section 5.06 of the basic plan document.

Contributions

Each year, participants may contribute up to ninety percent (90%) of annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at four percent (4%) of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes annually, an amount equal to a discretionary percentage of a participant's compensation, or a discretionary dollar amount. For the years ended December 31, 2024 and 2023, the Company contributed 50% of the first 8% of Plan compensation that a participant contributes to the Plan. Contributions are subject to certain IRS limitations. For the year ended December 31, 2024 the Company contributed \$638,488.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the actual earnings they accrue. Vesting in the Company's contribution portion of their accounts is determined by years of continuous service. For vesting calculations, only complete years of service are taken into account. A participant becomes 100% vested in the Company's contributions after a total of five years of credited service, with vesting progressing at a rate of 20% per year.

1. *DESCRIPTION OF THE PLAN (continued)*

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at one percent (1%) above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions. The interest rate at December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the listed investment options as permitted by the Plan. The investment options include various mutual funds and common/collective trusts, and a fully benefit-responsive investment contract.

Payment of Benefits

On termination of service due to death, disability, or attainment of normal retirement age (65), a participant (or their estate) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or periodic installments as defined by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Participants may elect to defer payment for vested accounts greater than \$1,000.

Forfeited Accounts

Participants who terminate employment before becoming fully vested forfeit the non-vested portion of their account balances. Forfeited balances of terminated participants who elect to leave their vested account balances in the Plan remain unallocated for up to five years, as specified in the Plan. After this period, unallocated forfeitures are used to reduce future Company contributions. As of December 31, 2024 and 2023, unallocated forfeitures available for future use totaled \$61,400 and \$89,056, respectively. For the year ended December 31, 2024, total forfeitures amounted to \$24,968, and \$56,046 of forfeited amounts were applied to offset the employer's contributions.

2. *SUMMARY OF ACCOUNTING POLICIES*

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and Trustee. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net increase includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, based upon the terms of the Plan document.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain withdrawal fees are charged directly to the participant's account and are included in administrative expenses. Professional fees paid to the Plan's financial statement auditor are paid directly by the Plan and are included in administrative expenses. Investment related expenses are included in net increase of fair value of investments. For the year ended December 31, 2024, administrative expenses were \$86,375.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Event Evaluation

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

3. *CERTIFIED INVESTMENTS*

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net increase in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan), a qualified institution. Also, contract value of the guaranteed investment contract and related income was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts (CCT's): Valued based on their daily net asset value ("Nav"), as a practical expedient, which approximates fair value. Such basis is determined by reference to the respective fund's underlying assets, which are primarily mutual funds. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of level 3.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their portion of employer contributions.

6. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself did not receive a determination letter from the IRS. The Plan's administrator believes that the Plan currently used is designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. *RISKS AND UNCERTAINTIES*

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. *RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST*

Certain Plan investments are shares of mutual funds and common/collective trusts managed by Fidelity Management Trust Company (FMTC). FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for investment management services are included in net increase in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

As described in Note 2, for the year ended December 31, 2024, the Plan made direct payments of \$42,984 to Fidelity Investments Institutional Operations, Co. for fees related to the administration of notes receivable from participants and certain withdrawal fees, which were not covered by revenue sharing. For the year ended December 31, 2024, the Plan also made direct payments of \$43,391 to Kestra Investment Services, LLC for advisory fees. The Plan Sponsor pays directly any other fees related to the Plan's operations.
