Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the TFO Tech Company, Ltd. Savings Incentive Plan (the Plan) is provided for general information. Participants should refer to the Plan document for more complete information.

General

Effective January 1, 1990, the board of trustees of TFO Tech Company, Ltd. (the Company) adopted the TFO Tech Company, Ltd. Savings Incentive Plan, a defined – contribution, 401(k) deferred plan. The Plan is a 401(k) Plan and covers all employees of TFO Tech Company, Ltd. Employees are eligible for participation in the Plan upon attaining 18 years of age and completing six consecutive months of employment and enter the plan on the first day of the Plan Year Quarter coinciding with or next following the date you satisfy the eligibility requirements of employment with Tech Company, Ltd. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Administrative Committee.

Contributions

Participant’s may contribute up to \$23,000 and additional catch-up for age 50 or older of \$7,500 of pretax annual compensation for 2024 as defined by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company will make a matching contribution of 50% of an employee’s contribution up to 4% of their annual pay for the Plan year for persons who are active participants at any time during the Plan year and received at least \$5,000 of compensation from the Company during the Plan year. Participants direct the investment of their contributions and corporate contributions into various investment options offered by the Plan. Also, the Company may make an employer uniform discretionary profit-sharing contributions to be allocated to each Participant’s account based on Participant’s compensation as of each pay date.

Participant Accounts

Each participant’s account is credited with the participant’s respective deferral, the Company’s matching contribution profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of 1 percentage points over the prime interest rate. Interest rates on outstanding participant loans are currently 4.25%-9.75%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, the vested interest in the participant's account shall be paid in the form of a qualified joint and survivor annuity, unless otherwise elected as provided or in the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the value of the vested benefit does not exceed \$5,000 and has never exceeded \$5,000 at the time of any prior distribution, the entire vested benefit shall be paid to the participant in a single lump sum.

Forfeitures

Forfeitures of nonvested Company contributions are used to reduce subsequent employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$78 and \$1,494, respectively. The balance existing at December 31, 2024 will be used to reduce future employer contributions. The Company used \$2,084 in forfeitures during the year ended December 31, 2024 to offset employer contributions.

Administrative Expenses

The Plan document provides for the payment of all Plan expenses from the Plan assets unless paid by the Company. The Company has elected to pay the administrative expenses of the Plan while the investment expenses of the Plan are paid through Plan Assets. Such investment expenses are included in net investment gain from separate accounts in the accompanying Statement of Changes in Net Assets Available for Benefits.

Investment Options

The participants are permitted to direct the allocation of their individual account balance within the investment options of the Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Investments are reported at fair value except for the Morley Stable Value Fund (Common/Collective Trust) which is measured at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator (Administrator), in conjunction with the Trustee to the Plan, determine the Plan's valuation policies. See Note 6 for description of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by defined contribution plans are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a collective trust fund. Contract value for this collective trust fund is based on the net asset value (NAV) of the fund as reported by the investment advisor.

Risk and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general are exposed to various risks, such as interest rate, market credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Contributions

Participant contributions and the employer matching contributions are recognized when the participant contributions are withheld from the participant's earnings. The Company's policy is to make the contribution of participants' withholding and Company match in a timely, normally within five business days of payroll withholding.

Benefits and Withdrawals Paid to Participants

Benefits payments and withdrawals to participants are recorded upon distribution.

Allowance for Credit Losses – Notes Receivable from Participants

The allowance for credit losses is a valuation account that is deducted from, or added to, the note receivable from participants amortized cost basis to present the net amount expected to be collected on the loan. Loans are charged off against the allowance when management believes the uncollectibility of a loan balance is confirmed.

Management estimates the allowance balance using relevant available information, from internal and external sources, relating to past events, current conditions, and reasonable and supportable forecasts. Historical credit loss experience provides the basis for the estimation of expected credit losses. Adjustments to historical loss information are made for changes in environmental conditions, such as changes in unemployment rates, collateral values, or other relevant factors. Management has determined there is no requirement to provide an allowance for credit loss because the loans are secured by the balance in the participant's account.

Allowance for Credit Losses – Investments

Management assesses the financial condition and near-term prospects of the issuer, industry and/or geographic conditions, credit ratings as well as other indicators at the individual security level. Impairments below cost in the estimated fair value of individual securities when there is an intent to sell or for which it is more likely than not the Plan will be required to sell before the impairment is recovered, are realized in other income in the statement of changes in net assets available for benefits. When there is not an intent to sell or it is more likely than not the Plan will not be required to sell the security before the impairment is recovered, management assesses whether the decline in fair value has resulted from credit losses or other factors. If the present value of discounted cash flows expected to be collected is less than the amortized cost basis, credit loss exists and an allowance for securities credit losses is recorded. Such losses are limited to the amount that amortized cost exceeds fair value, even if the amount of the credit loss is greater. Any future changes in the allowance for credit losses is recorded as provision for (reversal of) credit losses. Losses attributable to other factors are charged to net appreciation (depreciation in fair value of investments). Mutual Funds are carried in the financial statements at fair value and Common/Collective Trust Funds are measured at net asset value, and both realized and unrealized gains and losses are included net increase (Decrease) in net assets.

Accounting Standards - Adopted

In June 2016, the FASB issued ASU No. 2016-13, "Financial Instruments – Credit Losses (Topic 326): Measurement of *Credit Losses on Financial Instruments*". "ASU 2016-13 amendments provide guidance on accounting for current expected credit losses on financial instruments that are not accounted for at fair value through net income, including loans held for investment, held-to-maturity debt securities, trade and other receivables, net investment in leases and other commitments to extend credit held by a reporting entity at each reporting date. The required measurement methodology is based on expected loss model that includes historical experience, current conditions, and reasonable and supportable forecasts. ASU 2016-13 eliminated the probable incurred loss recognition in current GAAP.

During 2023, the Plan adapted ASU 2016-13 and it had no material effect on its financial statements and footnote disclosures.

NOTE 3 – PLAN TERMINATION

Although the Plan has not expressed any intention to do so, it has the right under the Plan to terminate the Plan, subject to the provisions set forth in ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and the Plan documents. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 4 – TAX STATUS

The Plan has an agreement with The Newport Group (Trustee) whereby specified plan administration services will be provided to the Plan by means of a prototype plan sponsored by The Newport Group. The Internal Revenue Service has determined and informed The Newport Group by a letter dated November 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. All IRS Form 5500, *Annual Return/Report of Employee Benefit Plan*, have been timely filed and are subject to examination by the IRS, generally for three years after they are filed.

NOTE 5 – PARTY-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Administrative Expenses paid to Ascensus/The Newport Group for contract administration amounted to \$19,401 for 2024. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.

NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation method are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical and similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data;
- Correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Common/collective trust: The Morley Stable Value Fund primarily consists of diversified portfolio of Stable Value Investment Contracts issued by life insurance companies, banks, and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations.

Securities without quoted market price: If quoted market prices are not available, then fair values are established by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows.

On April 8, 2022 the Newport Group (Newport) merged with Ascensus, LLC, (Ascensus). Newport delegated its obligations under its recordkeeping and/or administrative services agreement for the Plan to Ascensus, effective April 18, 2024 (effective date). The Newport recordkeeping and/or administrative services agreement will be amended to reflect current Ascensus processes and will take effect on the Effective Date. At a future date, the Plan may be asked to sign a new service agreement, but Ascensus does not expect that to occur for some time.

NOTE 11 – CARES ACT AND SECURE ACT

The Plan implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Act of 2019 (the SECURE Act), which laws changed the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The applicable features within these Acts have been implemented. Written amendments to the Plan to reflect these operational changes will be adopted on or before December 31, 2025, in accordance with applicable law and IRS guidance.

NOTE 12 – AMENDMENT

Effective January 1, 2022 the Plan's Non-Standardized Defined Contribution agreement was restated to amend the Participant Loan Program provisions.
