## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Pomp's Tire Service, Inc. Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pomp's Tire Service, Inc. Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

**NOTE 1 - Description of Plan**

The following description of the Pomp's Tire Service, Inc. Salary Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan, as adopted effective December 18, 1968, and restated effective June 3, 2022, covering all employees of Pomp's Tire Service, Inc. (the "Company"), who have met the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan includes an automatic contribution arrangement of 4 percent for newly eligible participants. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to the Plan. For 2024 and 2023, the Company matched 50 percent of the first 5 percent of base compensation that a participant contributes to the Plan. The Company's matching contribution is invested based on the participant's direction. The Company may also make discretionary profit-sharing contributions to the Plan (to be determined annually). Contributions are subject to certain statutory limitations. The Company did not make a discretionary profit-sharing contribution for 2024 or 2023. Participants with one year of service, as defined by the Plan, are eligible for profit-sharing contributions. Profit-sharing contributions are allocated to participants based on eligible compensation.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's discretionary matching contribution, (b) the Company's discretionary profit-sharing contribution, (c) Plan earnings (losses), (d) any forfeiture of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting** - Participants are immediately vested in their voluntary contributions, rollover contributions, and the employer matching contribution, plus actual earnings (losses) thereon. Vesting in the discretionary profit-sharing contributions is based on years of continuous service. A participant is 100 percent vested in the Company's profit-sharing contributions after 6 years of credited service.

**Participant Loans** - The Plan includes a provision allowing eligible participants to borrow, from their fund accounts, a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years, or up to fifteen years for the purchase of a primary residence. Participants may not have more than one loan outstanding at any time. However, former employees of Cross Midwest Tire Co. and Tire Associates were allowed to roll up to two loans into the Plan. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 3.25 to 9.50 percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

**NOTE 1 - Description of Plan - Continued**

**Payments of Benefits** - Upon termination of service, participants with a vested account balance exceeding \$5,000 may elect to receive either a lump sum payment equal to the value of his or her vested account balance or installments over a period of time, not to exceed the participant's life expectancy. Participant accounts with an account balance up to \$1,000 are paid in a lump sum as soon as feasible. Participant accounts with a value greater than \$1,000 and not exceeding \$5,000 will be directly rolled over into an individual retirement plan designated by the Plan administrator, unless the participant affirmatively directs the distribution of his or her vested account balance. In-service and hardship distributions are permitted if certain criteria are met.

**Administrative Expenses** - All administrative expenses may be paid out of the Plan unless paid by the Company. During 2024 and 2023 expenses were paid by both the Plan and the Company.

**Forfeited Accounts** - Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100 percent vested in the Company's discretionary profit-sharing contributions. At December 31, 2024 and 2023, forfeited nonvested accounts and accumulated earnings totaled \$4,322 and \$492, respectively. These amounts may be used to pay plan expenses, reduce future employer contributions, or allocated as additional employer contributions. During 2024 and 2023, forfeitures credited to participant accounts totaled \$2,502 and \$2,026, respectively.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable From Participants** - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payments of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through August 21, 2025, the date which the financial statements were available to be issued.

**NOTE 4 - Fair Value Measurements**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

---

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Information Certified by the Plan Trustees**

Certain information related to investments, notes receivable from participants, and cash surrender value of life insurance disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and cash surrender value of life insurance at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, increase in cash surrender value of life insurance, and interest income from notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Matrix Trust Company, the trustee of the Plan.

**NOTE 6 - Tax Status**

The Company became a participating employer in the OneAmerica Financials Partners Inc. Defined Contribution Volume Submitter Plan and Trust Prototype Plan and Trust effective June 3, 2022, and is relying on its opinion letter dated November 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions with Parties-in-Interest**

Certain Plan investments are managed by OneAmerica. OneAmerica is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

OneAmerica provides certain administrative services and receives revenue from investment fund service providers for services OneAmerica provides to the funds. This revenue is used to offset certain amounts owed to OneAmerica for its administrative services to the Plan.

If the revenue received by OneAmerica from such investment fund service providers exceeds the amount owed, OneAmerica remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts.

Fees for professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan also allows participants to take out notes receivable against their account balances, and those activities are deemed party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - Excess Deferrals/Contributions**

For the years ended December 31, 2024 and 2023, some highly compensated participants had contributed in excess of the amounts that were allowed by the average deferred percentage (ADP) test. These amounts totaled \$9,928 and \$71,886, for the years ended December 31, 2024 and 2023, respectively, and are deemed immaterial to the financial statements taken as a whole. Therefore, in lieu of accruing these amounts, they are reported in the financial statements in the years that the funds are repaid to participants.

**NOTE 11 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 12 - Cash Surrender Value of Life Insurance**

The Plan is the owner of 29 and 31 whole life insurance policies at December 31, 2024 and 2023, respectively. The policies have a combined total cash surrender value of \$463,780 and \$463,245 at December 31, 2024 and 2023, respectively. Assurity Life Insurance Company is the insurer of all of the policies. The current policies have been grandfathered into the Plan and no new policies can be entered into. Upon death of the insured participant or other qualifying event, the cash surrender value will be paid to the Plan on behalf of the participant. Premiums on the life insurance policies are paid from the account balances of the insured participants.
