(1) Description of Plan

The following description of the Worth & Company, Inc. Retirement Plan (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Worth & Company, Inc. (the Company) who have completed one month of service, except employees who are covered by a collective bargaining agreement, non-resident aliens, and leased employees. Eligible employees may begin participating in the Plan on the first day of the first payroll period after achieving eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of investments and monitors investment performance.

Contributions

Eligible employees may direct the Company to make contributions (pre-tax and after-tax) on their behalf up to limits contained in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a Vanguard Target Retirement Fund until changed by the participant.

Participants may receive a discretionary matching employer contribution as determined each year by the Company. The matching contribution for 2024 was 50% of the first 5% of eligible employees' compensation.

Participants working on government projects receive a Company contribution in an amount equal to the fringe benefit payment for health and welfare as set forth on the Secretary of Labor's Register of Wage Determinations under the Service Contract Act or the Davis-Bacon Act as in effect for the particular Federal Contract under which the participant is performing services for the Company, after deducting the cost of providing health and welfare and/or other fringe benefits including cash differential payments made to the participant. All prevailing wage contributions are treated as a qualified non-elective employer contribution (QNEC) per the plan document. Participants direct the investment of their contributions into various options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contribution and prevailing wage contribution, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon as well as any prevailing wage contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

Participants' accounts are fully vested upon death, normal retirement, or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are for a period not to exceed five years or up to thirty years for the purchase of a primary residence. The loans are secured by the vested balance in the participants' accounts and bear interest at rates ranging from 3.24% to 9.50%. The rate remains fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions.

Participants may only have one loan outstanding at any time. Additional loans taken prior to the effective date may continue to be held in a participants account until they are paid in full. Participants must pay off any outstanding loan prior to requesting a new loan.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, participants may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Employees may elect withdrawals during employment subject to the terms described in the plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$69,443 and \$207,437, respectively. Forfeited nonvested balances may be used to first provide restoration of a participant's forfeitures, second to pay administrative expenses incurred by the Plan, third to reduce the Company's matching contribution, and fourth to reduce the Company's discretionary contribution. During 2024, the plan used \$137,540 and \$65,462 for employer match contributions and plan expenses, respectively.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by investment managers and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the employer prevailing wage and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ending December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company (Ascensus), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Cash, interest bearing: Valued at historical cost, which approximates fair value.

Common collective trust: Valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by the Vanguard Group, Inc. (Vanguard). The Plan entered into a recordkeeping and administrative services agreement with Vanguard effective August 1, 2021. Ascensus is the plan trustee. Therefore, these transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments. Fees incurred by the Plan for record keeping services provided by Vanguard are included in administrative expenses.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

(7) Tax Status

The Plan uses a non-standardized, pre-approved plan document sponsored by Ascensus, LLC. The IRS has determined and informed Ascensus, LLC by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risk and Uncertainties

The Plan invests in various securities that are, in general, exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
