Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The University of Tulsa Defined Contribution Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of a qualified institution or qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by an agent on behalf of a qualified institution or qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an agent on behalf of a qualified institution or qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the “Auditor’s Responsibilities for the Audit of the Financial Statements” section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of The University of Tulsa Defined Contribution Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by The University of Tulsa (University) for the benefit of its employees, except for employees who normally work fewer than 20 hours per week during any plan year, student employees, or employees covered under a collective bargaining agreement. Participants are required to attain age 21 to qualify for the University's contributions.

The Plan is intended to satisfy all of the requirements for a 403(b) plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Teachers Insurance and Annuity Association of America (TIAA) serves as the issuer of the TIAA Traditional Annuity contract held by the Plan and is the record-keeper of the Plan. TIAA and College Retirement Equities Fund (CREF), together TIAA-CREF, are custodians of certain plan assets, including annuity accounts. The directed custodian of the Plan is TIAA Trust, N.A. Prior to July 15, 2023, the directed custodian of the Plan was TIAA, FSB.

Contributions

The Plan permits eligible employees to have the University make annual contributions of up to 100% of eligible compensation through a salary deferral election. Employee Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. For eligible employees who have attained the age of 21, the University makes matching contributions equal to 100% of each participant's elective deferrals up to 5% of eligible compensation.

Employees covered under a collective bargaining agreement, independent contractors, leased employees, and adjunct professors are excluded from the University's contributions.

Contributions to the Plan are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various annuity accounts, a pooled separate account, mutual funds, and a money market fund. Each participant has the option of directing contributions into any of the investment account options selected by the University or may participate in the Plan's self-directed brokerage option. Participants may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contributions, the University's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants and Plan Loans

Notes Receivable From Participants

Prior to July 1, 2022, the plan document included provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested

account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator. Effective July 1, 2022, the Plan no longer allows TIAA to issue loans from the Plan to active eligible participants.

Plan Loans

Prior to July 1, 2022, the Plan allowed TIAA to issue loans directly to plan participants. These loans are issued from funds directly owned by TIAA and not from participant accounts and are considered outside the scope of the Plan. Participants may elect to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their balance in the TIAA Traditional Annuity account. To secure plan loans, participants are required to pledge as collateral the balance of their TIAA Traditional Annuity account value equal to 110% of the outstanding loan balance in the event of default. Principal and interest are paid by the participant directly to TIAA.

Loan balances outstanding between TIAA and plan participants were approximately \$56,000 and \$140,000 as of December 31, 2024 and 2023, respectively. The amount pledged as collateral on these outstanding loans at December 31, 2024 and 2023 was approximately \$62,000 and \$154,000, respectively. Plan loan interest rates ranged from 5.28% to 5.56% as of December 31, 2024 and from 5.02% to 5.72% as of December 31, 2023.

The Employee Benefits Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by EBSA.

Effective July 1, 2022, the Plan no longer allows TIAA to issue loans directly to plan participants.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Prior to July 1, 2022, participants were immediately vested in the University's contributions plus earnings thereon. Effective July 1, 2022, participants are 100% vested in the University's contributions and earnings thereon upon completion of one year of service, as defined. In the event of death or disability, the participant becomes 100% vested. The one-year service requirement may include an employee's previous employment with any tax-exempt educational or research organization, provided that the employment was within the last five years immediately preceding employment with the University and that the employee certifies these prior services in accordance with the Plan Document.

Payment of Benefits

Upon retirement (age 65), termination, disability, or death, a participant, or their beneficiary in the event of death, may elect to receive benefits in any of the forms available from the relevant funding vehicle. Forms of benefit available under the Plan, but not necessarily from all funding vehicles, include: 1) a lump-sum amount, 2) a partial payment, 3) installment payments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary, or 4) the purchase of an annuity contract or conversion to an income option. Participants who have invested in the TIAA Traditional Annuity are limited in their ability to elect a lump-sum distribution depending upon the year in which contributions were made; however, they may receive the value of their accumulated benefits over a 10-year period. Additionally, participants are allowed to take an in-service withdrawal upon reaching the age of 59½. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$62,000 and \$7,000, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by approximately \$1,000 and \$7,000, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan is funded by individually controlled TIAA and CREF investments. Contributions are allocated to TIAA Traditional Annuity accounts, CREF variable annuity accounts, TIAA-CREF mutual funds, a TIAA Real Estate pooled separate account, a money market fund, and other mutual funds. The Plan also allows participants to invest in other investments through participation in the Plan's self-directed brokerage option.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds, money market funds, and variable annuities in mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The TIAA Traditional Annuity is a fixed-dollar annuity and investment product offered by TIAA, an insurance company, and includes benefit-responsive and nonbenefit-responsive accounts. The TIAA Traditional Annuity is maintained in the TIAA general account. Contributions to the TIAA Traditional Annuity purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of TIAA. The benefit-responsive TIAA Traditional Annuity account is recorded at contract value, and the nonbenefit-responsive TIAA Traditional Annuity account is recorded at fair value as estimated by TIAA, which approximates contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals, and administrative expenses. The investment contract with TIAA contains liquidity restrictions that require withdrawals and transfers from the investment contract to other investment options available to the Plan to be spread over a period of 10 annual installments or five annual installments for withdrawals after a participant's termination of employment.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The TIAA Real Estate pooled separate account is valued at the NAV per accumulation unit of the investment as provided by TIAA. The underlying real estate holdings or other real estate-related investments are valued principally utilizing external appraisals. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the Plan with a liquidity guarantee. Transfers out of the pooled separate account are limited to one per calendar quarter. There are no unfunded commitments or redemption notice periods.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the University are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the University or the Plan at the University's discretion.

Note 3. Certification of Plan Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA (an agent on behalf of a qualified institution) and TIAA-CREF (a qualified institution) have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds or units of annuity accounts or a pooled separate account that are managed by TIAA-CREF or held by TIAA, FSB or TIAA Trust, N.A., which are custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue-sharing rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations. The Plan's traditional annuity contract is maintained in the TIAA general account.

The Plan paid approximately \$200 and \$60,000 to TIAA and BOKF, NA, respectively, during the year ended December 31, 2024 for administrative and investment advisory services for the Plan.

The plan sponsor pays certain legal fees to the firm of a member serving on the Retirement Plan Oversight Committee.

The plan sponsor provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such

investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 investments.

Level 3 Activity

Purchases of Level 3 investments totaled approximately \$1,498,000 and \$860,000 for the years ended December 31, 2024 and 2023, respectively. There were no issuances or transfers into or out of Level 3 during the years ended 2024 or 2023.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and trust document sponsored by TIAA. This volume submitter plan document has obtained an advisory letter from the Internal Revenue Service (IRS) stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since the volume submitter plan document received the advisory letter, the University and the University’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. Once the Plan has determined it has remitted employee contributions late to the Plan, the Plan is required to compute lost earnings on those contributions and allocate lost earnings to the participants impacted in an equitable manner.

While the University remitted all employee contributions to the Plan, contributions of \$449,800 and \$87,148 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. Late remittances are required to be reported as nonexempt transactions, including the year they are corrected; therefore, these late contributions have been included on the Schedule H, Line 4a of the Form 5500.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

TIAA and CREF issue various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of the contract accumulations, which could impact the value realized upon exiting the contract.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Plan Amendments

Effective July 1, 2025, the Plan was amended for the following matters:

- The plan document will include an automatic deferral feature whereby a participant who became eligible to participate after April 1, 2026 is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature provides for a default deferral rate of 5% of participant compensation. Participants are allowed 90 days from the first automatic deferral to receive a refund on these deferrals.
- Following a severance from employment, a participant or beneficiary with an account balance of less than \$5,000 will receive an automatic mandatory distribution via rollover contribution to an individual retirement account (IRA).
