Report of Independent Auditors

To the Administrator of CB Neptune Holdings LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of CB Neptune Holdings LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

June 30, 2024 and 2023

1. Description of the Plan

The following brief description of the CB Neptune Holdings LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. CB Neptune Holdings LLC (the “Company”) is the Plan’s sponsor. Participants should refer to the Plan document for more complete information.

The Plan is administered by members of Company management. Ascensus Trust Company is the trustee and custodian of the Plan (the “Trustee”).

General

The Plan is a defined contribution plan that was established on September 1, 2020, retroactive to July 1, 2020. Under such a plan, the participant is not provided with any fixed benefit. Plan contributions are made at specified rates and are credited to an individual account for the benefit of each participant. Investment income of the Plan is allocated daily to individual participant accounts based on participant account balances, as provided in the Plan. The ultimate benefit to be received by a participant depends on the aggregate amount contributed by the participant and the Company over the years and the investment results allocated to the participant’s individual account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On September 5, 2023, the Company acquired the assets and liabilities of Quotient Technology, Inc. and subsidiaries (“Quotient”). Effective October 13, 2023, US employees of Quotient were eligible for enrollment into the Plan.

Contributions

Eligible participants may elect to have made on their behalf, through salary reductions, a contribution at each payroll period of up to 100% of annual compensation. Participants may contribute up to the maximum allowable amount as prescribed in the Internal Revenue Code (\$23,000 per annum for 2024 and \$22,500 per annum for 2023, based on the calendar year). Contributions for highly compensated employees are further reduced if certain nondiscrimination tests are not complied with. Contributions made to the Plan are recorded during the Plan year to which they relate. In addition, participants aged 50 and over may contribute a “catch-up” contribution up to \$7,500 for calendar years 2024 and 2023. Participants are permitted to make rollover contributions from certain other qualified plans.

The Company has the discretion to match each participant’s contribution as defined in the Plan. Participants are eligible for Company contribution after six months of service, as defined in the plan document. The matching contribution is calculated after the end of the fiscal year, June 30th, and is based upon the Company’s EBITDA performance.

Vesting

Participants are immediately vested in all employee contributions and the earnings thereon, and in the matching employer contributions once they have met the service requirements.

Forfeitures

Participants who terminate employment, but have not become fully vested in Company contributions, forfeit their vested balances. In accordance with the Plan, the amount of forfeitures will be applied to reduce Company contributions. Forfeitures for the year ended June 30, 2024 were not material.

Administrative Expenses

For the year ended June 30, 2024, expenses related to the administration of the Plan were paid by the participants.

Eligibility

Participants who have attained age 21 are generally eligible to participate on their hire date.

Payments of Benefits

A participant's vested interest in Plan assets is distributable generally upon termination, disability, retirement or death. Active participants may receive distributions from the vested amounts in their accounts at any time after attaining the age of 59-1/2 or due to hardships as defined in the Plan. Participants may elect to receive their account balance as a single lump-sum payment (which payment would generally be eligible to be rolled-over to an Individual Retirement Account of the participant's choosing) or as a direct transfer to an Individual Retirement Account established by the Trustee.

Notes Receivable From Participants

Under certain conditions, participants may borrow up to the lesser of 50% of the participant's vested account balance or \$50,000 from their account balances, subject to the provisions of the Plan. The repayment term of the loans may vary from one to five years (with the exception of a loan used to purchase a primary residence, in which case the term of the loan may exceed five years) with interest payable at a fixed rate equal to the prime rate (as of the first day of the month following receipt of the loan application), plus 1%.

The loans are evidenced by promissory notes and require repayments of principal and interest to be deducted from the participants' salaries. The loans to a participant are collateralized by the participants' interests in the Plan's assets. If a participant terminates service with the Company prior to repayment of the loan, the outstanding balance of the loan becomes due immediately and the amount of the participant's distribution from the Plan is reduced accordingly.

As of June 30, 2024, loans outstanding bear interest at rates ranging from 3.25% to 8.50% with maturity dates ranging from 2024 through 2036.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in September 2024.

Amendment and Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and to discontinue contributions at any time, subject to the provisions of ERISA. Upon termination or complete discontinuance of contributions to the Plan, all earned benefits credited to each participant's account shall be distributed at the time and in the manner provided for in the Plan. However, neither through amendment, nor by termination, may any part of the Plan's assets be used for purposes other than the exclusive benefit of the participants.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investments and Investment Income

Investments in mutual funds are stated at fair value. Quoted market prices are used to determine fair value. Shares of mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

The Plan presents in the statement of changes in net assets available for benefits the net (depreciation) appreciation in the fair value of its investments, which consists of the realized gains and losses and unrealized (depreciation) appreciation in these investments.

Contributions Receivable

An employer contribution receivable is recorded for amounts due to the Plan related to the current fiscal year at year-end.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, at the time when the participant becomes eligible for a distribution under the terms of the Plan, the participant's account is reduced by the unpaid loan amount, plus any applicable interest, and the reduction is treated as a distribution.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties

The Plan provides for investments in various investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events that could impact the value of investment securities, such as a pandemic or an international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in investment values in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

The Plan is exposed to credit loss in the event of nonperformance by the investment managers of the funds. However, the Plan does not anticipate nonperformance by the investment managers.

3. Information Certified by the Trustee

The following information as of and for the year ended June 30, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an authorized representative of Ascensus Trust Company (the trustee of the Plan), in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for

4. Related Parties and Parties-In-Interest

Certain Plan investments are shares of mutual funds managed by the Vanguard Group. Vanguard Group, Ascensus Trust Company and Ascensus LLC are the investment advisor, trustee and record keeper, respectively, as defined by the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$51,295 for the year ended June 30, 2024.

5. Income Tax Status

The Plan has adopted a plan document that was pre-approved, and the Internal Revenue Service issued an opinion letter dated December 1, 2018 indicating that the plan document meets the applicable sections of the Internal Revenue Code. The Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years beginning prior to July 1, 2020.

6. Fair Value Measurements

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification 820 (“ASC 820”), *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
