### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Asplundh Tree Expert, LLC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### (1) Description of Plan

The following description of the Asplundh Tree Expert, LLC Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document, including plan amendments, for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan, which was instituted on December 31, 1947. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan provides retirement, disability, and/or death benefits to all eligible salaried employees of Asplundh Tree Expert, LLC and wholly owned subsidiaries (collectively the Company). The Board of Directors oversees governance of the Plan. The Plan's Administrative Committee is responsible for the administration of the Plan, supervision, and control of operations of the Plan and reports to the Board of Directors. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

##### *Eligibility*

Eligible participants include employees in a covered class of the Company who have completed 1,000 hours of service within one year of employment with the Company. The Plan excludes nonresident aliens with no U.S. source income, hourly employees, employees working on a H-2B visa, leased employees, and certain corporate employees as defined by the Plan. Highly compensated employees, as defined by the Plan, are not eligible for the allocated Company contributions.

##### *Contributions*

The Plan is funded by Company contributions; participant contributions are not permitted. Company contributions that are allocated to participants are accrued annually upon authorization by the Board of Directors of the Company. The Company makes yearly contributions to the Plan equal to either fifteen percent (15%), ten percent (10%), or five percent (5%) of each participant's gross payroll depending on the results of the Company's operations for the year and the employee's position and date of hire. Participants direct the investment of their Company contributions into various investment options offered by the Plan. In no event shall the Company make any contributions, which would cause the annual addition to any participant's account to exceed the limitation set forth in the Internal Revenue Code (IRC). The Company made contributions of \$18,695,146 and \$15,749,213, net of forfeitures used, for the years ended December 31, 2024 and 2023, respectively.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Each participant's account is credited with the allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Vesting in the Company's contributions plus earnings thereon is based on years of service as follows:

##### *Payment of Benefits*

The Plan provides for benefits at retirement, death, total disability, or termination of employment. Benefits are paid in the form of a lump-sum cash distribution.

##### *Forfeited Accounts*

The forfeited non-vested account balance is available to be used to reduce future employer contributions and administrative expenses. Forfeitures of \$193,247 and \$173,245, respectively were used to offset the employer contributions receivable at December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested account balances were \$152,099 and \$205,394, respectively.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Contributions*

Company contributions are recorded in the year in which they are earned.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

Certain administrative expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

##### *Reclassification of Prior Year Amounts*

Certain amounts in the prior year's financial statements have been reclassified to conform to the current year's presentation. These reclassifications had no impact on net assets available for benefits or changes in net assets available for benefits.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

#### (3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. During the year ended December 31, 2024, the Plan reclassified its investment in a pooled separate account to a group annuity contract. This reclassification reflects a change in the investment structure and reporting classification based on updated contractual terms and benefit responsiveness. The group annuity contract is considered a fully benefit-responsive investment and is therefore reported at contract value. Prior to reclassification, the pooled separate account was reported at fair value. The change in classification aligns with FASB ASC 962, *Plan Accounting – Defined Contribution Pension Plans* guidance for defined contribution plans and reflects the Plan's updated investment strategy. The reclassification did not result in a material change to the net assets available for benefits. Comparative figures for the prior year have been adjusted to reflect consistent presentation.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end investments that are registered with the Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the net asset value (NAV) of units of a trust company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### (4) Group Annuity Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with New York Life Anchor Account IV (NYLAAIV) totaling \$15,643,364 and \$16,078,721 as of December 31, 2024 and 2023, respectively. NYLAAIV maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract meets the criteria to be considered fully benefit responsive and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by NYLAAIV represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal, or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### (5) Certified Investments

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

#### (6) Related Party and Party-In-Interest Transactions

Certain plan investments are registered investment companies and common collective trusts managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is also the custodian, as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

Administrative expenses paid by the Plan amounted to \$197,210 and \$185,021 for the years ended December 31, 2024 and 2023, respectively.

#### (7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### (8) Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 14, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (9) Risks and Uncertainties

The Plan invests in various investment instruments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such a change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
